69K-33.007 Requirements Regarding Handling and Storing of Human Remains.

(1) All human remains in the possession of a chapter 497 licensee shall be refrigerated at 40 degrees Fahrenheit or below commencing 24 hours after death, unless the remains have by then been embalmed.

(2) Un-embalmed remains once placed in refrigeration shall not be removed from refrigeration for more than three hours in any 24 hour period, until removed for final disposition.

(3) Human remains shall be kept completely covered while being removed or transported from the place of death to an establishment or facility licensed under Chapter 497, F.S.

(4) Human remains while held at an establishment or facility licensed under Chapter 497, F.S., shall be kept out of sight of the public, except when, with the approval of a licensed funeral director, particular remains are intentionally exposed to a legally authorized person, to one or more family members of the decedent, or at a viewing or funeral service.

(5) Prior to exposure of human remains to a legally authorized person, family member, or at a viewing or service, a licensed funeral director shall inspect the remains.

(6) As used in this rule, the term "vermin" includes flies, fly eggs, maggots, roaches, ants, other insects, and rodents.

(7) All human remains received at a licensed establishment or facility shall within 12 hours of receipt at the establishment or facility be inspected by a licensed funeral director or embalmer, for the presence of vermin infestation, and if same is detected, the remains shall be promptly treated for elimination of same by a licensed funeral director or embalmer.

(8) Embalmed remains not stored in refrigeration shall be inspected at least daily by a licensed funeral director or embalmer. Any vermin infestation, mold, or mildew noted on the remains shall be promptly and effectively treated for elimination by a licensed funeral director or embalmer.

(9) Human remains stored in refrigeration shall be inspected at least weekly by a licensed funeral director or embalmer. Any vermin infestation, mold, or mildew noted on the remains shall be promptly and effectively treated for elimination by a licensed funeral director or embalmer.

(10) The requirement that human remains be treated by all Ch. 497, F.S., licensees with dignity and respect, is not contingent on payment to the licensee of amounts due for professional services by the licensee.

(1) An applicant filing DOH Form #DH-MQA 1142 Application for Licensure, Revised 08/12, which is hereby incorporated by reference, which is available through <http://www.flrules.org/Gateway/reference.asp?No=Ref-02042> or www.doh.state.fl.us/mqa, and demonstrating that he or she meets the requirements of Rule 64B17-3.001, F.A.C., may be licensed to practice physical therapy by endorsement by presenting evidence satisfactory to the Board that the applicant has active licensure in another jurisdiction and has passed an examination before a similar, lawful, authorized examining board in physical therapy in such other jurisdiction if their standards for licensure are as high as those maintained in Florida. The standard for determining whether the standards of another jurisdiction are as high as the standards in Florida shall be whether the written examination taken for licensure in such other jurisdiction by applicants meeting Florida’s minimum educational qualifications was through the national physical therapy examination provider certified by the Department. An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapists by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

(2) An applicant who has been educated in a foreign country may demonstrate minimum qualifications by providing the following:

(a) A certified copy of the credential evaluation used by the physical therapy licensing board of another state. The evaluation must be on the appropriate coursework tool (CWT) adopted by the Federation of State Boards of Physical Therapy (FSBPT) and reflect the education criteria in place at the time of graduation; and:

(b) Proof of 1000 clinical practice hours each year in the United States for five (5) out of the last ten (10) years;

Full-time teaching of physical therapy education may count toward 250 of the 1000 required practice hours per year.

(3) An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapists by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

64B17-4.003 Licensure by Endorsement.

(1) An applicant, filing DOH Form #DH-MQA 1142 Application for Licensure, Revised 08/12, which is hereby incorporated by reference, which is available through <http://www.flrules.org/Gateway/reference.asp?No=Ref-02042> or www.doh.state.fl.us/mqa, and demonstrating that he or she is licensed in another state may be licensed to practice as a physical therapist assistant by endorsement by presenting evidence of active licensure in another jurisdiction, under oath, and evidence satisfactory to the Board that the applicant from such other jurisdiction has been licensed under standards for licensure as high as those maintained in Florida. The standard for determining whether those requirements are as high as those in Florida shall be whether the applicant was required to meet educational standards equivalent to those set forth in subsection 64B17-4.001(3), F.A.C., and whether the written examination taken for licensure in such other jurisdiction was through the designated national physical therapist assistants examination provider certified by the Department. An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapist Assistants by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

(2) An applicant who has been educated in a foreign country may demonstrate minimum qualifications by providing the following:

A certified copy of the credential evaluation used by the physical therapist assistant licensing board of another state. The evaluation must be on the appropriate coursework tool (CWT) adopted by the Federation of State Boards of Physical Therapy (FSBPT) and reflect the education criteria in place at the time of graduation; and

Proof of 1000 clinical practice hours each year in the United States for five (5) out of the last ten (10) years;

Full-time teaching of physical therapist assistant education may count toward 250 of the 1000 required practice hours per year.

An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapist Assistants by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.
