Only one entity will be funded. The entity must be capable and willing to provide services to all eligible low-income citizens in Monroe County.

ACTIONS TO BE TAKEN: DEO will review the submitted applications, and make a decision regarding each applicant's eligibility to provide CSBG services to Monroe County. DEO staff will prepare a recommendation for the selected entity for subsequent consideration and approval or disapproval by DEO's Executive Director.
