PURPOSE AND EFFECT: The purpose of the amendment to Rule 12D-9.020, F.A.C., is to implement the Administrative Law Judge's (ALJ) ruling in Rob Turner, Hillsborough County Property Appraiser vs. Department of Revenue. The effect of this rule amendment is to make the rule consistent with the ALJ's ruling regarding the exchange of evidence in the value adjustment board (VAB) hearing process, as well as with Chapter 2016-128, s. 10, and Chapter 2013-109, s. 8, Laws of Florida.

SUMMARY: The amended rule provides consistency with an ALJ ruling regarding the exchange of evidence in the value adjustment board hearing process.

12D-9.020 Exchange of Evidence.

(1)(a)1. At least 15 days before a petition hearing, the petitioner shall provide to the property appraiser a list of evidence to be presented at the hearing, a summary of evidence to be presented by witnesses, and copies of all documentation to be presented at the hearing.

2. To calculate the fifteen (15) days, the petitioner shall use calendar days and shall not include the day of the hearing in the calculation, and shall count backwards from the day of the hearing. The last day of the period shall be included unless it is a Saturday, Sunday, or legal holiday, in which event the period shall run until the end of the next previous day that is neither a Saturday, Sunday, or legal holiday.

(b) A petitioner's noncompliance with paragraph (1)(a) does not affect the petitioner's right to receive a copy of the current property record card from the property appraiser as described in Section 194.032(2)(a), F.S.

(c) A petitioner's noncompliance with paragraph (1)(a) does not authorize a value adjustment board or special magistrate to exclude the petitioner's evidence. The petitioner has the option of participating in an exchange of evidence with the property appraiser. If the petitioner chooses not to participate in the evidence exchange, the petitioner may still present evidence for consideration by the board or the special magistrate. However, under Section 194.034(1)(h), F.S., as described in this section, if the property appraiser asks in writing for specific evidence before the hearing in connection with a filed petition, and the petitioner has this evidence and knowingly refuses to provide it to the property appraiser a reasonable time before the hearing, the evidence cannot be presented by the petitioner or accepted for consideration by the board or special magistrate. Reasonableness shall be

determined by whether the material can be reviewed, investigated, and responded to or rebutted in the time frame remaining before the hearing. These requirements are more specifically described in subsection (8) of this rule and in paragraphs 12D-9.025(4)(a) and (f), F.A.C.

~~(2)(a) If the petitioner chooses to participate in an exchange of evidence with the property appraiser, at least fifteen (15) days before the hearing, the petitioner shall provide the property appraiser with a list and summary of evidence to be presented at the hearing accompanied by copies of documentation to be presented at the hearing. To calculate the fifteen (15) days, the petitioner shall use calendar days and shall not include the day of the hearing in the calculation, and shall count backwards from the day of the hearing.~~

~~(b) If the petitioner chooses to participate in an exchange of evidence with the property appraiser and he or she shows good cause to the board clerk for not being able to meet the fifteen (15) day requirement and the property appraiser is unwilling to agree to a different timing of the exchange, the board clerk is authorized to reschedule the hearing to allow for the exchange of evidence to occur.~~

~~(2)(a)(c) No later than seven (7) days before the hearing, if~~ If the property appraiser receives the petitioner's documentation as described in paragraph (1)(a) and if requested in writing by the petitioner, the property appraiser shall, no later than seven (7) days before the hearing, provide to the petitioner with a list and summary of evidence to be presented at the hearing, a summary of evidence to be presented by witnesses, and accompanied by copies of all documentation to be presented by the property appraiser at the hearing. The evidence list must contain the current property record card. There is no specific form or format required for the petitioner's written request.

~~(b) To calculate the seven (7) days, the property appraiser shall use calendar days and shall not include the day of the hearing in the calculation, and shall count backwards from the day of the hearing. (d) The last day of the period so computed shall be included unless it is a Saturday, Sunday, or legal holiday, in which event the period shall run until the end of the next previous day which is neither a Saturday, Sunday, or legal holiday.~~

~~(3)(a) If the petitioner does not provide the information to the property appraiser as described in paragraph (1)(a), to the property appraiser at least fifteen (15) days prior to the hearing pursuant to paragraph (2)(a), the property appraiser need not provide the information to the petitioner as described in subsection (2), to the petitioner pursuant to paragraph (2)(c).~~

(b) If the property appraiser does not provide the information to the petitioner within the time required by paragraph (2)(b)(c), the hearing shall be rescheduled to allow

the petitioner additional time to review the property appraiser's evidence.

(4) By agreement of the parties the evidence exchanged under this rule section in subsection (2) shall be delivered by regular or certified U.S. mail, personal delivery, overnight mail, FAX or email. The petitioner and property appraiser may agree to a different timing and method of exchange. "Provided" means received by the party not later than the time frame provided in this rule section. If either party does not designate a desired manner for receiving information in the evidence exchange, the information shall be provided by U.S. mail. The property appraiser shall provide the information at the address listed on the petition form for the petitioner.

(5) Level of detail on evidence summaries; summary: The summaries of evidence to be presented by witnesses for the petitioner and the property appraiser under this rule section summary pursuant to subsection (2) shall be sufficiently detailed as to reasonably inform a party of the general subject matter of the witness' testimony, and the name and address of the witness.

64B9-2.021 Curriculum Guidelines.

(1) All nursing programs leading to initial licensure must conform with the Florida Department of Education curriculum framework.

(2) In order to ensure the preparation of nurses capable of competent practice, the curriculum shall:

(a) Reflect the stated philosophy and objectives of the program.

(b) Evidence an organized pattern of instruction consistent with principles of learning and sound educational practices.

(c) Provide for systematic evaluation of student learning in both clinical experience and theoretical instruction.

(d) Evidence ongoing program evaluation in relation to currency of content, competency of instruction, adequacy of clinical experiences and effectiveness of graduate performance.

(3) Each nursing program and each campus offering nursing education require separate individual approval by the Board. Programs may be offered in the following categories:

(a) Professional nursing education programs that terminate in a bachelor's degree.

(b) Professional nursing education programs that terminate in an associate's degree.

(c) Professional nursing education programs that terminate in a diploma.

(d) Practical nursing education programs.

(4) Specific minimum requirements for professional nursing education programs:

(a) Content:

1. Medical: 70 hours didactic, 127 hours clinical.

2. Surgical: 45 hours didactic, 104 hours clinical.

3. Obstetrics: 31 hours didactic, 44 hours clinical.

4. Pediatrics: 32 hours didactic, 43 hours clinical.

5. Psychiatric: 34 hours didactic, 53 hours clinical.

6. Personal, family, and community health concepts.

7. Nutrition.

8. Human growth and development throughout the life span.

9. Body structure and function.

10. Interpersonal relationship and leadership skills.

11. Mental health concepts.

12. Pharmacology and administration of medication.

13. Legal aspects of practice.

14. Professional role and function.

15. Health teaching and counseling skills.

(b) Percentage of clinical:

1. The curriculum for professional nursing programs that terminate in a bachelor's degree must consist of at least 40% clinical training.

2. The curriculums for professional nursing programs that terminate in an associate’s degree and professional nursing programs that terminate in a diploma must consist of at least 50% clinical training.

(5) Specific minimum requirements for practical nursing programs.

(a) Content:

1. Medical: 87 hours didactic, 115 hours clinical.

2. Surgical: 76 hours didactic, 103 hours clinical.

3. Obstetrics: 34 hours didactic, 47 hours clinical.

4. Pediatrics: 27 hours didactic, 38 hours clinical.

5. Personal, family, and community health concepts.

6. Nutrition.

7. Human growth and development throughout the life span.

8. Body structure and function.

9. Interpersonal relationship skills.

10. Mental health concepts.

11. Pharmacology and administration of medication.

12. Legal aspects of practice.

(b) The curriculum must consist of at least 50% clinical training.

64B9-2.022 Clinical Training.

(1) Clinical learning experiences shall be an integral part of the total curriculum plan and show relationship to concurrent theory.

(2) Clinical training must be in the United States, the District of Columbia, or a possession or territory of the United States.

(3) Clinical training must include experience in:

(a) Acute Care: where a patient receives active but short-term treatment for a severe injury or episode of illness, an urgent medical condition, or during recovery from surgery.

(b) Long Term Care: a continuum of medical and social services designed to support the needs of people living with chronic health problems that affect their ability to perform everyday activities.

(c) Community-based Care: Where health care is provided to the community as a whole, providing nursing care to individuals, families, and groups, to promote wellness, maintain health and prevent illness.

(4) Supervision:

(a) A clinical instructor is a faculty or staff member responsible for an assigned cohort of students in a clinical environment.

(b) A clinical preceptor is a registered nurse supervising a student in the clinical setting. The preceptor provides oversight of the student’s patients and gives feedback to the student and the clinical instructor. The clinical preceptor may be a licensed practical nurse if supervising students for a practical nursing education program.

(c) The clinical instructor must directly supervise no more than 12 students, unless, by written agreement the clinical training site allows more, not to exceed 18 students.

(d) Direct supervision means the clinical supervisor is within the health care facility while the students are providing care to the patients.

(e) Indirect supervision is allowed in a hospital setting if:

1. There is no more than 18 students.
2. There is direct supervision by an assigned clinical preceptor.
3. The clinical instructor is available by telephone.
4. The arrangement is approved in writing by the clinical training site.

(f) Indirect supervision is allowed for community-based clinic experiences when the clinical instructor is available by telephone, unless the clinical experience is an invasive or complex nursing activity. Supervision for invasive or complex nursing activities must be approved by the community-based clinical site.

(5) Up to 50% of each clinical training category: acute care, long-term care, and community-based care may be simulated when accompanied by traditional clinical experience.

(a) Traditional clinical experience consists of activities that include observation, hands-on experience with patients, and interaction with an interdisciplinary team.

(b) Simulation consists of activities or events replicating clinical practice using scenarios, high-fidelity manikins, medium-fidelity manikins, standardized patients, role playing, skills stations, and computer-based critical thinking situations.

1. High-fidelity simulation is experience using full scale computerized patient simulators, virtual reality or standardized patients that are extremely realistic and provide a high level of interactivity and realism for the learner.

2. Medium-fidelity simulation is experience using two-dimensional focused experiences to problem solve, perform a skill and make decisions, or the use of mannequins more realistic than static low fidelity ones having breath sounds, heart sounds, and/or pulses.

(c) Debriefing is a part of the simulation that follows the experience. Participants’ reflective thinking is encouraged, and feedback is provided regarding the participant’s performance in the simulation experience. The purpose of debriefing is to

move toward assimilation and accommodation in order to transfer learning to future situations.

THE FULL TEXT OF THE EMERGENCY RULE IS:

53ER18-6 30th Birthday Cash Spectacular Second Chance Promotion

(1) Beginning January 15, 2018, through April 9, 2018, the Florida Lottery will conduct the 30th Birthday Cash Spectacular Second Chance Promotion (“Promotion”) in which players can enter non-winning Florida Lottery Scratch-Off tickets (also known as instant tickets) from the following FLORIDA X THE CASH games into a second chance drawing for a chance to win a cash prize:

- (a) FLORIDA 5X THE CASH Game Number 1372;
- (b) FLORIDA 10X THE CASH Game Number 1373;
- (c) FLORIDA 20X THE CASH Game Number 1374;
- (d) FLORIDA 50X THE CASH Game Number 1375; and
- (e) FLORIDA 100X THE CASH Game Number 1379.

Non-winning Scratch-Off lottery tickets from FLORIDA 5X THE CASH, FLORIDA 10X THE CASH, FLORIDA 20X THE CASH and FLORIDA 50X THE CASH games may be entered throughout the entire Promotion (January 15, 2018 through April 9, 2018) for the next available drawing. Non-winning Scratch-Off lottery tickets from the FLORIDA 100X THE CASH game may only be entered during the period of February 26, 2018, through April 9, 2018, for the next available drawing. Winning Scratch-Off tickets from the above-listed games cannot be used for entry into the Promotion.

(2) How to Enter.

(a) To enter a non-winning FLORIDA 5X THE CASH, FLORIDA 10X THE CASH, FLORIDA 20X THE CASH, FLORIDA 50X THE CASH or FLORIDA 100X THE CASH (referred to individually or collectively as “FLORIDA X THE CASH family”) Scratch-Off ticket into one of the second chance drawings, players must enter on the Florida Lottery’s website at flalottery.com. Players will be prompted to log-in or register. Players are to scratch off the latex covering to reveal the number and enter the entire 24-digit ticket serial number in the designated ticket entry area on the website.

(b) Entry Determination. Each non-winning FLORIDA X THE CASH family Scratch-Off ticket is assigned a

Players may enter as many times as they wish during the Promotion; however, each valid ticket number may only be entered one time and only into one drawing. Tickets should not be mailed to the Florida Lottery unless players are contacted by the Florida Lottery and requested to do so. Non-winning tickets received in the mail by the Florida Lottery will not be entered in a drawing and will not be returned. The odds of winning depend on the number of entries entered. The live-stream post will be on the Florida Lottery’s official Facebook page on the first Thursday of each entry period beginning at noon, ET. The live-stream post will continue to be available on the Florida Lottery’s official Facebook page (www.facebook.com/floralottery) after the live event has concluded; however, each Facebook promo code is only valid for the one entry period for which it is designated and can only be entered one time.

(d) Instagram Promo Code. A player may earn 10 additional entries by entering an Instagram promo code at the time the player enters a non-winning FLORIDA X THE CASH family Scratch-Off ticket into a drawing. A non-winning FLORIDA X THE CASH family Scratch-Off ticket must be entered to enable the Instagram promo code feature and the ticket and the promo code must be entered simultaneously. After each of the six Facebook live-stream posts described in paragraph (2)(c) above conclude, players will be encouraged to

view the Florida Lottery’s Instagram story, where an Instagram promo code will be posted. The Florida Lottery’s Instagram story and Instagram promo code will only be available for viewing 24 hours after being posted, however, the Instagram promo code may be entered at any time during the entry period for which it is designated. Each Instagram promo code is only valid for the one entry period for which it is designated and may only be entered one time.

(e) An eligible Facebook promo code and an eligible Instagram promo code described in paragraphs (2)(c) and (d) can both be entered at the same time a non-winning FLORIDA X THE CASH family Scratch-Off ticket is entered provided the ticket and the promo codes are entered simultaneously.

In each of the drawings, a total of 50 valid entries will be drawn by the Florida Lottery using a certified random number generation process. The first valid entry drawn will win the first prize of \$30,000. The second and third valid entries drawn will each win a second prize of \$10,000. The fourth through seventh valid entries drawn will each win a third prize of \$5,000. The eighth through thirty-seventh valid entries drawn will each win a fourth prize of \$1,000. (5) Notification.

(a) The prizewinners in each second chance drawing will be posted on flalottery.com after the drawing.

(b) The Florida Lottery will attempt to notify each winner by telephone or email using the contact information provided in the winner’s registration data no later than twenty-four hours after the winners are posted on the Florida Lottery’s website. The Florida Lottery deems the winner’s registration data as the winner’s official contact information, including the physical mailing address, and will not attempt to further locate a winner if attempts to reach the winner by telephone or email are unsuccessful. If the Florida Lottery is unable to have personal contact (by telephone or email) with a prize winner within two weeks of the date of the posting on the website, the winner will forfeit his or her right to claim the prize and the Florida Lottery will award the prize to an alternate winner in accordance with subsection (3) above. If the Florida Lottery is unable to have personal contact with the alternate winner within two weeks of the date of notification, the alternate winner will forfeit his or her right to claim the prize and the Florida Lottery will award the prize to the next alternate winner. The same timeframe for a winner to return required documentation to the Florida Lottery shall apply to an alternate winner.

(7) Award of Top Prize. Upon the Florida Lottery's timely receipt of the top prize winner's required documentation, the Lottery will award a prize of \$30,000, less applicable federal tax withholding.

(10) Award of Fourth Prizes. Upon the Florida Lottery's timely receipt of a fourth prize winner's required documentation, the Lottery will award a prize of \$1,000.

(11) Taxes. Except as specifically described herein, all federal, state and/or local taxes or other fees on the prizes won in the 30th Birthday Cash Spectacular Second Chance Promotion will be the responsibility of the winner. Thirty percent federal income tax withholding will be withheld from any prize won by a nonresident alien claimant in the Promotion, regardless of the amount of the prize.
