SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

There is also some road work associated with adjusted traffic patterns. The project is currently planned for bid packages as early as late July for some of the early work including the garage/structure package and there will be additional packages bid in the fall associated with some of the site amenities and added infrastructure. The project is scheduled to start work in December 2018.
