The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within

one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: During discussion of the economic impact of this rule at its Board meeting, the Board concluded that this rule change will not have any impact on licensees and their businesses or the businesses that employ them. The rule will not increase any fees, business costs, personnel costs, will not decrease profit opportunities, and will not require any specialized knowledge to comply. (1) No change.

(2) An inactive status licensee may change to active status at any time provided the licensee meets the continuing education requirements of Rule 64B15-13.001, F.A.C.; however, if the license has been inactive for more than one (1) year, the licensee must meet the requirements of Rule 64B15-13.002, F.A.C.

(3)(a) Inactive status licensees choosing active status at the time of renewal must pay the active status renewal fee and the reactivation fee.

(b) Inactive status licensees choosing active status at any other time than at the time of license renewal shall pay the difference between the inactive status renewal fee and the active status renewal fee, the reactivation fee and the fee to change licensure status.

(4) ~~A~~ However, a licensee whose license has been in inactive status for more than two consecutive biennial licensure

cycles and who has not been practicing medicine on a full-time basis in another jurisdiction during such period of time, shall be required to appear before the Board before the license can be placed into active status. The Board at the time of the appearance shall impose upon the licensee reasonable conditions necessary to insure that the licensee can practice with the care and skill sufficient to protect the health, safety and welfare to the public. For purposes of this rule, "full-time basis" shall be defined as working as a physician for over 20 hours per week.

(1) As a condition to the reactivation of a retired status license, a physician must:

(a) Submit documentation of successful completion of twenty (20) hours per year of continuing medical education courses which comply with the requirements of Rule 64B15-13.001, F.A.C., for each year of retired status; however, if the license has been inactive for more than one (1) year, the licensee must meet the requirements of Rule 64B15-13.002, F.A.C.

64B15-13.001 Continuing Education for Biennial Renewal. Every person licensed pursuant to chapter 459, F.S., except those licensed as physician assistants pursuant to section 459.022, F.S., shall be required to complete forty (40) hours of continuing medical education courses approved by the Board in the twenty-four (24) months preceding each biennial renewal period as established by the Department. Continuing medical education (CME) requirements for biennial renewal of licensure are set forth in this rule.

(1)(a) For each biennial renewal, a licensee shall complete a one (1) hour continuing medical education course in Florida Laws and Rules/Professional and Medical Ethics, and a two (2) hour course in Prevention of Medical Errors.

(b) through (d) No change.

(e) A licensee who is registered with the United States Drug Enforcement Agency and is authorized to prescribe controlled substances is required to complete a 2-hour course on prescribing controlled substances at each biennial renewal of licensure as required by section 456.0301, Florida Statutes. The Board approves the controlled substance prescribing courses offered by the Florida Medical Association, the Florida Osteopathic Medical Association, the Florida Academy of Family Physicians, the Florida College of Emergency Physicians, Baptist Health South Florida/Quality Network, ~~and~~ InforMed, Florida Psychiatric Society, NetCE, and The Doctors Company, for the purpose of meeting this continuing education requirement. The course may be offered in a distance learning format.

(1) Every license holder pursuant to Chapter 459, F.S., whose license has been inactive or retired for more than one (1) year shall be required to complete continuing education requirements as a condition for reactivating the his license.

(2)(a) The continuing education requirements shall be twenty (20) attendance hours for each year the license was inactive or retired; of these 20 hours, at least 10 must be AOA Category 1A hours.

(b) ~~Three (3)~~ ~~At least five (5)~~ of the total number of continuing medical education hours required for reactivation renewal shall be as found in paragraph 64B15-13.001(1)(a), F.A.C.

(c) If the licensee is registered with the United States Drug Enforcement Agency and is authorized to prescribe controlled substances, the licensee also is required to complete the 2-hour course on prescribing controlled substances as set forth in Rule 64B15-13.001(1)(e), F.A.C., as part of the total number of continuing education hours required for reactivation.

(3) The courses listed in Rule 64B15-13.001, F.A.C., shall constitute the list of approved courses under this rule.
