through the fast track process in section 403.8055, F.S., and 2) adopt procedures in Rule 62-701.805, F.A.C., by which the Department of Environmental Protection will issue Coal Combustion Residuals Permits to facilities in Florida that are currently required to comply with the requirements in 40 CFR Part 257.50 through 257.107.

**SUBJECT AREA TO BE ADDRESSED:** The subject matter to be addressed in this rulemaking includes adoption of the requirements in 40 CFR Part 257.50 through 257.107, “Standards for the Disposal of Coal Combustion Residuals in Landfills and Surface Impoundments” and any subsequent amendments or modifications that became effective prior to June 2019, into Chapter 62-701 F.A.C, and establishing the procedures by which Coal Combustion Residuals permits will be issued to facilities in Florida that are currently required to comply with the requirements in 40 CFR Part 257.50 through 257.107.

<b>PURPOSE AND EFFECT:</b> To incorporate by reference an updated version (2019) of the “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book) publication. Changes in law, accounting principles and district practices require periodic revision of this publication, which includes a chart of accounts. The effect is that districts will have an updated chart of accounts to use.	
<b>SUMMARY:</b> The superintendent of each school district is responsible for keeping adequate records and accounts of all financial transactions in the manner prescribed by the	

commissioner in “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book), which is incorporated by reference in rule 6A-1.001, F.A.C. The Office of Funding and Financial Reporting is responsible for updating the publication. The amendment allows for the 2019 version of the “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book) to replace the 2018 version, currently incorporated by reference in rule 6A-1.001, F.A.C.

(1) Before any manufacturer, distributor or dealer may offer for sale or lease any school bus chassis or bodies to be used for the transportation of students to public schools of Florida, such manufacturer, distributor or dealer shall:

(a) File with the Deputy Commissioner for Finance and Operations a certified statement that any school bus chassis or body sold by such manufacturer, distributor or dealer will meet the Federal Motor Vehicle Safety Standards required by section 1006.25(2), F.S., the *National School Transportation Specifications & Procedures, May ~~2015~~ 2010* (<http://www.flrules.org/Gateway/reference.asp?No=Ref-08558>), and the *Florida School Bus Specifications, revised 2019* (<http://www.flrules.org/Gateway/reference.asp?No=Ref-08559>), all of which are incorporated herein by reference. In re: A LAND DEVELOPMENT REGULATION ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF LAKE COUNTY, FLORIDA, BY ORDINANCE NO. 2019-34

**FINAL ORDER**

APPROVING LAKE COUNTY ORDINANCE 2019-34

The Department of Economic Opportunity ("Department") hereby issues its Final Order, pursuant to subsection 380.05(6), Florida Statutes, approving land development regulations adopted by the Board of County Commissioners of Lake County, Florida ("County"), Ordinance 2019-34 ("Ordinance").

**FINDINGS OF FACT**

1. The Green Swamp Area is designated by Section 380.0551, Florida Statutes, as an area of critical state concern. Lake County is a local government within the Green Swamp Area.
2. The Ordinance was adopted by the County on June 11, 2019, and rendered to the Department on June 17, 2019.
3. The Ordinance amends Section 6.06.01 and Section 3.09.00 of the County's Land Development Regulations.
4. Section 6.06.01, relating to mining, is amended to clarify the circumstances and procedures that are required for excavation on agricultural properties.
5. Section 3.09.00, relating to lighting, is amended to apply existing provisions to all nonresidential development, which is defined to include agricultural uses, commercial uses, industrial uses, community facility uses, and recreational uses.

**CONCLUSIONS OF LAW**

6. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See § 380.05(6), Fla. Stat.



7. "Land development regulations" include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.

8. The Ordinance is consistent with the County's Comprehensive Plan as required by Section 163.3177(1), Florida Statutes, generally, and is specifically consistent with Policy 1-4.3.7 and Policy 1-4.1.5 of the County's Plan.

9. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See § 380.05(6), Fla. Stat. The Principles for Guiding Development for the Green Swamp Area of Critical State Concern are set forth in Rule 28-26.003, Florida Administrative Code.

10. The Ordinance is consistent with the Principles for Guiding Development for the Green Swamp Area of Critical State Concern as a whole, and is not inconsistent with any Principle. WHEREFORE, IT IS ORDERED that the Department finds that Lake County Ordinance 2019-34 is consistent with the Lake County Comprehensive Plan and the Principles for Guiding Development for the Green Swamp Area of Critical State Concern and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
