**PURPOSE AND EFFECT:** 5E-2.014 Sampling of Pesticides: The proposed rule change is being made to update the edition of the Official Methods of Analysis, Association of Official Analytical Chemists from the 15th Edition, 1990 to the 21st Edition, 2019. This will provide for the most current methods for sampling pesticides.

5E-2.015 Method of Analyses: The proposed rule change is being made to update the edition of the Official Methods of Analysis, Association of Official Analytical Chemists from the 15th Edition, 1990 to the 21st Edition, 2019. This will provide for the most current methods for analyzing pesticides.

5E-2.031 Pesticide Registration; Exemptions from Registration; Experimental Use Permits: The proposed rule changes are being developed to align the rule with changes to 487.041 F.S. made in 2018. The following sentence, “Effective January 1, 2013, all payments of any pesticide registration fees, including late fees, shall be submitted electronically using the department’s Internet website for registration of pesticide product brands” is to be removed.

5E-2.033 Organo-Auxin Herbicides: Restrictions and Prohibitions: Overall the proposed rule changes are being developed to update this rule with the new organo-auxins that have been registered in the state and are not specifically mentioned in the rule and to remove others that are no longer registered in the state. This will help users of this type of herbicides to better identify members of this herbicide group and be aware of the additional restrictions for application that go beyond those of the label. Minor grammar edits and wording are also proposed to improve clarity and intent of the rule, so applicators are less likely to misinterpret and be in violation. Exemptions for specific types of applications where spray drift is not a concern are also proposed, adding an additional tool for weed control that may provide benefits for surface water quality and may be less of a concern for Threatened and Endangered Species and may also be more efficient and economical to the user in the long term than other types of herbicides or control practices.

RULE NO.: 69A-46.041  
RULE TITLE: Inspection Requirements for Fire Protection Systems

PURPOSE AND EFFECT: The State Fire Marshal (SFM) has the right to inspect any fire control system during and after construction to determine that such system meets the standards set forth in the laws and rules of the state. Section 633.312, F.S., requires the SFM to adopt rules to implement a standardized reporting format for a uniform summary report. The proposed amendments will adopt Form DFS-K3-2015, Uniform Inspection, Testing, and Maintenance (ITM) Report, that the contractor must complete and submit to the local authority having jurisdiction (AHJ), and make grammatical changes and other required updates.

SUMMARY: The proposed changes will update the rule and adopt a uniform summary report to be submitted by the contractor to the local AHJ, and make grammatical changes and other required updates.

**SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:**

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The Department conducted an economic analysis of the potential impact of the proposed rule amendments and determined that there will be no adverse economic impact or regulatory increases that would require legislative ratification. THE FULL TEXT OF THE PROPOSED RULE IS:

**69A-46.041 Inspection Requirements for Fire Protection Systems.**

(1) A Fire Protection Contractor, contracting to perform inspecting, testing, and maintenance (ITM) service on a fire protection system ~~must shall~~ comply with the requirements of chapter 633, F.S., and the applicable standards in NFPA 25, Standard for the Inspection, Testing, and Maintenance of Water-Based Fire Protection Systems (ITM), which is incorporated by reference standards as adopted in rule chapter 69A-3.012, F.A.C. When an inspection/test is required to be performed at a specified frequency, up to and including annually, by NFPA 25, all inspection/tests required more frequently than the specified frequency are also required to be performed, e.g., performance of an annual inspection/test would include the inspection/test required on a daily, weekly, monthly, quarterly and semi-annual frequency.

(2) Each system that has been inspected, tested, or maintained by a ~~F~~ire ~~P~~rotection ~~C~~ontractor, or his or her permitted Water-Based Fire Protection Inspector, ~~must shall~~ have a record tag of durable and weather resistant material placed on the system's main water control valve.

(a) For sprinkler systems, including water spray fixed systems and foam-water sprinkler systems, the main water control valve ~~is shall be~~ defined as the valve upstream of the water flow alarm device that controls the entire system.

(b) through (g) No change.

(3) Inspection Tags.

(a) After inspection and testing, an inspection tag shall be completed indicating all work that has been done, and then attached to the system's main water control valve in such a position as to permit convenient inspection and not hamper activation or operation. A new inspection tag must shall be attached to the system's main water control valve each time an inspection and test service is performed.

(b) No change.

(c) Inspection tags must shall bear the following information in an easy-to-read format:

1. 'DO NOT REMOVE BY ORDER OF THE STATE FIRE MARSHAL.' This particular information must shall be in a minimum of 10-point ~~pt~~ type and in all capital letters;

2. through 8. No change.

9. The reverse of the RED or YELLOW tag must shall include at least four separate boxes for the listing of repair work as follows:

a. through e. No change.

(d) No change.

(e) An inspection tag shall only be removed by the Fire Protection System Contractor or his or her permitted Water-Based Fire Protection Inspector.

(f) Compliance and Non-compliance Tags that are greater than 1-year old shall be removed from the system except those tags used for 3 and 5-year inspection/tests. The Compliance and Non-compliance Tags shall remain on the system until replaced with the next ~~three~~ 3 or ~~five~~ 5-year inspection/test tag. Water Based Fire Protection Inspectors shall not remove Compliance and Non-compliance Tags from the system when the tags are less than 1-year old.

(g) A fire protection system that has been repaired to correct a noted deficiency or impairment documented during an inspection and test service is shall not be required to be reinspected by a Water Based Fire Protection Inspector until the next inspection and test scheduled in accordance with NFPA 25. The repair must shall be documented on the reverse side of the RED or YELLOW tag and a retagging of the system is shall not be required.

(4) Compliance and Non-compliance Tag.

(a) If a fire protection system is found to be in compliance with the applicable NFPA ITM standards, a GREEN Compliance Tag must shall be attached to the main water control valve in such a manner as to be plainly visible and not more than 60 inches above the finished floor. GREEN tags shall not be placed on a system if deficiencies or impairments still exist from a previous inspection.

(b) If a fire protection system is found to have noncritical deficiencies and is not in compliance with the applicable NFPA ITM standards, a completed YELLOW Non-compliance Tag must shall be attached to the main water control valve of the system to indicate that corrective action is necessary. The

building owner or authorized representative must shall be notified by copy of the NFPA 25 inspection report within 30 days of the inspection. If the building owner or authorized representative has not contracted with the inspecting contractor so that the noncritical deficiencies are corrected within 90 days from the date of the inspection, or the inspecting contractor has not received confirmation from the building owner or authorized representative that the corrections have been performed by another licensed contractor, the inspecting contractor must shall notify the local authority having jurisdiction (AHJ).

(c) If the system has critical deficiencies or is found to be impaired, a completed RED Non-Compliance Tag must shall be attached to the main water control valve of the system, and the contractor or inspector must shall notify the building owner or authorized representative within 24 hours of the time of the inspection. If the building owner or authorized representative has not contracted with the inspecting contractor so that the critical deficiencies are corrected within 30 days from the date of the inspection, or the inspecting contractor has not received confirmation from the building owner or authorized representative that the corrections have been performed by another licensed contractor, the inspecting contractor must shall notify the local AHJ authority having jurisdiction. If a system is found to be impaired, the inspecting contractor must shall notify the local AHJ authority having jurisdiction within 72 hours of the time of the inspection if the impairment has not been corrected within 72 hours of the finding.

(d) If a system is found to have noncritical deficiencies or critical deficiencies, and the building tenant(s) is different from the building owner, the building owner must shall notify the tenant(s) within 30 days of receipt of the NFPA 25 inspection report.

(e) If a system is found to have impairments, and the building tenant(s) is different from the building owner, the building owner must shall notify the tenant(s) within 72 hours of receiving notification of the impairment.

(5) through (6) No change.

(7) Form DFS-K3-2015, Uniform Inspection, Testing, and Maintenance (ITM) Report (Eff. 03/2021) must ~~The inspection report shall~~ be provided to the local ~~Authority Having Jurisdiction (AHJ)~~ in a format mutually determined by the contractor, as mutually agreed between the contractor and the local AHJ, using one of the following means: (a) by United States mail; (b) by hand delivery; (c) by electronic submission; or (d) through a third-party vendor that collects the reports on behalf of the local AHJ. Form DFS-K3-2015 is hereby incorporated by reference and is available on the following link: <insert DOS website address>; or on the Division's website at: [myfloridacfo.com/Division/SFM](http://myfloridacfo.com/Division/SFM); or by contacting the Regulatory Licensing Section, Bureau of Fire Prevention,

Division of State Fire Marshal, 200 E. Gaines Street, Tallahassee, Florida 32399-0342, Phone: (850)413-3610. No other records storage format or transmission method shall be required other than what is required in this rule or NFPA 25, as adopted in rule chapter 69A-3, F.A.C.

(8) The contractor or his or her permitted Water-Based Fire Protection Inspector must shall complete the inspection reports as required in NFPA 25, which is incorporated by reference as adopted in rule chapter 69A-3.012, F.A.C., that outlines all points of the inspection, test, and maintenance as required by the applicable NFPA ITM standards. A copy of the NFPA 25 inspection report must shall be provided to the owner at the completion of each inspection performed.

(9) The NFPA 25 inspection report must shall include a detailed explanation of every deficiency, and indicate if the inspection is a weekly, monthly, quarterly or annual inspection. The NFPA 25 inspection report must shall include the name of the permitted Water-Based Fire Protection Inspector, the inspector permit number, the inspector’s signature, the date and time of the inspection, and the signature of the owner or the owner’s representative.

(10) Pursuant to the provisions of section 633.312, F.S., it is the owner’s responsibility to maintain the fire protection system and notify the tenant(s) of deficiencies and impairments in accordance with this rule. Affixing an inspection tag as required herein does not eliminate responsibility nor will shall a transfer of risk be construed.

(11) A contractor or licensee that performs ITM services in accordance with the applicable NFPA ITM standards and this rule will shall be deemed to have performed to the required standard of care in performing such services.

12-9.001 Definitions. The following definitions apply to this chapter:

- (5) Professional designee: An elected or appointed official, or an employee of such official or an employee of the Department who has met the requirements for certification as set forth in these rules.

12-9.002 Certified Florida Appraiser, Certified Florida Evaluator, Certified Cadastralist of Florida, Certified Florida Collector, and Certified Florida Collector Assistant Program.

- (1) through (2) No change.
- (3)(a) No change.
- (b) The CFE certification is available to employees of Florida county property appraisers and the Department.
- (c) The CCF certification is available to property appraisers, and employees of Florida county property appraisers and the Department.
- (d) No change.
- (e) The CFCA certification is available to employees of Florida county tax collectors and the Department.

(4) No change.

(5) The Executive Director, or the Executive Director’s designee, shall appoint two Admissions and Certifications Committees. One committee will administer the certification of property appraisers, and employees of Florida county property appraisers persons as “Certified Florida Appraisers,” “Certified Florida Evaluators,” and “Certified Cadastralists of Florida.” Another committee will administer the certification of tax collectors, and employees of Florida county tax collectors persons as “Certified Florida Collectors” and “Certified Florida Collector Assistants.” The Executive Director, or the Executive Director’s designee, shall serve as permanent chairperson. The Executive Director, or the Executive Director’s designee, shall appoint nine members to each committee, one of whom shall be the president of the members’ state association. In the event the president of the state association does not hold a professional designation as specified in Rule 12-9.001(9), F.A.C., the president will appoint a designee who does hold such certification. Members of the committees will be appointed for 3-year terms, except for the presidents of the state associations, who shall serve a 1-year term concurrent with their term as president. All members shall serve at the pleasure of the Executive Director, or the Executive Director’s designee.

(9) The Executive Director, or the Executive Director’s designee, will administer the certification of Department employees who meet the qualifications for professional designation as provided in Rule 12-9.003, F.A.C.

To be approved as a course for initial certification, the course must contain a monitored examination.

## Section IV Emergency Rules

### DEPARTMENT OF REVENUE

#### Sales and Use Tax

RULE NO.: 12AER21-1      RULE TITLE: Sales Tax Holiday on Specific Admissions and Outdoor Activity Supplies During the Period of July 1 through July 7, 2021.

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 45 of Chapter 2021-31, Laws of Florida, authorizes the Department of Revenue to promulgate emergency rules to implement the provisions of the law specifying a period during which the sale of admissions to music events, sporting events, cultural events, specified performances, movies, museums, state parks, and fitness facilities are exempt from sales tax, including the sales of qualifying boating and water activity supplies, camping supplies, fishing supplies, general outdoor supplies, and sports equipment. The promulgation of this emergency rule ensures that the public is notified in the most expedient and appropriate manner regarding the exemption during the period of July 1 through July 7, 2021.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: The Legislature expressly authorized the promulgation of an emergency rule to

administer the provisions of Section 45 of Chapter 2021-31, Laws of Florida. Additionally, an emergency rule is the most expedient and appropriate means of notifying dealers and taxpayers of the provisions of Section 45 of Chapter 2021-31, Laws of Florida.

**SUMMARY:** The rule describes the items included in the exemption and explains how various transactions are to be handled for purposes of the exemption, including sales of sets of both exempt and taxable items, items normally sold as a unit, remote sales, shipping and handling charges, layaway sales, rain checks, exchanges, coupons, rebates, and discounts, repairs and alterations, gift cards, rentals of exempt items, and merchant's license fees. The exemption does not apply to sales within a theme park or entertainment complex, as defined in Section 509.013(9), F.S., or within a public lodging establishment, as defined in Section 509.013(4), F.S., or within an airport, as defined in Section 330.27(2), F.S.

THE FULL TEXT OF THE EMERGENCY RULE IS:

**12AER21-1 Sales Tax Holiday on Specific Admissions and Outdoor Activity Supplies During the Period of July 1 through July 7, 2021.**

(1) Definitions. For purposes of this rule, the following definitions apply:

(a) "Holiday period" means the period from July 1, 2021 through July 7, 2021.

(b) "Admissions" has the same meaning as provided in s. 212.02(1), F.S.

(c) "Remote sale" has the same meaning as provided in Section 5, Chapter 2021-2, Laws of Florida.

(2) The following items are always exempt from sales tax:

(a) American flags and Florida flags.

(b) Bicycle helmets marketed for use by youth.

(c) Prescription sunglasses or lenses, including items that become a part thereof.

(3) Admission sales.

(a) During the holiday period, no tax may be collected on the sale by way of admissions for the following:

1. A live music event scheduled to be held on any date or dates from July 1, 2021, through December 31, 2021.

2. A live sporting event scheduled to be held on any date or dates from July 1, 2021, through December 31, 2021.

3. A movie to be shown in a movie theater on any date or dates from July 1, 2021, through December 31, 2021.

4. Entry to a museum, including any annual passes.

5. Entry to a state park, including any annual passes.

6. Entry to a ballet, play, or musical theatre performance scheduled to be held on any date or dates from July 1, 2021, through December 31, 2021.

7. Season tickets for ballets, plays, music events, or musical theatre performances.

8. Entry to a fair, festival, or cultural event scheduled to be held on any date or dates from July 1, 2021, through December 31, 2021.

9. Use of or access to private and membership clubs providing physical fitness facilities from July 1, 2021, through December 31, 2021.

(b) If the purchaser of a tax-exempt admission subsequently resells the admission, the purchaser shall collect tax on the full sales price of the resold admission.

(4) Retail sales. During the holiday period, no tax may be collected on the retail sale for the following:

(a) Boating and water activity supplies.

1. The first \$75 of the sales price of life jackets and coolers.

2. The first \$50 of the sales price of safety flares.

3. The first \$150 of the sales price of water skis, wakeboards, kneeboards, and recreational inflatable water tubes or floats capable of being towed.

4. The first \$300 of the sales price of paddleboards and surfboards.

5. The first \$500 of the sales price of canoes and kayaks.

6. The first \$75 of the sales price of paddles and oars.

7. The first \$25 of the sales price of snorkels, goggles, and swimming masks.

(b) Camping supplies.

1. The first \$200 of the sales price of tents.

2. The first \$50 of the sales price of sleeping bags, portable hammocks, camping stoves, and collapsible camping chairs.

3. The first \$30 of the sales price of camping lanterns and flashlights.

(c) Fishing supplies. This does not include supplies used for commercial fishing purposes.

1. The first \$75 of the sales price of rods and reels, if sold individually, or the first \$150 of the sales price if sold as a set.

2. The first \$30 of the sales price of tackle boxes or bags.

3. The first \$5 of the sale price of bait or fishing tackle, if sold individually, or the first \$10 of the sales price if multiple items are sold together.

(d) General outdoor supplies.

1. The first \$15 of the sales price of sunscreen or insect repellent.

2. The first \$100 of the sales price of sunglasses.

3. The first \$200 of the sales price of binoculars.

4. The first \$30 of the sales price of water bottles.

5. The first \$50 of the sales price of hydration packs.

6. The first \$250 of the sales price of outdoor gas or charcoal grills.

7. The first \$50 of the sales price of bicycle helmets.

8. The first \$250 of the sales price of bicycles.

(e) Sports equipment includes any item used in individual or team sports, not including clothing or footwear, selling for \$40 or less.

(5) The tax exemptions provided do not apply to sales within a theme park or an entertainment complex as defined in Section 509.013(9), F.S., within a public lodging establishment as defined in Section 509.013(4), F.S., or within an airport as defined in Section 330.27(2), F.S.

(6) Articles Normally Sold as a Unit.

(a) Articles that are normally sold as a unit must continue to be sold in that manner; they cannot be separately stated and sold as individual items in order to obtain the exemption.

(b) Example: A pair of water skis normally sells for \$300. The pair of skis cannot be split in order to sell each ski for \$150 to qualify for the exemption.

(7) Sales of Sets Containing Both Exempt and Taxable Items.

(a) When exempt items are normally sold together with taxable merchandise as a set or single unit, the sales price of the set or single unit is subject to sales tax.

(b) Example: A packaged set consisting of swim fins (which are not exempt during the holiday period) and a swim mask (which is exempt) is sold for a single price of \$30. Although the swim mask would otherwise be exempt during the holiday period, the sales price of the packaged set is subject to tax.

(8) Gift Cards.

(a) Eligible items purchased during the holiday period using a gift card will qualify for the exemption, regardless of when the gift card was purchased.

(b) Eligible items purchased after the holiday period using a gift card are taxable, even if the gift card was purchased during the holiday period.

(c) A gift card does not reduce the selling price of an item.

(9) Buy One, Get One Free or for a Reduced Price. The total price of items advertised as “buy one, get one free” or “buy one, get one for a reduced price” cannot be averaged in order for both items to qualify for the exemption.

(10) Exchanges.

(a) If a customer purchases an eligible item during the holiday period, then later exchanges the item for the same item (different size or different color), no additional tax will be due even if the exchange is made after the holiday period.

(b) If a customer purchases an eligible item during the holiday period, then later returns the item and receives credit on the purchase of a different item, the new item purchased is subject to tax.

(11) Coupons, Discounts, and Rebates. The sales price of an item includes all consideration received by the retailer for

that item. The price of an item is not limited to the amount paid by a customer.

(a) Manufacturer’s coupons do not reduce the sales price of an item, because the retailer is reimbursed for the amount of any discount provided to a customer. Therefore, the amount of the reimbursement is included in the taxable sales price of an item.

(b) Store coupons, discounts, or rebates offered by the retail seller reduces the sales price of an item because it reduces the total amount received by the retail seller for the item.

(c) Rebates occur after the sale and do not affect the sales price of an item purchased.

(12) Returns. When a customer returns an item purchased during the sales tax holiday period and requests a refund or credit of tax the customer must produce a receipt or invoice showing tax was charged and paid on the original purchase of the item, or the retailer must have sufficient documentation to show tax was paid on the original purchase of the item.

(13) Rain checks. Eligible items purchased during the holiday period using a rain check will qualify for the exemption regardless of when the rain check was issued. However, issuance of a rain check during the holiday period will not qualify an eligible item for the exemption if the item is purchased after the holiday period.

(14) Layaway sales. A layaway sale is a transaction in which merchandise is set aside for future delivery to a customer who makes a deposit, agrees to pay the balance of the purchase price over a period of time, and receives the merchandise at the end of the payment period. Eligible items placed on layaway during the holiday period are tax exempt, even if final payment of the layaway is made after the holiday period. If a customer makes a final payment and takes delivery of the item during the holiday period, the eligible items are tax exempt.

(15) Remote Sales.

(a) Qualifying items purchased through a marketplace provider or from a remote seller are exempt when the order is accepted by the marketplace provider or remote seller during the sales tax holiday period for immediate shipment, even if delivery is made after the sales tax holiday period.

(b) An order is accepted by the company when action has been taken to fill the order for immediate shipment. Actions to fill an order include assigning an “order number” to a telephone order, confirming an Internet order by an email to the customer, or placing a date received on an order received by mail.

(c) An order is considered to be for immediate shipment when delayed shipment is not requested by the customer. An order is for immediate shipment even if the shipment may be delayed because of a backlog of orders or stock is currently unavailable or on back order.

(16) Shipping and Handling Charges. When separately stated shipping charges are part of the sales price of the items



listed on a sales invoice or receipt, the shipping charges must be proportionately allocated to each item sold to determine the total sales price of the item. The cost of each item is divided by the total cost of all the items ordered to obtain the percentage of cost that each item bears to the total order. The amount of the shipping charge applicable to each item is calculated by multiplying the total shipping charge by the percentage of cost for each item.

(17) Service Warranties. The taxation of any charges for a service warranty contract depends on the taxability of the product being sold. If the retail sale of an item is exempt from tax, the charge for a service warranty sold with the item is exempt.

(18) License Fees or Other Fees imposed by Panama City and Panama City Beach. Panama City and Panama City Beach impose a 1 percent merchant’s license fee or tax on retailers. The merchant’s license fee is included in the sales price of each item. If the fee is separately stated, it must be assigned to the sales price of each item on the invoice to determine if an item is exempt during the holiday.

(19) Repairs or Alterations to Eligible Items.

(a) Repairs to eligible items do not qualify for the exemption.

(b) Alterations to clothing or footwear do not qualify for the exemption, even though alterations may be sold, invoiced, and paid for at the same time as the item to be altered is purchased.

(20) Rentals. Rentals of eligible items do not qualify for the exemption.
