6A-10.02413 Civic Literacy Competency

PURPOSE AND EFFECT: Currently, the Division of Florida Colleges (Division), implements Rule 6A-10.02413, F.A.C., which requires students to take and pass either a course or an assessment to demonstrate civic literacy competency. The rule has been in place since 2018. The proposed rule amendment will update the current rule to specify that both an assessment and a course are required to meet the civic literacy competency requirements. In addition to the list of currently approved assessments in rule, which are the AP and CLEP, the Florida Civic Literacy Test will be added as a low-cost option. The amendment also specifies that high school students who take the U.S. Government course and pass the Florida Civic Literacy Test will have met the postsecondary civic literacy assessment requirement. Lastly, the amendment allows credit earned through articulated acceleration mechanisms to count toward the course requirement and the assessment requirement, if the assessment is identified in rule. All FCS institutions will be affected by the rule amendment. The effect of this amendment will require colleges to modify their policies, procedures, advising practices and catalogs regarding the new civic literacy requirements.

The Florida Department of Economic Opportunity announces an opportunity for public review of the state's application for Low-Income Household Water Assistance Program (LIHWAP) funds.

DATE AND TIME: August 2, 2021 through August 5, 2021. The proposed application has been developed in compliance with the requirements of the Consolidated Appropriations Act of 2020 and the American Rescue Plan Act of 2021 and includes information on the types of activities to be supported and categories or characteristics of individuals to be served through use of the state's allocation of LIHWAP funding.

PLACE: The Florida Department of Economic Opportunity (DEO) will receive comments and recommendations on the Low-Income Household Water Assistance Program application via email at LIHWAP@deo.myflorida.com. All comments submitted by email will be included as part of the official record and considered by DEO.

GENERAL SUBJECT MATTER TO BE CONSIDERED: The Low-Income Household Water Assistance Program (LIHWAP) was created as an emergency program to provide funds to help low-income households affected by the COVID-19 pandemic pay their water and wastewater bills, avoid water shut-offs, and support water reconnections related to nonpayment. The program was funded through two Congressional spending packages: \$638 million as part of the \$2.3 trillion spending package passed in December and \$500 million from the American Rescue Plan passed in March 2021.

The United States Department of Health and Human Services (HHS), Administration for Children and Families (ACF), Office of Community Services (OCS), Division of Energy Assistance (DEA), administers LIHWAP. The administration of this program is authorized under Section 553 Title V of Division H of the Consolidated Appropriations Act, 2021, Public Law No. 116-260 and the American Rescue Plan Act of 2021, Public Law 117-2. HHS has provided guidance that LIHWAP should be modeled on existing processes, procedures, policies, and systems in place to provide assistance, such as the Low-Income Home Energy Assistance Program (LIHEAP) administered by DEO.

Approximately \$75 million was appropriated to Florida through the Consolidated Appropriations Act of 2021 and the American Rescue Plan Act of 2021 in one-time funding to assist low-income households with water and wastewater bills. DEO has been designated the administering agency for LIHWAP in Florida.

The LIHWAP Model Plan outlines eligibility requirements, benefit levels, and the projected funds for LIHWAP assistance. LIHWAP funds are used to assist low-income households with water and wastewater bills.
