(2) General Requirements. In the case of any applicant applying for an exemption from certificate of need review, the request shall include:

(a) The type of exemption requested, with reference to the authorizing paragraph in s. 408.036(3), F.S. Except as provided in paragraphs (6)(a) or (b) of this rule, an exemption request must be limited to a single type of exemption.

(b) The name of the health care facility or hospice involved, and the name of the licensee. A request for exemption affecting an existing licensed health care facility or hospice must be submitted by the current licensee.

(c) The location of the project.

(d) The costs of the project.

(e) The gross square footage of the project, if applicable.

(f) The proposed licensed bed capacity of the health care facility, if applicable.

(g) A non-refundable fee of two hundred and fifty dollars (\$250) payable to the Agency for Health Care Administration in accordance with s. 408.036(4), F.S. Exemption requests shall not be accepted by the agency at the time of receipt unless accompanied by the \$250 fee. Attendance at a continuing education program must be certified by the lecturer or someone in charge of the program. An instructor of a course may credit the hours taught towards completion of the required continuing education; provided, however, that an instructor may only credit a course once, regardless of the number of times the course is taught. 2. ~~The applicant is registered or licensed as a drug manufacturer as specified in Chapter 499, F.S.; The manufacture and distribution of the radiopharmaceutical containing radioactive material is not subject to the Federal Food, Drug and Cosmetic Act and the Public Health Service Act; or~~

3. The applicant has a nuclear pharmacy permit and only authorized nuclear pharmacists compound or dispense radiopharmaceuticals as specified in Section 465.0193, F.S.

(c) The applicant submits information on the radionuclide, chemical and physical form, packaging including maximum activity per package, and shielding provided by the packaging of the radioactive material which is appropriate for safe handling and storage of radiopharmaceuticals by medical use group licensees; and

(d) The applicant satisfies the following labeling requirements:

1. The label affixed to each transport radiation shield of any material of a radioactive drug transferred for commercial distribution includes the radiation symbol and the words "Caution, Radioactive Material" or "Danger, Radioactive Material"; the name of the radioactive drug or its abbreviation; and the quantity of the radioactive material at a specified date and time. The time can be omitted for radioactive drugs with a half life greater than 100 days. ~~The label affixed to each package of the radiopharmaceutical contains information on the radionuclide, quantity and date of assay and the label affixed to each package contains a statement that the radiopharmaceutical is licensed by the department for distribution to persons licensed pursuant to Part VI and Rule 64E-5.626, 64E-5.627, 64E-5.630, F.A.C., as appropriate, or under equivalent licenses of the U.S. Nuclear Regulatory Commission, an agreement state or a licensing state.~~

2. A label affixed to each syringe, vial, or other container used to hold a radioactive drug transferred for commercial distribution includes the words "Caution, Radioactive Material" or "Danger, Radioactive Material" and an identifier that correlates the syringe, vial, or other container with the information on the transport radiation shield label; and ~~The labels, leaflets or brochures required by (10)(d)1., above, are in addition to the labeling required by the Federal Food and Drug Administration (FDA) and they may be separate from or, with the approval of FDA, may be combined with the labeling required by FDA.~~

(e) A licensee shall possess and use instruments to measure the radioactivity of radioactive drugs. The licensee shall have procedures for use of the instruments. The licensee shall measure by direct measurements or by combination of measurements and calculations the amount of radioactivity in doses of alpha-emitting, beta-emitting, or photon-emitting radioactive drugs before transfer for commercial distribution. In addition, the licensee shall:

1. Perform tests before initial use, periodically, and following repair on each instrument for accuracy, linearity, and geometry dependence appropriate for the use of the instrument and make adjustments when needed; and

2. Check each instrument for constancy and proper operation at the beginning of each day of use.

FINAL ORDER

The Department of Community Affairs (the "Department") hereby issues its Final Order, pursuant to §§ 380.05(6) and (11), Fla. Stat. (2000), and § 380.0552(9), Fla. Stat. (2000), approving a land development regulation adopted by a local government within the Florida Keys Area of Critical State Concern as set forth below.

FINDINGS OF FACT

1. On April 26, 2001, the Department received for review Islamorada, Village of Islands Ordinance No. 01-02 which was adopted by the Village Council ("Ord. 01-02"). Ord. 01-02 modifies the existing land development regulations for Transfer of Dwelling Unit Allocation Exemption Rights For Off-Site Redevelopment in section 9.5-121(g) of the Village Code.

CONCLUSIONS OF LAW

2. The Department is required to approve or reject land development regulations that are enacted, amended or rescinded by any local government in the Florida Keys Area of Critical State Concern. §§ 380.05(6) and (11), Fla. Stat. (2000), and § 380.0552(9), Fla. Stat. (2000).
3. Islamorada, Village of Islands is a local government within the Florida Keys Area of Critical State Concern. § 380.0552, Fla. Stat. (2000), and Rule 28-29.002 (superseding Chapter 27F-8), Florida Administrative Code.
4. "Land development regulations" include local zoning, subdivision, building and other regulations controlling the development of land. § 380.031(8), Fla. Stat. (2000). The regulations adopted by Ord. 01-02 are land development regulations.
5. All land development regulations enacted, amended or rescinded within an area of critical state concern must be consistent with the Principles for Guiding Development (the "Principles"). The Principles are construed as a whole and no specific provision is construed or applied in isolation from the other provisions. § 380.0552(7), Fla. Stat. (2000).
6. Ordinance 01-02 is not inconsistent with the Principles for Guiding Development. Therefore, Ord. 01-02 is consistent with the Principles for Guiding Development as a whole.

WHEREFORE, IT IS ORDERED that Ord. 01-02 is found to be consistent with the Principles for Guiding Development of the Florida Keys Area of Critical State Concern, and is hereby APPROVED.
