PURPOSE AND EFFECT: The purpose and effect of the proposed rule is to comply with Ch. 2012-13, Laws of Florida, that directed the Florida Building Commission to establish a workgroup to assist the commission in developing a rule for implementing an alternative design method for screen enclosures that allows for the removal of a section of the screen to accommodate high-wind events consistent with the provisions of the Florida Building Code.

SUMMARY: As mandated by law, the proposed rule provides for an alternative screen enclosure design to be required by the Florida Building Code. The proposed alternative is a site-specific engineered design method which allows for cutting, retracting or removing of certain sections of the screen enclosure when winds are forecasted to exceed 75 mph. The proposed alternative is limited in scope to aluminum screen enclosures and provides for labeling and replacement criteria for the screen panels that are designed to be cut.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: the economic review conducted by the agency.

THE FULL TEXT OF THE PROPOSED RULE IS:

61G20-1.002 Alternative Design Method for Screen Enclosure.

(1) The purpose of this Rule is to provide an alternate method for designing aluminum screen enclosures as defined by the Florida Building Code permitting the loads of the

structural frame to be based on portions of the screen in the screen walls removed, retracted, moved to the open position or cut. The use of framing materials other than aluminum is allowed in accordance with section 104.11 of the Florida Building Code, Building. The method applies only to walls and roofs with 100% screen. The provisions of Chapter 1 of the Florida Building Code, Building shall govern the administration and enforcement of this Rule.

(a) Screen enclosure frames designed in accordance with the screen removal alternates of this rule, shall be designed using signed and sealed site-specific engineering and shall be designed in accordance with the wind load provisions of the Florida Building Code, Section 1609.1.1.

(b) Designs that consider these screen alternates shall comply with Florida Building Code, Building, Section 2002.4 and Table 2002.4 using the 110 mph column as modified by Table 2002.4A with all screen panels in place.

(c) Designs using strength design or load and resistance factor design in accordance with the Florida Building Code, Building Section 1605.2, or allowable stress design methods of the Florida Building Code, Building, Section 1605.5.3.1 shall be permitted.

(d) The design shall be by rational analysis or by 3D Finite Element Analysis. Either method will be acceptable.

(2) Where screen enclosures are designed in accordance with the screen removal alternates of this rule, removable screen may consist of removable panels, retractable panels, or by designating specific screen panels in the design in which the screen is to be removed by cutting the screen. Removable panels shall be removed, retractable panels shall be placed in the retracted position without increasing the load on the affected area. Screen designated in the design to be cut shall be completely cut when wind speeds are forecast to exceed 75 mph.

(3) Where screen enclosures designed in accordance with the screen removal alternates of this rule serve as the barrier required by the Florida Building Code at Sections 424.2.17 and R4101.17.1, the required minimum height of the barrier shall be maintained when screen panels are retracted, removed, moved to the open position, or cut.

(4) Where screen enclosures are designed in accordance with the screen removal alternates of this rule, retractable screen panels, removable screen panels, and screen panels identified to be cut shall be clearly identified on adjacent structural members with highly visible permanent labels, at each panel, or by other means approved by the local building department.

(5) Where screen enclosures are designed in accordance with the screen removal alternates of this rule, the retraction of screen panels, removal of screen panels, or cutting of screen panels shall not require the use of ladders or scaffolding.

(6) Engineering documents submitted with building permit applications shall identify the panels to be removed, retracted, opened, or cut.

(7) Where screen enclosures are designed in accordance with the screen removal alternates of this rule based on removing screen panels by cutting the screen, the contractor shall provide replacement screen for a one-time replacement of all screen and spline designated by the design to be cut.

(8) Where screen enclosures are designed in accordance with the screen removal alternates of this rule, the contractor shall provide written notice to the owner and the local building code enforcement department that the owner must retract, remove, or cut a panel or panels of the screen enclosure in accordance with the project engineering design or the manufacturer’s instructions when wind speeds are expected to exceed 75 mph.

Notice is hereby given that the following correction has been made to the proposed rule in Vol. 38, No. 62, October 31, 2012 issue of the Florida Administrative Register.

These changes are in response to written comments received from the Joint Administrative Procedures Committee dated November 20, 2012. The changes are as follows:

The Summary of Statement of Estimated Regulatory Costs and Legislative Ratification in the Notice of Proposed Rule is revised to include the District’s basis for determining that no SERC is required and that the proposed rule is not likely to require legislative ratification.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The proposed amendments will not result in an adverse economic impact on small businesses or increased costs to the regulated public. Therefore, the rulemaking does not require a SERC or legislative ratification.

The District is amending its rules to incorporate two forms by reference. Pre-installation and reimbursement forms to be used by permittees in the Dover/Plant City Water Use Caution Area required to install a flow meter. This flow meter needs to meet specific requirements as described in the rule. The pre-installation form will be completed and submitted to the District prior to meter installation. The reimbursement form will allow the permittee to obtain a refund for the cost of the meter and installation. These page-long forms ask basic questions about the site and the meter to be installed. Thus, the permittee is not expected to incur additional cost in the process of completing these forms.

Moreover, agricultural permittees responsible for mitigating the impacts neighboring wells gone dry after a frost/freeze emergency will have up to three (3) business days to file mitigation reports with the District. This will allow more flexibility, especially to those permittees responsible for mitigating multiple dry wells. As the majority of farms in this area are likely small businesses, adoption of the proposed rule is not expected to increase their costs or negatively impact them.

Applications for course provider ~~and training course approval~~ must be submitted using Form DBPR ALU 7, "Application for Education Course Provider", effective December 2012, incorporated and adopted herein ~~the form provided by the Department. Applications for training course approval must be submitted using Form DBPR ALU 8, "Education Course Application", effective December 2012, incorporated and adopted herein.~~ The forms may be obtained by contacting the Department at the following address: Asbestos Licensing Unit, 1940 N. Monroe Street, Tallahassee, Florida 32399-1027 or at <http://www.myflorida.com/dbpr/pro/forms/asbest/>. Any substantial change in the course content will require the provider to reapply to the Department for approval.

(3) A training course provider must meet the standard set forth in 40 C.F.R. Part 763, Appendix C to Subpart E, ~~59 FR 5251, as amended November 12, 2010, July 1, 2007~~ and incorporated herein by reference. (a) Training providers and courses approved by a state that has a written reciprocating agreement with the Department.

(b) Training courses recognized by the Environmental Protection Agency and listed in the National Directory of Asbestos Hazard Emergency Response Act Accredited Courses as set forth in 40 C.F.R. Part 763, Appendix C to Subpart E, as amended November 12, 2010, 7/1/2007 and incorporated herein by reference.

(4) through (5) No change.

(6) Training course audits.

(a) The Department shall; conduct on-site audits of in person training courses. The Department shall conduct online audits of online training courses. The Audits/online audits of training courses at no cost to the Department, which shall include:

1. Training course content;
2. Technical accuracy;
3. Instructor effectiveness; and
4. Course administration.

(b) Such audits may be conducted without advance notice if the Department has reasonable cause to believe that a violation of this rule or Chapter 469, Florida Statutes, has occurred.

(c) Training course providers who are located outside this state must meet the requirements of this section in either of the following ways:

1. The training course provider will make arrangements for the Department representatives to conduct an on-site review of the training course located outside the state at no charge, including travel, subsistence, and lodging costs as provided in Section 112.061, Florida Statutes.

2. Another state in which the training provider is approved has a reciprocal agreement with this state for auditing of training courses for compliance with the standards set forth in this rule.

(d) All training course providers shall provide copies of course materials and other necessary information to the Department for courses being audited at no cost to the Department.

(7) through (10) No change.

(11) The application for online courses shall include the total number of classroom or interactive distance learning hours, the course syllabus, a detailed outline of the contents of the course, the name and qualifications of all instructors and minimum qualifications of all instructors. Online training courses are only available for refresher courses. In addition, a course provider applying to offer interactive distance learning courses must meet applicable classroom course requirements and must submit documents indicating the following:

(a) The means by which the course provider is able to monitor student enrollment, involvement, participation, course completion, and comprehension of content at regular intervals.

(b) The means by which the course provider will be able to satisfactorily demonstrate that stated course hours are consistent with the actual hours spent by each student to complete the course.

(c) The means by which the provider will provide necessary support throughout the course including, but not limited to, the means by which the course provider will respond to student inquiries within 24 hours of receipt.

(d) That the student will be required to complete a statement at the beginning and end of the course that indicates that he/she personally completed each module/session of instruction.

(e) The means by which the course provider will verify student identification and completion of initial course.
