PURPOSE AND EFFECT: The purpose of these amendments to the rules in Chapter 34-5, F.A.C., is to incorporate the statutory changes made pursuant to the enactment of Chapter 2013-36, LOF. Primarily, the changes in the law now allow referrals from the Governor, the Department of Law Enforcement, a state attorney, or a United States Attorney. The law also increased the "black-out" period for complaints filed five (5) days prior to an election. As a result, complaints or referrals filed within thirty (30) days of an election will now be returned, unless based upon personal information or information other than hearsay.

SUBJECT AREA TO BE ADDRESSED: These rules involve the Commission's procedures for the filing, handling, and disposition of complaints and referrals alleging a breach of public trust filed with the Commission.

69A-37.065 Programs of Study and Vocational Courses PURPOSE AND EFFECT: Section 633.45(1), F.S., requires the Division to (i) establish minimum standards for the employment and training of firefighters; (ii) establish minimum curriculum requirements for schools operated for the specific purpose of training firefighter recruits or firefighters; and (iii) issue certificates of competency to persons who, by reason of experience and completion of basic training, are especially qualified for particular aspects or classes of firefighter duties.

SUMMARY: The proposed amendments to Rule 69A-37.039, F.A.C., will amend two current forms and add six new forms that will be used by the Division to determine whether a fire officer applicant meets certain training requirements to receive a voluntary certificate of competency from the Division. The proposed amendments to Rule 69A-37.065, F.A.C., will add

two additional levels, Fire Officer III and Fire Officer IV, to the existing Fire Officer Program. This training program is being expanded to provide training opportunities for persons who serve as senior fire officers in volunteer and career fire department agencies. This program enhancement will improve alignment with the National Fire Protection Association (NFPA) 1021, Standard for Fire Officer Professional Qualifications (2009 Edition). The rule amendment will also adjust the program requirements at the existing Fire Officer I and II levels. The introduction of the Fire Officer III and IV levels along with the adjustments to the Fire Officer I and II level are recommended by the Firefighters Employment, Standards, and Training Council established by Section 633.31, F.S.

- 69A-37.065 Programs of Study and Vocational Courses. The following programs of study are developed and revised by the Florida State Fire College, pursuant to Sections 633.45 and 633.081, F.S.:
 - (1) No change.
- (2) Fire Officer Program. This is an advanced training and certification program designed for firefighers having supervisory and management responsibilities. This program is based on the National Fire Protection Association (NFPA) 1021, Standard for Fire Officer Professional Qualifications. This program is intended to prepare students for service as fire department company and chief officers at four progressive levels lieutenants, captains or equivalent positions and consists of Fire Officer I and Fire Officer II certificates of competency. The applicant may provide proof of equivalent education and training approved by the Bureau of Fire Standards and Training and meeting the criteria outlined under this subsection (2).
- (a) Fire Officer I Certification. The Division shall issue a Fire Officer I Certificate of Competency to a firefighter who meets the program requirements of this paragraph (a), and the qualifications for Fire Officer I set forth by the Division and based on the National Fire Protection Association (NFPA) 1021, "Standard for Fire Officer Professional Qualifications," (2009 Edition), which is hereby incorporated by reference.
- 1. Program Requirements Length of Program. To qualify for certification, a candidate must complete the prequisite course titled "Courage to be Safe" or a course determined by the Division to be equivalent. This program shall consist of not less than 180 hours of training. Each course shall be no less than 45-hours in duration. This program shall consist of the following courses or those of equivalent interactive instruction, as approved by the Bureau of Fire Standards and Training.

This program shall consists of no fewer than eight courses, vocational or academic, of not less than 320 hours or the following courses or those of equivalent of interactive instruction, as approved by the Bureau of Fire Standards and Training.

 - c. Fire Prevention Practices.
 - d. Private Fire Protection Systems I.

Statoil has applied for an OCS air permit pursuant to section 328 of the Clean Air Act (CAA) from EPA Region 4. The proposed air permit will regulate emissions from a proposed exploratory drilling operation within the DeSoto Canyon lease area of the OCS. The proposed project will include mobilization and operation of one of two deep water drilling vessels, the Maersk Developer drill rig or the Transocean Discoverer Americas drill ship, and associated crew and support vessels. Drilling operations may occur for up to 180 days per year within Statoil's DeSoto Canyon lease blocks for a period of five to ten years. The proposed project is for exploratory drilling only and does not include the establishment of any permanent production platforms.

Statoil proposes to conduct exploratory drilling at multiple sites within its DeSoto Canyon lease blocks designated Lease Sale areas 213 and 222. These lease blocks (numbers 143, 187, 188, 230, 231, 625, 669, 670, 671, 715, 716, 759, 760, and 804) are located in OCS waters of the Gulf of Mexico east of longitude 87.5°, approximately 160 miles southeast of the mouth of the Mississippi River and 200 miles southwest of Panama City, Florida.

EPA Region 4 is the agency responsible for implementing and enforcing CAA requirements for OCS sources in the Gulf of Mexico east of longitude 87.5°. Pursuant to section 328 of the CAA, 42 U.S.C. § 7627, and the air quality regulations applicable to OCS sources set forth in Title 40, Code of Federal Regulations (CFR), part 55, this project is required to obtain an OCS air quality permit and is subject to Prevention of Significant Deterioration (PSD) requirements that apply to major sources and also to title V operating permitting requirements. Statoil must apply best available control technology (BACT), among other requirements, for emissions of NOX. The maximum potential annual emissions in tons per year for each drilling vessel and its support vessels are detailed in the application materials and preliminary determination/statement of basis. Potential annual emissions are also summarized in the project fact sheet.

EPA's draft permit and preliminary determination/statement basis: Statoil's application and supporting documentation/data; and comments received from the public, other government agencies, and the applicant during the public comment period will become part of the administrative record for the permit. An extension of the 30-day comment period may be granted if the request for an extension adequately demonstrates why additional time is required to prepare comments.

Any interested person may submit written comments on the draft permit during the public comment period. If you believe that any conditions in the permit are inappropriate, you must raise all reasonably ascertainable issues and submit all reasonably available arguments supporting your position by the end of the comment period. Any documents supporting your comments must be included in full and may not be incorporated by reference unless they are already part of the record for this permit or consist of state or federal statutes or regulations, EPA documents of general applicability, or other generally available reference materials.

Comments should focus on the draft air quality permit. If you have general comments regarding offshore leasing, non-air quality impacts, drilling safety, discharge, or other similar issues not subject to this public comment period, you should submit them during the leasing and approval proceedings of the Bureau of Ocean Energy Management, which is the lead agency for offshore drilling.

All comments will be included in the administrative record without change and will be made available to the public. including any personal information provided, unless the comment includes Confidential Business Information or other information whose disclosure is restricted by statute. Information that you consider Confidential Business Information or otherwise protected should be clearly identified as such and should not be submitted through email. If you send email directly to EPA, your email address will be captured automatically and included as part of the public comment. An email or postal address must be provided with your comments if you wish to receive direct notification of EPA's final decision regarding the permit and response to comments submitted during the public comment period. All timely comments on the draft permit will be considered in making the final decision. EPA will respond to all significant comments on the proposed permit and may summarize and group similar comments in our response. EPA will not respond to individual commenters directly.
