PURPOSE AND EFFECT: The purpose of the amendment to Rule 59G-8.600, F.A.C. is to clarify the requirements for good cause disenrollment, by enrollees, from Statewide Medicaid Managed Care plans. The amendment also revises the rule title to Good Cause for Disenrollment from Managed Care Plans.

SUBJECT AREA TO BE ADDRESSED: Good Cause for Disenrollment from Health Plans.

An additional area to be addressed during the workshop will be the potential regulatory impact Rule 59G-8.600, Florida Administrative Code, will have as provided for under sections 120.54 and 120.541, Florida Statutes.

THE PRELIMINARY TEXT OF THE PROPOSED RULE DEVELOPMENT IS:

59G-8.600 Good Cause for Disenrollment from Managed Care Health Plans.

(1) Purpose. A Florida Medicaid recipient (herein referred to as an enrollee) who is required to enroll in the Statewide Medicaid Managed Care (SMMC) Managed Medical Assistance (MMA) or Long-term Care (LTC) program, may request to change managed care plans for good cause at any time. Such request must be submitted to the Agency for Health Care Administration (AHCA) or its enrollment broker. Enrollees required to enroll in SMMC programs should not interpret this rule as an exemption from participation in Florida Medicaid's SMMC program. This rule only applies to the process and reasons for which managed care enrollees may change plans. Recipients subject to the 12 month enrollment period may request disenrollment from the health plan for cause at any time during their no change period. The no change period is defined as the period of time during which a recipient cannot change plans without a good cause reason in accordance with 42 CFR 438.56(e). Recipients making such requests must submit the request to the call center representative for a determination.

(2) Definitions. Active relationship - when an enrollee has received services from a service provider within the six months preceding a disenrollment request.

(3)(2) Good Cause Reasons. The following reasons constitute good cause for disenrollment from the managed care health plan:

(a) The enrollee does not live in a region where the managed care plan is authorized to provide services, as indicated in the managed care plan's contract with AHCA recipient moves out of the county, or the recipient's address is incorrect and the recipient does not live in a county, where the health plan is authorized to provide services.

(b) The enrollee recipient is excluded from enrollment in a managed care plan, pursuant to Sections 409.965, 409.972, and 409.979, Florida Statutes (F.S.).

(c) A substantiated marketing violation, confirmed by AHCA, has occurred with the individual recipient that is substantiated by the Agency for Health Care Administration, Bureau of Managed Health Care. The recipient must submit the allegation in writing to the Bureau of Managed Care, 2727 Mahan Drive, M.S. 26, Tallahassee, FL 32308.

(d) The enrollee recipient is prevented from participating in the development of his or her treatment plan or plan of care.

(e) The enrollee recipient has an active relationship with a service health care provider who is not in on the managed care health plan's network, but is in the network of another managed care health plan ; or the health care provider with whom the recipient has an active relationship is no longer with the health plan.

(f) The enrollee is in the wrong managed care plan, as determined by AHCA. The recipient is ineligible for enrollment in the health plan.

~~(g) The health plan no longer participates in the county in which the recipient resides.~~

~~(g) The state has imposed intermediate sanctions upon the managed care plan, as specified in Title 42, Code of Federal Regulations (CFR), Section 438.702(a)(3).~~

~~(h) The enrollee recipient needs related services to be performed concurrently (for example, a cesarean section and tubal ligation), but not all related services are available within the managed care health plan's network; or the enrollee's recipient's primary care provider (PCP) has determined that receiving the services separately would subject the enrollee recipient to unnecessary risk.~~

~~(i) The managed care health plan does not, because of moral or religious objections, cover the service the enrollee recipient seeks.~~

~~(j) The enrollee missed open enrollment due to a temporary loss of eligibility.~~

~~(k) Other reasons, per 42 CFR 438.56(d)(2) and Section 409.969(2), F.S.~~

~~(j) Poor quality of care.~~

~~(k) Lack of access to services covered under the contract, including lack of access to medically necessary specialty services.~~

~~(l) The health plan makes inordinate or inappropriate changes of the recipient's primary care provider (PCP).~~

~~(m) An unreasonable delay or denial of service.~~

~~(n) Service access impairments due to significant changes in the geographic location of services.~~

~~(o) There is a lack of access to health plan providers experienced in dealing with the recipient's health care needs.~~

~~(p) Fraudulent enrollment.~~

~~(q) The recipient, although otherwise locked in, requests enrollment in a specialty plan and meets the eligibility requirements for the specialty plan.~~

~~(r) The recipient received a notice from their plan of a reduction in required benefits at the end of the plan's annual contract year (for the next year).~~

(4)(3) The Agency for Health Care Administration will process all disenrollments from the managed care plan. The Agency for Health Care Administration, or its designee, will make final determinations about granting disenrollment requests and will notify the enrollee by surface mail of any disenrollment decision. Enrollees dissatisfied with the determination may request a Florida Medicaid fair hearing, pursuant to 42 CFR Part 431, Subpart E. The Agency's vendors shall mail a Disenrollment Denial Letter, AHCA/HSD Form #1, Eng., January 2009; Spanish version, AHCA/HSD Form #1Sp., January 2009; or Creole version, AHCA/HSD, Form #1C., January 2009, incorporated by reference, to recipients whose requests to disenroll from plans during the no change period are denied.

THE FULL TEXT OF THE PROPOSED RULE IS:

14-107.02 Joint Public-Private Development of Right of Way.

(1) Upon a determination by the Florida Department of Transportation to lease right of way for a joint public-private transportation purpose or receipt of an unsolicited joint public-private right of way development proposal which the Department finds worthy of consideration, the Department will prepare an estimate of its cost to evaluate proposals. The Department will publish a request for proposals on its website and in a newspaper of general circulation once a week for two weeks identifying the requirements of the proposal and the estimated cost of reviewing the proposals as a non-refundable application fee. Only proposals submitted with an application fee will be considered by the Department. The application fee will be in the form of a cashier's check or other non-cancelable instrument payable to the Florida Department of Transportation. Personal checks will not be accepted for the application fee.

(2) If the evaluation costs exceed those covered by the application fee, the Department will notify the proposer(s) in writing and require additional payment to be made before review of the proposal. The proposer(s) shall pay to the Department the additional fee within thirty days after receipt of notification. Failure to make such payment shall result in the proposal being rejected as non-responsive.

The following changes have been made to the Florida Medicaid Visual Aid Services Coverage Policy: Table of Contents has been renumbered and updated accordingly.

Section 1.1.1 Medicaid Policies, the title is Florida Medicaid Policies, and now reads:

This policy is intended for use by visual aid services providers that render services to eligible Florida Medicaid recipients. It must be used in conjunction with Florida Medicaid's general policy and any applicable service-specific and claim reimbursement policies with which providers must comply.

Section 1.1.2 Statewide Medicaid Managed Care Plans, Florida was added to all Medicaid references.

Section 1.3 Definitions, alphabetized subsection title and renumbered based on coverage policy update.

Section 1.3.1 Claim Reimbursement Policy, section added and now reads:

A policy document handbook that provides instructions on how to bill for services.

Section 1.3.1 Coverage and Limitations Handbook or Coverage Policy, Florida added before Medicaid reference.

Section 1.3.5 General Policy, section added and now reads:

A collective term for Florida Medicaid policy documents found in Rule Chapter 59G-1 containing information that applies to all providers including all basic requirements of the Florida Medicaid program.

Section 1.3.8 Provider General Handbook, deleted.

Section 1.3.10 Reimbursement Handbook, deleted.

Section 2.2 Who Can Receive, first sentence now reads:

Florida Medicaid recipients requiring medically necessary visual aid services.

Section 3.2 Who Can Provide, the phrase "Visual aid services providers must be one of the following:" is deleted.

Section 4.2.1 Eyeglasses, now reads:

Florida Medicaid reimburses for two pairs per 365 days for recipients under the age of 21 years.

For recipients age 21 years and older, Florida Medicaid reimburses for the following:

- One frame every two years
- Two lenses every 365 days

Florida Medicaid also reimburses the following:

- Polycarbonate or thermoplastic lens materials for a recipient's safety or documented medical condition (when necessary)
- Metal frames when plastic frames are medically inappropriate

Florida Medicaid may reimburse for additional frames, lenses, pairs of glasses, and special order frames with prior authorization.

Section 4.2.2 Fitting, Dispensing, and Adjustment of Eyeglasses, added Services to the end of title and now reads:

Florida Medicaid reimburses for services for new Medicaid-provided glasses and after factory repairs.

Section 4.2.3 Eyeglass Repair Service, now reads:

Florida Medicaid reimburses for repairs when performed in an office or by a licensed authorized dealer.

Only elements of the frames or lenses that are damaged beyond repair may be replaced.

Section 4.2.4 Contact Lenses, "Florida" added before Medicaid.

Section 4.2.5 Prosthetic Eyes, added "Florida" before Medicaid reference, and second paragraph, second sentence now reads:

Prosthetic eyes may also be reimbursed through Florida Medicaid's durable medical equipment and medical supply services.

Section 4.3 Place of Service, deleted.

Section 5.2 Specific Non-Covered Criteria, "Florida" added before Medicaid, and the sixth bullet now reads:

Glass lenses (including clear, absorptive tint, photogrey, photogrey extra, photosun, photochromic, or any glass lens product).

Section 6.1 General Criteria, now reads:

For information on general documentation requirements, please refer to the Florida Medicaid's general policy.

Section 7.1 General Criteria, second paragraph, second sentence now reads:

For recipients receiving services through the fee-for-service delivery system, providers should request authorization through the Quality Improvement Organization.

Section 7.2 Specific Criteria, second paragraph, leading sentence now reads:

Providers must obtain authorization when the following applies:

Section 8.1 General Criteria, now reads:

The reimbursement information below is applicable to the fee-for-service delivery system, unless otherwise specified.

Section 8.2 Specific Criteria, now reads:

The provider must forward the claim for reimbursement only after the fitting and dispensing is complete and the recipient has received the eyeglasses. The provider must enter the date when the eyeglasses were dispensed as the date of service on the claim form. An exception can be made to this whereby a provider may use the order date on the claim form if the recipient loses eligibility from one month to the next.

Latitude) including the waters off Collier, Monroe, Miami-Dade, Broward, Palm Beach, and Martin Counties.

(1) ~~Recreational Limits – Recreational Bag Limit~~—A recreational harvester may not harvest, possess, or land more than ~~two great barracuda per day within the above described region.~~

(a) Recreational Bag Limit – A recreational harvester may not harvest, possess, or land more than two great barracuda per day within the above described region.

(b) Recreational Vessel Limit – The recreational harvesters aboard a vessel may not collectively harvest, possess, or land more than six great barracuda per day within the above described region, regardless of the number of persons onboard.

(2) Commercial Limits –

(a) Commercial Bag Limit – A commercial harvester may not harvest, possess, or land more than two ~~20~~ great barracuda per day within the above described region.

(b) Commercial Vessel Limit – The commercial harvesters aboard a vessel may not collectively harvest, possess, or land more than six ~~20~~ great barracuda per day within the above described region, regardless of the number of persons onboard.
