(II)(III). Students who died or were totally and permanently disabled; those who left school to serve in the armed forces or were called to active duty; those who left to serve with a foreign aid service of the federal government, such as the Peace Corps; and those who left to serve on an official church mission are removed from the denominator.

c. Calculating Rates.

- (I). through (II). No change.
- (c). "Postgraduation Employment and Continuing Education" means a student has either an enrollment record in the year following graduation or a student graduated from college and has an earnings record during at least one fiscal quarter in the year following graduation.
- 1. This measure captures the outcomes of a cohort of graduates in the year after graduating. To be included in the cohort, the student would have earned a degree, certificate, diploma or apprenticeship awarded by the Florida College System institution first attended.
