PURPOSE AND EFFECT: The proposed rule amendments are intended to delete outdated language regarding the providing of community service in disciplinary cases and to set forth criteria for Respondent's to attend webinars for the purpose of meeting CME requirements imposed by Board orders.

SUMMARY: The proposed rule amendments delete language regarding community service for disciplinary cases since the Board no longer imposes community service requirements. Additionally, the rule permits Respondents to complete continuing education by attending webinars provided the webinars meet specific criteria.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described

herein: During discussion of the economic impact of this rule at its Board meeting, the Board concluded that this rule change will not have any impact on licensees and their businesses or the businesses that employ them. The rule amendment will make it easier for Respondents to meet the requirements for continuing education imposed by the Board's order by allowing the continuing education to be obtained through webinars. The rule will not increase any fees, business costs, personnel costs, will not decrease profit opportunities, and will not require any specialized knowledge to comply. This change will not increase any direct or indirect regulatory costs. 64B8-8.0011 Standard Terms Applicable to Orders. Unless otherwise approved by the Board or its designee, or addressed by the Final Order, the following are the terms applicable to all Final Orders rendered by the Board in disciplinary proceedings.

- (1) through (3) No change.
- (4) Continuity of Practice.
- (a) Tolling Provisions. In the event the Respondent leaves the State of Florida for a period of 30 days or more or otherwise does not or may not engage in the active practice of medicine in the State of Florida, then certain provisions of the requirements in the Board's Order shall be tolled and shall remain in a tolled status until Respondent returns to the active practice of medicine in the State of Florida. Respondent shall notify the Compliance Officer 10 days prior to his/her return to practice in the State of Florida. The following requirements shall be tolled until the Respondent returns to active practice:
 - 1. through 3. No change.

- 4. Any provisions regarding community service shall be tolled-
 - 4.5. No change.
- (b) Active Practice. In the event that Respondent leaves the active practice of medicine for a period of one year or more, the Respondent may be required to appear before the Board and demonstrate the ability to practice medicine with reasonable skill and safety to patients prior to resuming the practice of medicine in the State of Florida.
- (5) Community Service and Continuing Education Units. All community service requirements, continuing education units/courses must be completed, and documentation of such completion submitted to DOH/Client Services, at the address set forth in subsection (3) above. Documentation of completion of community service hours must be confirmed by an official from the organization at which the community service was performed. Documentation of completion of community service hours solely from the Respondent will not be accepted.
- (a) Definition of Community Service. "Community service" shall be defined as the delivery of volunteer services to an entity which is exempt from federal taxation under 26 U.S.C. s. 501(c)(3), without fee or cost to the patient or the entity, for the good of the people of the State of Florida. Community service shall be performed outside the physician's regular practice setting. Community service plans must be preapproved by the Board's Probationer's Committee.
- (a)(b) Continuing Education. Continuing education imposed by Board Order shall be in addition to those hours required for biennial renewal of licensure. Said continuing education courses must be pre-approved by the Board's Probationer's Committee and shall consist of a formal live lecture format.
- (b) In lieu of live lecture format set forth in paragraph (5)(a) above, the Board will permit Respondents to complete required continuing medical education by attending webinars. The webinar must be pre-approved by the Board's Probationer's Committee, upon demonstration by the Respondent that the webinar meets the following conditions:
- 1. the webinar must contain specific relevant learning objectives;
 - 2. the webinar must provide for an interactive format;
- 3. the webinar must provide for a post-course assessment; and
 - 4. the webinar provider must ensure attendance.

EDUCATOR CERTIFICATION QUALIFICATIONS FOR SPECIALIZED INSTRUCTIONAL PERSONNEL

Highly Qualified Teachers

The Elementary and Secondary Education Act (ESSA) places a major emphasis on highly qualified teachers (HQT). This federal law establishes requirements for determining if a teacher meets the criteria for being reported as "highly qualified" under ESSA. It is important to note that current Florida Statutes and SBE Rules relating to the classification of teachers reported for Florida purposes as "in-field," "qualified," or "out-of-field" are not the same as the federal highly qualified designation requirements. Thus, a teacher may be considered "in-field" pursuant to the requirements of the CCD, but will not be classified as a HQT in the ESSA reporting.

Any Field Certification Coverage

Some courses listed in the CCD display the appropriate certification as "Any Field When Certificate Reflects Bachelor or Higher Degree: or "Any Academic Coverage." These coverages may not meet the requirements of ESSA "HQT" and will, therefore, be subject to review and change.

These requirements will remain in place until full implementation of the Every Student Succeeds Act (ESSA).

Dropout Prevention, Teenage Parent, and Department of Juvenile Justice Programs

To be "in-field" and "highly qualified" when assigned to Dropout Prevention, Teenage Parent, or Department of Juvenile Justice programs, teachers must be certified in the specific core academic areas being taught or use a High, Objective, Uniform State Standard of Evaluation (HOUSSE) plan to document HQT in the core academic areas being taught, as authorized by Rule 6A-1.0503, F.A.C. subjects as identified in the CCD.

<u>Highly Qualified ESE</u> Requirements for Teachers Teaching Core Content Courses for Students with Disabilities

To meet the personnel qualification requirements of 20 U.S.C.1412(a)(14)(A-E), as amended by the Every Student Succeeds Act (ESSA), Aall K-12 ESE -certified teachers teaching ESE courses in the core academic subjects as described in Section 4 must be highly qualified have the

content knowledge and skills to serve students with disabilities. Therefore, these teachers must be certified in the appropriate core academic subjects areas as noted below.

- An ESE-certified teacher teaching students in Grades K-6 enrolled in 7700 (Grades K-5 students) and 7800 (Grade 6 students) series core academic subject courses must be <u>highly qualified</u> certified in elementary education.
- An ESE-certified teacher teaching 7800 and 7900 series core academic courses must be <u>highly qualified</u> for either elementary, middle or secondary level content area certification. The level of instruction is <u>based on the grade level content that is being taught</u>, not the reading or mathematics performance level of <u>the student</u>. certified in the content area of the course number assigned.
- An ESE-certified teacher of 7800 or 7900 series core academic courses may use the Middle Grades
 Integrated Curriculum (MGIC) subject area test to meet HOT certification requirements when the content of the ESE course is applicable to MGIC.
 The use of MGIC certification for infield purposes is governed by the grandfathering provision of the Department's May 13, 2011, memorandum.

A newly hired middle (Grades 7 and 8)/secondary special education content teacher, if highly qualified in language arts, mathematics, or science at the time of hire, may have two additional years and use of the High, Objective, Uniform State Standard of Evaluation (HOUSSE) option to document HQT in the additional content subjects.

Teachers providing hospital/homebound (H/H) services (with the ESE H/H course numbers 7755020, 7855020, or 7900030 utilized), must be <u>highly qualified for certified in</u> the basic core academic subjects taught. Note: 1) If a H/H teacher is teaching a general education course, the teacher must meet certification requirements in accordance with the general education course number; 2) Course 7900030 continues as a non-credit course.

Note: Refer to the table below for additional information regarding types of courses, scheduling methods/service delivery, and certification and HQT requirements.

On March 7, 2017, Office of Financial Regulation (Consumer Finance) received a Petition for declaratory statement from Marlin 1 LLC. Marlin 1 LLC is contemplating starting a private lending company that would provide short-term loans not exceeding \$25,000 at an interest rate of 18% per annum, to both individuals and small businesses. The petition seeks a declaratory statement from the Office on whether a consumer finance license pursuant to Chapter 516, Florida Statutes would be required. On May 5, 2017, the Office issued a Final Order. The facts provided in the Petition are inadequate for the Office to make a determination whether Petitioner's proposed activities are lawful. Petitioner states that the loans would provide 'for a higher default rate of interest'. However, Petitioner does not state what this higher rate of interest would be, how long it would last, the loan amounts to which the interest rate would correlate, and what the maximum rate would be. Petitioner also mentions 'the imposition of late fees', but does not say how much these fees would be and under what specific conditions they would be imposed. Without this information, the Office cannot ascertain whether Petitioner's proposed conduct would be lawful. A declaratory statement is not available to Petitioner because the facts provided in the Petition are not clearly identified or delineated.

FLORIDA HOUSING FINANCE CORPORATION PUBLIC NOTICE TO QUALIFIED HOMEBUYERS AND LENDERS FHFC 2017 MORTGAGE CREDIT CERTIFICATE PROGRAM

The Florida Housing Finance Corporation ("FHFC") proposes to implement a program (the "Program") to provide Mortgage Credit Certificates ("MCCs") to residents of the State of Florida who purchase new or existing residences within the State. An MCC reduces the amount of income tax a qualified homeowner pays by providing a non-refundable, federal tax credit during the life of a mortgage loan. After all other credits and deductions are taken into account the value of the MCC is applied directly to a homeowner's remaining tax liability.

No sooner than 90 days following publication of this Notice, FHFC intends to issue MCCs according to the guidelines summarized below.

The credit rate on an MCC will be at least 10% and not more than 50%, depending upon loan size. The annual amount of the tax credit will be equal to the lesser of (a) the sum equal to the credit rate multiplied by the yearly interest paid or accrued on the homeowner's mortgage loan or (b) \$2,000. If the credit rate is 20% or less, there is no \$2000 cap. The amount of the credit may not exceed the homeowner's total tax liability for a specified year, but excess credit may be carried forward for up to three subsequent tax years. Use of an MCC will reduce the deduction for home mortgage interest on the homeowner's tax return. An MCC expires on the date the mortgage loan relating thereto is paid in full or refinanced and is revoked on the date the residence to which it relates ceases to be the taxpayer's primary residence. FHFC reserves the right to adjust the MCC credit rate or make allocations to specific sectors of the housing industry or to conform to market demand or future tax

To be eligible for an MCC, an applicant must (1) purchase a new or existing single-family home within the state; (2) acquire a new mortgage loan (refinancing of an existing mortgage or land contract is not permissible, except for certain construction loans); (3) continuously occupy the home as a primary residence within 60 days of its purchase; (4) purchase a home with a purchase price that does not exceed the applicable county limits; these limits range between \$253,809

and \$595,293; please refer to FHFC's website at www.floridahousing.org for the specific purchase price limits for the county you are purchasing in; (5) have a household income, including all household members age 18 and older, that does not exceed the limits for the applicable county; these limits will range between \$57,700 and \$122,220 depending upon household size and the county of purchase; (6) have not had an ownership interest in a principal residence within the preceding three years, except for qualified homebuyers purchasing homes in federally designated targeted areas or certain qualifying veterans; and (7) pay a nonrefundable \$500 program administration fee at the time of loan closing. The applicant must sign all documents and affidavits which are needed to demonstrate eligibility for an MCC, and the regulations, rulings and interpretations issued by the Internal Revenue Service shall control in the event of a conflict with other requirements. FHFC reserves the right to adjust and/or waive the application fee and adjust the purchase price and income limits for the Program to reflect housing costs and market conditions within federal guidelines.

Until the total credit authority is exhausted, a qualifying taxpayer may obtain an MCC in connection obtaining financing relating to the purchase of an eligible residence from any participating lender, including, but not limited to, banks, savings and loan associations, mortgage banking firms and credit unions. The applicant must meet the credit and underwriting criteria established by the participating lender which provides the mortgage loan. MCC applications will be accepted on a first-come, first-served basis. There is no allocation of MCCs by lender; however, for the first year of the Program, 20% will be targeted to persons purchasing single-family homes in Targeted Areas.

Banks, savings and loan associations, credit unions, mortgage companies and other financing institutions and individuals are invited to participate as lenders. Each participating lender will be required to sign a Participation Agreement, which outlines the lender's loan review and reporting responsibilities, and pay to FHFC a one-time fee of \$1000. FHFC will make a list of participating lenders available to the public upon request. An applicant may also obtain a loan from a lender not on such list if the lender agrees to participate in the Program.

MCCs cannot be used with FHFC-financed mortgage revenue bond loans or with any mortgage loans subsidized by other tax-exempt obligations. Current federal tax law may require a payment to the federal government of a "recapture" tax if the homeowner sells or otherwise transfers his or her home to someone else within nine years after the MCC is issued.
