If the project is subsequently approved, it would move into design for eventual construction. A later phase will provide a connection to I-4, either at State Road 429 or at CR 532.

The overall goals of the Poinciana Parkway Extension are to enhance mobility from CR 532 to Poinciana Parkway; reduce congestion and delays on local roads; expand regional connectivity; provide transportation infrastructure to support planned growth; provide consistency with local plans and policies; and enhance safety.

FIU's Police Department must be prepared to respond to

spontaneous critical incidents such as bomb threats and active shooters as well as drawn out critical incidents such as hurricanes and special events.
