(1) Prior to the expiration of each biennial licensure period, and as a condition for renewal of their cosmetology license or specialty registration, all licensed cosmetologists and registered specialists shall complete a minimum of ten (10) ~~sixteen (16)~~ hours of continuing education which shall include, at a minimum, all of the following subjects as they relate to the practice of cosmetology:

(a) A minimum of one (1) ~~two (2)~~ hours of instruction regarding HIV/AIDS and other communicable diseases which shall consist of:

1. through 2. No change.

(b) No change.

(c) A minimum of one-half (.5) ~~one (1)~~ hour of instruction regarding Occupational Safety and Health Administration regulations.

(d) A minimum of one-half (.5) ~~one (1)~~ hour of instruction regarding issues of workers' compensation as they pertain to Florida law.

(e) No change.

(f) A minimum of one (1) ~~two (2)~~ hours of instruction regarding chemical makeup as it pertains to hair, skin, and nails.

(g) No change.

(h) A minimum of one (1) ~~four (4)~~ hours of continuing education to be composed of additional instruction in any of the subjects set forth above or such other subject or subjects as the licensee may choose provided that the subject or subjects chosen relate to the practice of cosmetology and serve to ensure the protection of the public; and, provided that the course in which such subjects are taught has been approved by the Board prior to its being taught for continuing education purposes, and provided the licensee or registrant has not previously taken the course during the current licensure period.

NOTICE OF CHANGE

Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 45 No. 230, November 26, 2019 issue of the Florida Administrative Register.

1N-7.001 Remote Online Notarization Definitions

(1) Words and terms defined in section 117.201, F.S., shall have the same meaning in this chapter. For the purpose of this chapter the following words and terms shall have the following meanings, unless the context clearly indicates otherwise:

(a) Registrant Applicant” means any person registering applying as for an online public notary pursuant to 117.225, F.S.

(b) Attached to or logically associated with” means the notary’s electronic signature is securely bound to the electronic document in such a manner as to make it impracticable to falsify or alter, without detection, either the signature or the document.

(c) Department” means the Florida Department of State.

(d) Electronic document” means information that is created, generated, sent, communicated, received, or stored by electronic means.

(e) “Electronic notarization” and “electronic notarial act” means an official act authorized under section 117.021(1), F.S., using electronic documents and electronic signatures.

(f) “Electronic Notary System” means a set of applications, programs, hardware, software, or technology designed to enable a notary to perform electronic notarizations.

(g) “Electronic signature” means an electronic sound, symbol, or process attached to or logically associated with an electronic document and executed or adopted by a person with the intent to sign the electronic document or record.

(h) “Unique to the notary public” means the notary’s electronic signature is attributable solely to the notary public to the exclusion of all other persons.

(i) “Retained under the online notary public’s sole control” means accessible by and attributable solely to the notary to the exclusion of all other persons and entities, either through being in the direct physical custody of the notary or through being secured with one or more biometric, password, token, or other authentication technologies in an electronic notarization system that meets the performance requirements of sections 117.021(2) and (3), F.S.

(j) “Tamper-evident technology” means technology that allows a person inspecting a record to determine whether there has been any tampering with the integrity of a certificate of electronic notarial act logically associated with a record or with the attachment or association of the notarial act with that electronic document.

(2) A registrant shall submit form DOC 1N-7 (hyperlink), effective XXXX, herein incorporated by reference.

(3) The registrant shall:

(a) Submit a payment registration fee of \$10 by check payable to the Florida Department of State; and

(b) Submit the application by:

1. U.S. mail to PO Box 6327, Tallahassee, FL 32314;

2. In person delivery; or

3. Courier service.

4. In person delivery and courier service will go to 2415 North Monroe St., Suite 810, Tallahassee 32303.

(4) A registration is effective upon filing by the Florida Department State and expires on the date of expiration, termination, or resignation of the registrant’s:

(a) Notary Public commission issued under section 117.01, F.S.;

(b) Appointment as a civil-law Notary pursuant to section 118.10, F.S., and Ch. 1N-5, F.A.C.; or

(c) Appointment as a commissioner of deeds pursuant to section 721.97, F.S.

(5) All qualifications and registration requirements applicable for an applicant’s registration shall apply to a renewal registration.

(6) The online notary public’s electronic journal, electronic signature, and electronic seal shall be retained under the online notary public’s sole control. The online notary public may not allow another person to use the online notary public’s electronic journal, electronic signature, or electronic seal.

(7) An online notary public shall attach the online notary public’s electronic signature and seal to the electronic notarial certificate of an electronic document in a manner that is capable of independent verification and renders any subsequent change or modification to the electronic document evident.

(8) Online notaries public shall utilize remote online notary service providers to facilitate their performance of online notarization.

(9) The remote online service provider utilized by the online notaries public shall comply with the standards and requirements pursuant to section 117.295, F.S., and utilize tamper-evident technologies.

The first phase of the building is estimated to have a total construction cost of \$25,578,299 as described in the Program Budget Summary.

In 2015, FIU announced plans to build CasaCuba to leverage its significant academic and non-academic resources and expand FIU’s depth and breadth of teaching, scholarship, and cultural engagement on Cuba and the Cuban diaspora. Under the leadership of FIU President Mark B. Rosenberg and Agustín R. Arellano, Sr., a group of prominent community members came together to form a Board of Advisors. More recently, CasaCuba has received prestigious grants from the John S. and James L. Knight Foundation and the National Endowment for the Humanities (“NEH”), empowering the University to launch CasaCuba’s architectural design phase.

CasaCuba is envisioned as the most ambitious public building paying homage to the Cuban heritage. The venue will house the leading think tank dedicated to conducting and sharing research on a wide range of topics related to Cuba. At the same time, CasaCuba aspires to be a preeminent institution for the celebration of Cuban culture. Importantly as well, CasaCuba will be a community center – but one that is grounded in a leading university with high academic standards – that welcomes individuals, families, and social and professional groups that will find an inviting environment to learn about Cuban history and culture.

CasaCuba plans to include a state-of-the-art event venue; exhibition galleries; classrooms and seminar rooms; a flexible working area; vibrant gathering spaces such as a garden, courtyard, porch and gift shop; as well as administrative suites for the leadership of CasaCuba and the Cuban Research Institute. All areas should be focused on service to the FIU and local communities, as well as visitors from other parts of the

country and the world at large. The building should accommodate a variety of uses and people of all ages, abilities and backgrounds; nurture reflection, artistic expression, creative thinking, social interaction, experimentation, intellectual rigor and curiosity, scholarly research and multimodal learning; and showcase purpose-driven design, as well as the ability to adapt with changes in technology. It must represent the Cuban legacy, telling a compelling story about Cuba's past, present and future, and resonating emotionally with visitors and the surrounding community. Throughout its design, the building will articulate CasaCuba's vision and transmit hope and innovation, fueling the aspiration to make a positive difference. The building will serve as a gateway to other cultural and academic resources at FIU, and will create a new international destination that enables the exchange of ideas and collaboration among like-minded institutions around the world.

FIU is committed to producing buildings that comply with sustainable energy conservation strategies and standards (minimum LEED Silver Certification).

The project scope may be modified by the University, in its sole discretion, to reduce scope or to include additional spaces or square feet should a funding source for such scope increases be identified prior to project completion. For instance, the project may be split into two phases. The first phase would include the project described in the approved Program dated March 27, 2019 as Phase 1. The second phase would include additional gallery space, teaching laboratory space, food service facilities and support areas as generally contemplated in the description of Phase 2 in the approved Program. With proper approvals, components of Phase 1 and Phase 2 may be revised due to funding changes and/or changing program needs. The selected Architecture/Engineering firm may be instructed to proceed with the second phase of the project if funding becomes available prior to completion of the first phase.

Notwithstanding the foregoing, applicants are hereby notified that in the event the University is unable to secure full funding, the University intends to proceed only with design and construction of fully funded project components, if any.

For this project, initial funding is expected to allow completion of design services by the Architecture/Engineering firm. A/E services may be suspended or terminated before the Construction Documents Phase, or earlier, according to the terms of the standard contract. At the present time, no State funding will be used for design and construction of this project. The FIU Board of Trustees has approved "the design phase for CasaCuba using funding from donors, and the corresponding amendment of the University Campus Master Plan, and upon further review of the design, funding, and other data, the Board will consider approval for construction." Further note that the A/E will not be required to do any campus master plan work.

Commencement of any work involving construction, and release of the NEH grant funds, are contingent on completion by the NEH of the project reviews required pursuant to the National Environmental Policy Act (NEPA) and Section 106 of the National Historic Preservation Act (NHPA). These reviews will be conducted concurrently with this selection process.

NOTICE OF RIGHTS

As required by Sections 120.569, Fla. Stat., the following is notice of the opportunities which may be available for administrative hearing or judicial review when the substantial interests of a party are determined by an agency. Please note that this Notice of Rights is not intended to provide legal advice. Not all of the legal proceedings detailed below may be an applicable or appropriate remedy. You may wish to consult an attorney regarding your legal rights.

RIGHT TO REQUEST ADMINISTRATIVE HEARING

A person whose substantial interests are or may be affected by the South Florida Water Management District's (SFWMD or District) action has the right to request an administrative hearing on that action pursuant to Sections 120.569 and 120.57, Fla. Stat. Persons seeking a hearing on a SFWMD decision which affects or may affect their substantial interests shall file a petition for hearing with the Office of the District Clerk of the SFWMD, in accordance with the filing instructions set forth herein, within 21 days of receipt of written notice of the decision, unless one of the following shorter time periods apply: (1) within 14 days of the notice of consolidated intent to grant or deny concurrently reviewed applications for environmental resource permits and use of sovereign submerged lands pursuant to Section 373.427, Fla. Stat.; or (2) within 14 days of service of an Administrative Order pursuant to subsection 373.119(1), Fla. Stat. "Receipt of written notice of agency decision" means receipt of written notice through mail, electronic mail, or posting that the SFWMD has or intends to take final agency action, or publication of notice that the SFWMD has or intends to take final agency action. Any person who receives written notice of a SFWMD decision and fails to file a written request for hearing within the timeframe described above waives the right to request a hearing on that decision.

If the District takes final agency action which materially differs from the noticed intended agency decision, persons who may

be substantially affected shall, unless otherwise provided by law, have an additional Rule 28-106.111, Fla. Admin. Code, point of entry.

Any person to whom an emergency order is directed pursuant to subsection 373.119(2), Fla. Stat., shall comply therewith immediately, but on petition to the board shall be afforded a hearing as soon as possible.

A person may file a request for an extension of time for filing a petition. The SFWMD may, for good cause, grant the request. Requests for extension of time must be filed with the SFWMD prior to the deadline for filing a petition for hearing. Such requests for extension shall contain a certificate that the moving party has consulted with all other parties concerning the extension and that the SFWMD and any other parties agree to or oppose the extension. A timely request for an extension of time shall toll the running of the time period for filing a petition until the request is acted upon.

FILING INSTRUCTIONS

A petition for administrative hearing must be filed with the Office of the District Clerk of the SFWMD. Filings with the Office of the District Clerk may be made by mail, hand-delivery, or e-mail. Filings by facsimile will not be accepted. A petition for administrative hearing or other document is deemed filed upon receipt during normal business hours by the Office of the District Clerk at SFWMD headquarters in West Palm Beach, Florida. The District's normal business hours are 8:00 a.m. – 5:00 p.m., excluding weekends and District holidays. Any document received by the Office of the District Clerk after 5:00 p.m. shall be deemed filed as of 8:00 a.m. on the next regular business day. Additional filing instructions are as follows:

Filings by mail must be addressed to the Office of the District Clerk, 3301 Gun Club Road, West Palm Beach, Florida 33406. Filings by hand-delivery must be delivered to the Office of the District Clerk. Delivery of a petition to the SFWMD's security desk does not constitute filing. It will be necessary to request that the SFWMD's security officer contact the Office of the District Clerk. An employee of the SFWMD's Clerk's office will receive and file the petition.

Filings by e-mail must be transmitted to the Office of the District Clerk at clerk@sfwmd.gov. The filing date for a document transmitted by electronic mail shall be the date the Office of the District Clerk receives the complete document. A party who files a document by e-mail shall (1) represent that the original physically signed document will be retained by that party for the duration of the proceeding and of any subsequent appeal or subsequent proceeding in that cause and that the party shall produce it upon the request of other parties; and (2) be responsible for any delay, disruption, or interruption of the electronic signals and accepts the full risk that the document may not be properly filed.

INITIATION OF AN ADMINISTRATIVE HEARING

Pursuant to Sections 120.54(5)(b)4. and 120.569(2)(c), Fla. Stat., and Rules 28-106.201 and 28-106.301, Fla. Admin. Code, initiation of an administrative hearing shall be made by written petition to the SFWMD in legible form and on 8 1/2 by 11 inch white paper. All petitions shall contain:

Identification of the action being contested, including the permit number, application number, SFWMD file number or any other SFWMD identification number, if known.

The name, address, any email address, any facsimile number, and telephone number of the petitioner and petitioner's representative, if any.

An explanation of how the petitioner's substantial interests will be affected by the agency determination.

A statement of when and how the petitioner received notice of the SFWMD's decision.

A statement of all disputed issues of material fact. If there are none, the petition must so indicate.

A concise statement of the ultimate facts alleged, including the specific facts the petitioner contends warrant reversal or modification of the SFWMD's proposed action.

A statement of the specific rules or statutes the petitioner contends require reversal or modification of the SFWMD's proposed action.

If disputed issues of material fact exist, the statement must also include an explanation of how the alleged facts relate to the specific rules or statutes.

A statement of the relief sought by the petitioner, stating precisely the action the petitioner wishes the SFWMD to take with respect to the SFWMD's proposed action.

MEDIATION

The procedures for pursuing mediation are set forth in Section 120.573, Fla. Stat., and Rules 28-106.111 and 28-106.401-.405, Fla. Admin. Code. The SFWMD is not proposing mediation for this agency action under Section 120.573, Fla. Stat., at this time.

RIGHT TO SEEK JUDICIAL REVIEW

Pursuant to Section 120.68, Fla. Stat., and in accordance with Florida Rule of Appellate Procedure 9.110, a party who is adversely affected by final SFWMD action may seek judicial review of the SFWMD's final decision by filing a notice of appeal with the Office of the District Clerk of the SFWMD in accordance with the filing instructions set forth herein within 30 days of rendition of the order to be reviewed, and by filing a copy of the notice with the clerk of the appropriate district court of appeal.
