(1) Scope. This rule governs the written examinations for teacher certification. Additional requirements for certification are specified in Chapter 6A-4, F.A.C.

(2) Description of the examinations and competencies to be demonstrated.

(a) The Florida Teacher Certification Examinations shall be developed by the Commissioner of Education.

(b) The written examinations shall include subtests of English language skills, reading, writing, mathematics, professional skills, and subject area specialty. These examinations may contain multiple-choice questions and questions requiring the examinee to write an answer or demonstrate a proficiency.

The Florida Department of Business and Professional Regulation, Division of Hotels and Restaurants hereby gives notice:

On February 1, 2019 the Division of Hotels and Restaurants received a Petition for an Emergency Variance for paragraph 61C-1.004(1)(a), Florida Administrative Code and Paragraph 5-202.11(A), 2009 FDA Food Code from Mystical Treats LLC located in Tampa. The above referenced F.A.C. addresses the requirement that each establishment have an approved plumbing system installed to transport potable water and wastewater. They are requesting to utilize holding tanks to provide potable water and to collect wastewater at the handwash sink and the three compartment sink.

The Petition for this variance was published in Vol. 45/23 on February 4, 2019. The Order for this Petition was signed and approved on February 11, 2019. After a complete review of the

This second phase has been listed as “Future

Project” on FIU Facilities Planning’s “Construction Projects Master List” since August 2011, soon after Phase I was occupied, and it was clear that additional space was needed to house the School of International and Public Affairs.
