6A-1.001       District Financial Records

**PURPOSE AND EFFECT:** To incorporate by reference an updated version (2020) of the “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book) publication. Changes in law, accounting principles and district practices require periodic revision of this publication, which includes a chart of accounts. The effect is that districts will have an updated chart of accounts to use.

**SUMMARY:** The superintendent of each school district is responsible for keeping adequate records and accounts of all financial transactions in the manner prescribed by the commissioner in “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book), which is incorporated by reference in rule 6A-1.001, F.A.C. The Office of Funding and Financial Reporting is responsible for updating the publication. The amendment allows for the 2020 version of the “Financial and Program Cost Accounting and Reporting for Florida Schools” (Red Book) to replace the 2019 version, currently incorporated by reference in rule 6A-1.001, F.A.C.

#### SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

SUMMARY: Revise forms for the school district summary budget, incorporated by reference, to add two funds and three revenue accounts as a result of the Coronavirus Aid, Relief, and Economic Security (CARES) Act. In addition, two new expenditure codes are added for reporting.

**SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:**

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The adverse impact or regulatory cost, if any, does not exceed, nor would it be expected to exceed, any one of the economic analysis criteria set forth in section 120.541(2)(a), Florida Statutes and is not expected to require legislative ratification. Revisions include account additions to reflect updated governmental accounting standards reporting requirements.

PURPOSE AND EFFECT: To revise submission procedures for school districts to plan and document delivery of required instruction related to s. 1003.42(2), F.S., for grades K-12 students. An online portal used by 69 districts in 2020 (when it was optional) will now be required for annual plans and the annual report. The following three rules: 6A-1.094121, 6A-

1.094122 and 6A-1.094123 will be consolidated into Rule 6A-1.094124. These three rules will then be repealed.

SUMMARY: School districts must annually submit a report documenting instruction for students in grades K-12 related to their implementation of the required instruction in s. 1003.42(2), F.S., by July 1. For Mental and Emotional Health Education, Substance Use and Abuse Health Education and Child Trafficking Prevention Education, school districts must also annually submit a plan by December 1 for how instruction will be delivered. These requirements, all relating to the same statute, are spread across four rules and there is not a standardized method for submitting plans and reports to the Department. This action will consolidate four rules into one and standardize the submission process. Additionally, the Department must provide school districts at least 45 days to submit revisions needed to comply with the requirements of the rule or the required instruction statute (s. 1003.42, F.S.).

**SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:**

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: Development and optional use of the portal for the July 2020 reporting did not exceed \$200,000. Furthermore, it is expected that the required use of the online portal by school districts will result in standardization and cost savings for districts and the Department. (1) In order to provide information about the manner in which the prescribed courses of study set forth in Section 1003.42(2), F.S., are provided by school districts, by July 1 of each year, each school district must submit a report to the Commissioner of Education that describes how instruction was provided for topics in Sections 1003.42(2)(a)-(n) and (p)-(t), F.S., during the previous school year. This report shall be submitted through the Required Instruction Reporting Portal located at [www.flrequiredinstruction.org](http://www.flrequiredinstruction.org). The department may provide technical assistance on required instruction specific to each topic.

(2) This report shall contain:

(a) The specific courses in which instruction has been ~~will~~ be delivered for each grade level; ~~and~~

(b) A description of the materials and resources utilized to deliver instruction; ~~and~~

(c) For subsections (3)-(5) of this rule, the professional qualifications of the person delivering instruction.

(3) Mental and Emotional Health Education. ~~Failure to comply with the requirements of this rule may result in the imposition of sanctions described in Section 1008.32, F.S.~~

(a) School districts must annually provide a minimum of five (5) hours of instruction to students in grades 6-12 related to youth mental health awareness and assistance, including suicide prevention and the impacts of substance abuse.

(b) Using the health education standards adopted in Rule 6A-1.09401, F.A.C., Student Performance Standards, the instruction for youth mental and emotional health will advance each year through developmentally appropriate instruction and skill building and must address, at a minimum, the following topics:

1. Recognition of signs and symptoms of mental health disorders;

2. Prevention of mental health disorders;
3. Mental health awareness and assistance;
4. How to reduce the stigma around mental health disorders;
5. Awareness of resources, including local school and community resources;
6. The process for accessing treatment;
7. Strategies to develop healthy coping techniques;
8. Strategies to support a peer, friend, or family member with a mental health disorder;
9. Prevention of suicide; and
10. Prevention of the abuse of and addiction to alcohol, nicotine, and drugs.
- (4) Substance Use and Abuse Health Education.
- (a) School districts must annually provide instruction to students in grades K-12 related to youth substance use and abuse health education.
- (b) Using the health education standards adopted in Rule 6A-1.09401, F.A.C., Student Performance Standards, the instruction for substance use and abuse education will advance each year through developmentally appropriate instruction and skill building.
- (5) Child Trafficking Prevention Education.
- (a) It is the intent of the State Board of Education that every school in Florida be a "Child Trafficking Free Zone."
- (b) School districts must annually provide instruction to students in grades K-12 related to child trafficking prevention and awareness.
- (c) Using the health education standards adopted in Rule 6A-1.09401, F.A.C., Student Performance Standards, the instruction for child trafficking prevention will advance each year through developmentally appropriate instruction and skill building.
- (d) Age-appropriate elements of effective and evidence-based programs and instruction to students in grades K-12 related to child trafficking prevention and awareness and must address, at a minimum, the following topics:
1. Recognition of signs of human trafficking;
2. Awareness of resources, including national, state and local resources;
3. Prevention of the abuse of and addiction to alcohol, nicotine, and drugs;
4. Information on the prevalence, nature, and strategies to reduce the risk of human trafficking, techniques to set healthy boundaries, and how to safely seek assistance; and
5. Information on how social media and mobile device applications are used for human trafficking.
- (e) In order to assist with instruction, the department will maintain a human trafficking webpage, located at <http://www.fldoe.org/schools/healthy-schools/human-trafficking.shtml>, with information about the education

described in this rule; resources on abuse, including sexual abuse, and human trafficking prevention for professional learning purposes; and materials for parents, guardians, and other caretakers of students.

(6) By December 1 of each year, each school district must submit an implementation plan to the commissioner through the Required Instruction Reporting Portal for sections (3)-(5) of this rule, and post the plan on the school district website. The implementation plan must include:

(a) The methods in which instruction will be delivered for each grade level;

(b) The professional qualifications of the person delivering instruction; and

(c) A description of the materials and resources utilized to deliver instruction.

(7) When a school district's plan for instruction as set forth in subsection (6), or a school district's reported instruction as set forth in subsections (1) and (2) of this rule, do not meet the requirements of this rule or Section 1003.42, F.S., school districts must be provided no less than 45 days in order to submit revisions to the department.

Forms are currently available on the Department’s website and may also be obtained by calling or writing the Department.

RULE TITLE: Use of Live Streaming Technology for Delivery of Approved In-Person Education Courses

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: The Florida Real Estate Commission ("FREC") is statutorily mandated to require specified Prelicensure, Post-Licensure, School Instructor and Continuing Education ("CE") courses as prerequisites to initial licensure, licensure renewal, and licensure reactivation of Real Estate Sales Agents, Real Estate Brokers, and Real Estate School Instructors. Pursuant to this authority, the FREC has promulgated rules setting forth the requirements for approval of Prelicensure, Post-Licensure,

Reactivation, and CE courses. The rules establish different minimum criteria for in-person vs. online or distance learning courses; and courses are submitted by providers and approved/authorized by the FREC as either in-person or online/distance. If a course is approved as in-person, it cannot be offered via online or distance learning methods, unless it is also approved as an online/distance learning course.

Due to the Novel Coronavirus Disease 2019 (COVID-19) public health emergency, the State of Florida has been under continuing public health emergency orders, issued by, among others, the Governor, the State Health Officer, the secretaries of various state agencies, and local governments. While the public health emergency appears to be abating, there is a continued significant, present, real danger to the public health and welfare from the COVID-19 disease.

In order to help accomplish the public policy goal of preventing the spread of the COVID-19 disease, the FREC has promulgated two (2) prior Emergency Orders, allowing delivery of FREC approved in-person educational courses to be offered through synchronous live video streaming/videoconferencing technologies, such as Zoom®, GoToMeeting®, Microsoft Teams®, or WebEx®, among others. This has allowed the state's real estate professionals, as well as applicants for licensure, to avail themselves of all FREC approved courses, whether "live" or "online," while reducing the requirement for an in-person gathering of people. As part of the second Emergency Order issued by the FREC, which expires October 8, 2020, the FREC simultaneously initiated rulemaking pursuant to section 120.54, F.S., to amend the existing rules in Chapter 61J2-3, F.A.C., to make the synchronous live-streaming option available through the end of the calendar year. However, due to the minimum timeframes and statutorily requirements for adoptions of amendments to existing rules, it appears the rule amendments will not be completed prior to the expiration of the emergency rule.

The FREC has been informed that the "gap" created by expiration of the second Emergency Rule and the adoption of the proposed rule amendments will result in more than 100 educational courses currently scheduled being either cancelled or a requirement that registrants travel and physically gather in order to avail themselves of the course content. Given the continued public health emergency, the FREC finds this presents an unnecessary and imminent risk to the public health, safety, and welfare, which risk the FREC has been attempting to eliminate since publication of the first Emergency Order in June. Accordingly, the FREC, by a third emergency rule, will continue to waive the requirement that those educational courses previously approved by the FREC as live or in-person must in fact be presented "in-person," and authorizes any such course previously approved as live to continue to be delivered by synchronous live-streaming technologies, that allow the

instructor or monitor to observe each student. The Board finds that this action is a measured regulatory approach that helps to mitigate the threat of exposure to COVID-19 disease to Floridians, including Real Estate professionals and those that come in contact with them, while still satisfying the purpose and intent of the waived requirements.

**REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES:** Given the fact that many providers of educational courses, as well as licensees and applicants for licensure, have relied on the FRECs clearly enunciated policy to allow synchronous live streaming of educational courses, and have planned, developed, scheduled, registered, and paid for these courses; that the FREC diligently followed the rulemaking provisions of section 120.54, F.S. in an attempt to promulgate amendments to existing rules to accomplish this goal through the end of 2020; and that a large number of courses will either be cancelled or persons will be forced to gather in-person to receive statutorily required education; the FREC finds that the continued immediate danger to the public health, safety, or welfare due to COVID-19 disease necessitates immediate action to eliminate the gap of time between the expiration of the currently effective second Emergency Rule and the effective adoption of rule amendments. In addition, at the same meeting where this Emergency Rule was proposed, the Commission determined to withdraw the rulemaking initiated to amend the existing rules, since this third Emergency Rule will extend the effective period of allowable synchronous live streaming through the end of 2020, which was and continues to be the intent of the FREC. Notice of this meeting was published in the Florida Administrative Register in Volume 46, No. 191 on September 30, 2020. In addition, notice of the FREC's meeting was posted on the FREC's official website and was emailed to interested persons and entities.

**SUMMARY:** The proposed emergency rule authorizes the continued delivery of Prelicensure, Post-Licensure, Reactivation, Continuing Education, and School Instructor education courses previously approved by the FREC to be delivered live and in-person to be delivered via synchronous live streaming / videoconferencing technologies until December 31, 2020. After January 1, 2021, a provider wishing to continue offering courses through synchronous live streaming that technology must apply for approval following existing procedures.

1. The Florida Keys Area is designated by Section 380.0552, Florida Statutes, as an area of critical state concern. Monroe county is a local government within the Florida Keys Area.
2. The Ordinance was adopted by Monroe County on July 15, 2020 and rendered to the Department on August 17, 2020.
3. The Ordinance amends Chapter 142 of Monroe County’s Land Development Code to modify regulations for signs that are erected within the county, to delineate procedures for obtaining permits for signs within the county, and to provide for penalties regarding violations of sign usage.

**CONCLUSIONS OF LAW**

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. *See* §§ 380.05(6) and 380.0552(9), Fla Stat.
5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. § 380.031(8), Fla. Stat. The regulations adopted by the Ordinance are land development regulations.
6. The Ordinance is consistent with the Monroe County Comprehensive Plan generally, as required by subsection 163.3177(1), Florida Statutes, and specifically, with Objective 101.15 and Policy 101.15.1.
7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the Principles for Guiding Development for that area. § 380.05(6) and 380.0552(9), Fla Stat. The Principles for Guiding Development for the Florida Keys Area of Critical State Concern are set forth in subsection 380.0552(7), Florida Statutes.
8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and specifically complies with the following:

- (a) Strengthening local government capabilities for managing land use and development so that local government is able to achieve these objectives without continuing the area of critical state concern designation.
- (m) Providing adequate alternatives for the protection of public safety and welfare in the event of a natural or manmade disaster and for a post disaster reconstruction plan.

WHEREFORE, IT IS ORDERED that the Department finds that Monroe county Ordinance No. 018-2020 is consistent with the Monroe County Comprehensive Plan and Principles for Guiding Development for the Florida Keys Area of Critical State Concern and is hereby **APPROVED**.

The Ordinance also amends Section 130-100 to add detached dwellings to the list of permitted uses in the Urban Residential Mobile Home Limited District.
