The Commission has approved the following regulations and bag limits for taking ducks, geese, and coots:

- (1) Duck, light goose, and coot season:
- (a) Open season:
- 1. through 2. No change.
- 3. Youth Waterfowl Hunt The Saturday prior to the opening of the first phase as specified in subparagraph (1)(a)1. and the second Saturday following the close of the second phase as specified in subparagraph (1)(a)2. Hunters must be under 16

- years of age and must be accompanied by a non-hunting adult at least 18 years of age. Daily bag limits and species restrictions for ducks, geese, and coots will be as described in paragraphs (1)(e) and (4)(c). Common gallinules may also be taken and bag and possession limits for this species will be as specified in rule 68A-13.008, F.A.C.
- 4. Veterans and Active Military Hunt The first Saturday and Sunday following the close of the second phase as specified in subparagraph (1)(a)2. Hunters must be veterans or members of the Armed Forces on active duty, including members of the National Guard and Reserves on active duty. Daily bag limits and species restrictions for ducks, geese, and coots will be as described in paragraphs (1)(e) and (4)(c). Common gallinules may also be taken and bag and possession limits for this species will be as specified in rule 68A-13.008, F.A.C.
- (b) In Leon County (except below or within the ordinary high water line for Lake Talquin and the Ochlockonee River) and below the ordinary high water line for Lake Miccosukee in Jefferson County, waterfowl hunting is permitted only on Wednesdays, Saturdays and Sundays during the open season. In addition to Wednesdays, Saturdays and Sundays, waterfowl hunting is permitted on Thanksgiving and the day after; December 24, 25, 26 and 31; January 1 and 2; Martin Luther King, Jr. Day (if occurring during the open season described in paragraph (1)(a), above); and the first, last, and next-to-the-last days of the open season in paragraph (1)(a)1. and 2., above.
  - (c) No change.
- (d) In addition to the open season specified in paragraph (1)(a), above, a "Youth Waterfowl Hunt" will be held the Saturday prior to the opening of the first phase as specified in subparagraph (1)(a)1. above, and the second Saturday following the close of the second phase as specified in subparagraph (1)(a)2. above. Youth hunters must be under 16 years of age and must be accompanied by a non-hunting adult at least 18 years of age. Daily bag limits and species restrictions for ducks, geese, and coots will be as described in paragraphs (1)(f) and (4)(c). Common moorhens may also be taken on the "Youth Waterfowl Hunt;" bag and possession limits for this species will be as specified in rule 68A-13.008, F.A.C.
- (d)(e) Shooting hours: One-half hour before sunrise until sunset.
- (e)(f) Limits: The possession limit for ducks and coots shall be three days' bag limit. There shall be no possession limit for light geese. Light geese include only snow (including blue) and Ross' geese.
- 1. Ducks: The daily bag limit for ducks is six, including no more than: two mallards, of which only one can be female; one scaup during the open season specified in subparagraph (1)(a)1. and the first 31 days of the open season specified in subparagraph (1)(a)2.; two scaup during the last 20 days of the open season specified in subparagraph (1)(a)2. and the open

seasons specified in subparagraphs 1(a)3. and 1(a)4.; four scoters; four eiders; four long-tailed ducks; three wood ducks; two redheads; one pintail; two canvasbacks; two black ducks; one Florida duck (mottled duck); and one fulvous whistling-duck. In addition to the daily bag limit for ducks, the daily bag limit for mergansers is five, only two of which may be hooded mergansers.

68D-24.018 St. Johns River Boating Restricted Areas PURPOSE AND EFFECT: In order to protect the public, this rule amendment would establish an idle speed no wake boating-restricted area from shoreline to shoreline in the St. Johns River extending approximately 1.25 miles north of the I-4 bridge in Sanford, Florida. This boating-restricted area would become effective only when the river is at flood stage. The proposed boating restricted area would have a flood stage restriction height of 5.5 feet as reported by the National Weather Service gauge at Lake Monroe. A slow speed minimum wake zone already exists on the St. Johns River that extends to this portion of the river; however, Seminole County and local Fish and Wildlife Conservation Commission law enforcement have additional concerns for public safety during flooding in this area.

SUMMARY: This rule amendment will establish an idle speed no wake boating-restricted area from shoreline to shoreline in the St. Johns River extending approximately 1.25 miles north of the I-4 bridge in Sanford, Florida. This boating-restricted area would become effective only when the river is at flood stage. The proposed boating restricted area would have a flood stage restriction height of 5.5 feet as reported by the National Weather Service gauge at Lake Monroe.



- (1) For the purpose of regulating the speed and operation of vessel traffic on the St. Johns River in Lake, Seminole and Volusia Counties, Florida the following boating restricted areas are established. Coordinates used in the description of zone boundaries are referenced to the North American Datum of 1983 (NAD83). The boating restricted areas exclude all associated tributaries, creeks, canals, backwaters, channels, boat basins and other waterways unless otherwise designated or specifically described for inclusion:
  - (a) No change.
  - (b) Flood Zones.
  - 1. through 4. No change.
- 5. Lake Monroe: During flooding, an Idle Speed No Wake zone from shoreline to shoreline in the St. Johns River, bounded on the southeast by the northwesterly side of the I-4 bridge in Sanford, Florida, and bounded on the northwest by a line drawn perpendicular to the centerline of the St. Johns River at approximate latitude 28° 50.61660' North, and approximate longitude 81° 20.23200' West, including all canals associated with St. Johns River Estates, Boat Tree Marina, the intake and discharge canals at the Sanford Power Plant, and the water basin on the north side of the River between US Highway 17/92 and I-4, as depicted in Drawing N, when the St. Johns River water

level is 5.5 feet or higher as indicated by the National Weather Service gauge at the Lake Monroe Station.

RULE NO.: RULE TITLE:

53ER20-34 Game Number 1455, DOUBLE PAYDAY SUMMARY: This emergency rule describes Game Number 1455, "DOUBLE PAYDAY," for which the Department of the Lottery will start selling tickets on a date to be determined by the Secretary of the Department. The rule sets forth the specifics of the game; determination of prizewinners; estimated odds of winning, value and number of prizes in the game.

#### THE FULL TEXT OF THE EMERGENCY RULE IS:

53ER20-34 Game Number 1455, DOUBLE PAYDAY.

(1) Name of Game. Game Number 1455, DOUBLE PAYDAY.

(2) Game Number 1455, DOUBLE PAYDAY is a Scratch-Off lottery game (also known as an instant lottery game).

(3) Price. DOUBLE PAYDAY lottery tickets sell for \$1.00 per ticket.

- (4) DOUBLE PAYDAY lottery tickets shall have a series of numbers in machine readable code (or bar code) on the back of the ticket, along with a validation number under the latex area on the ticket. To be a valid winning DOUBLE PAYDAY lottery ticket, the ticket must meet the applicable requirements of Rule 53ER17-54, Payment of Prizes, Florida Administrative Code.
- (5) The play symbols and play symbol captions that may appear in the YOUR NUMBERS play area are as follows:

(9) Determination of Prizewinners.

(a) A ticket having a play symbol and corresponding play symbol caption in the YOUR NUMBERS play area that matches the play symbol and corresponding play symbol caption in the WINNING NUMBER play area shall entitle the prizewinner to the corresponding prize shown for that symbol.

#### PAYDAY

A ticket having a DOUBLE symbol in the YOUR NUMBERS play area shall entitle the prizewinner to double the corresponding prize shown for that symbol. A ticket having a

WINALL symbol in the YOUR NUMBERS play area shall entitle the prizewinner to all five prizes shown in the play area.

(b) A player may win up to five times on a ticket.

On April 29, 2020, Governor DeSantis issued Executive Order 20-112, Phase 1 of the Safe, Smart, Step-by-Step Plan for Florida's Recovery, which directs all persons in Florida to continue to limit their personal interactions outside the home as specified in Executive Order 20-91, including to avoid congregating in large groups, avoid nonessential travel, and adherence to the CDC guidelines for isolation following travel on a cruise or from any international destination or any area with a significant presence of COVID-19.

As of Thursday, May 14, 2020, there are more than 41,000 positive cases of COVID-19 in Florida and there have been more than 1,800 deaths attributed to the virus. Additionally, as of March 15, 2020, there have been 1,405,356 confirmed unique reemployment assistance claims submitted by Florida residents. While 78.3 percent (1,100,282) of those claims have been processed, to-date, only 49.4 percent (693,950) of those claims have been paid as of May 12, 2020. Challenges related to COVID-19 conditions, such as this, persist for many Florida families.

School Districts and SFSP sponsors were surveyed regarding meal service during COVID-19 conditions in April 2020. When asked to rank 12 issues on a 1-5 scale, with 1 being of lowest concern and 5 being of highest concern, the survey results showed that expiration of the waiver for non-congregate feeding ranked as the highest concern, at 4.37 out of 5 among School Districts and SFSP sponsors. The primary concerns voice by School Districts and SFSP sponsors in response to the survey related to the expiration of the non-congregate feeding waiver included (1) communicating the change effectively to parents/guardians, (2) losing program consistency and (3) reduction in program participation. Additionally, many School Districts are concerned about continued staffing capacity – particularly without hazard pay and with many staff contracts ending as of May 31, 2020.

In addition, school nutrition industry members have expressed challenges associated with the School Districts and SFSP sponsors not knowing what their program operations will look like throughout the remainder of the program period. Because most manufacturers and distributors now need approximately 4-6 weeks of lead time to ensure product availability instead of the typical 2-week lead time, firm order commitments are needed from School Districts and SFSP sponsors to identify if more of the convenience type food items currently being offered will be needed going forward, or if traditional SFSP

food items will be needed to prevent further financial losses to manufacturers and distributors from anticipated, but unutilized food items. School Districts and SFSP sponsors also need to be able to provide manufacturers and distributors with accurate volume forecasting, which is complicated by not knowing if the program will operate in the traditional congregate setting or in the current non-congregate setting.

To address these important issues, FDACS is requesting an extension of the waiver enabling sponsors to serve meals in a non-congregate setting in communities and at school sites during school closures related to COVID-19.
