PURPOSE AND EFFECT: The purpose of this Notice of Rule Development (NORD) is to amend Chapter 62-210, F.A.C., to update and expand the current categorical permit exemption for burning of drugs in boilers with a heat input of 250 million Btu per hour or more, to instead allow for law enforcement and other government agencies to incinerate contraband, prohibited goods, and animal carcasses in incinerators consistent with the state’s incinerator rule, Rule 62-296.401, F.A.C., and federal incinerator regulations, 40 CFR Part 60, Subparts Eb, Cb, AAAA, BBBB, CCCC, DDDD, EEEE, adopted and incorporated by reference in Rule 62-204.800, F.A.C. The proposed revisions also include correcting a cross-reference in the permit exemption for brownfield remediation sites.

33-401.401      Use of Tobacco Products

PURPOSE AND EFFECT: The proposed rule is intended to clarify protocols relating to the use of tobacco products at institutions, including the prohibition of vapor products

SUMMARY: Rulemaking is necessary to amend an existing rule to change its name and to establish protocols for the use and possession of vapor products and vapor-generating electronic devices in or on Department property in accordance with the Florida Clean Indoor Air Act as amended by the Florida Legislature in 2019 and § 944.47, F.S., as amended by the Florida Legislature in 2020.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The Department used an itemized checklist to conduct an economic analysis and determine if there is an adverse impact or regulatory cost associated with this rule that exceeds the criteria. 33-401.401 Use of Tobacco and Vapor Products.

(1) This rule establishes the tobacco and vapor products use policy for the Department of Corrections. For the purposes of this rule, "tobacco products" means items such as cigars, cigarettes, snuff, loose tobacco, or similar goods made with any part of the tobacco plant, which are prepared or used for smoking, chewing, dipping, sniffing, or other personal use. "Vapor products" means aerosolized or vaporized nicotine or other aerosolized or vaporized substance produced by a vapor-generating electronic device or exhaled by the person using such a device, or the vapor-generating electronic device itself.

(2)(a) Pursuant to Section 944.115, F.S., use of any tobacco products shall be prohibited in all indoor areas of any building

or office within a state correctional facility except for employee housing on department grounds and inmate maximum security (death row) housing areas. Only unlighted tobacco product use shall be permitted in death row housing.

(b) Pursuant to Section 386.204, F.S., smoking and vaping are is prohibited in all enclosed indoor workplaces as defined in Section 386.203, F.S.

(c) Pursuant to Section 947.47, F.S., a vapor-generating electronic device as defined in s. 386.203, F.S. shall not be intentionally and unlawfully introduced inside the secure perimeter of any state correctional institution.

(3) Should Department of Corrections' offices be located in buildings not totally in the control of the department, smoking and vaping shall be prohibited in all enclosed indoor workplaces occupied or controlled by the department. Employees may not smoke or vape in areas which do not fully meet the requirements of the Florida Indoor Clean Air Act, Sections 386.201-.209, F.S.

(4) Outdoor areas owned or leased by the Department of Corrections may be designated by the secretary or the secretary's designee as areas where tobacco and/or vapor products may be used by inmates, staff, or visitors. Tobacco waste receptacles shall be provided in all areas where tobacco products use is permitted.

(5) Use of tobacco and vapor products shall be prohibited in all vehicles owned or leased by the department.

(6) All inmates at all state correctional facilities, with the exception of those participating in a community release program under Rule 33-601.602, F.A.C., or as otherwise provided in subsection (8)(7) of this rule shall not be allowed to possess any tobacco products or lighters.

(7) All inmates at all state correctional facilities shall not be allowed to possess any vapor products or vapor-generating electronic device.

(8)(7) Inmates on death row shall not purchase more than two (2) packages of smokeless tobacco products per week and shall not exceed the possession limit of two (2) packages. Inmates assigned to a Community Release Program in accordance with "Community Release Programs," Rule 33-601.602, F.A.C., shall not possess more than ten (10) packs of cigarettes, or ten (10) packages of smokeless tobacco products, or twenty (20) individual cigars, and one (1) non Bic-style disposable lighter at any time while on the property of a state correctional facility.

(9)(8) Tobacco cessation assistance shall be available to inmates to assist them in making a successful tobacco-free transition.

(10)(9) Violation of this rule shall be grounds for disciplinary action against employees and inmates. Visitors found in violation of this rule shall be subject to having their approval for access to the department facility withdrawn.

5JER21-2 Volatility Standards for Gasoline

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Due to the extreme winter weather event that occurred in Texas during the month of February, eleven fuel refineries, representing twenty percent of the nation’s petroleum production, were shut down for an extended period of time. Pursuant to adopted national fuel standards, fuel volatility requirements will soon shift to accommodate the changing seasons. Typically, this shift happens seamlessly; however, due to the unprecedented events in Texas, distributors have been unable to shift their supplies to season-appropriate fuel. As a result, only winter fuel remains available in a quantity sufficient to meet demand in Florida. If volatility standards are not adjusted to account for this extraordinary situation, there will be a shortage of lawful fuel available for sale, even as storage tanks sit full of useable fuel.

Since Florida’s average temperatures are higher than those across much of the nation, though, there is a greater concern that vehicle operability, drivability, and portable power supply generator reliability could be impacted if high volatility fuel is used into the late spring and early summer months. Therefore, this waiver is limited in time and geographical scope; it

balances the public need for a reliable fuel supply with the industry’s need to help stabilize the fuel market, all while protecting the public welfare.

**REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES:** This emergency rule was initiated at the request of fuel suppliers to ensure a consistent supply of fuel in Florida while avoiding the unnecessary creation of a fuel shortage. As the post-crisis recovery in Texas is an unprecedented and rapidly-evolving situation, prompt action based on information regarding recent developments in the fuel industry is both necessary and fair.

**SUMMARY:** This emergency rule allows fuels of different volatility classes than those set forth in ASTM International designation D4814-20a, as adopted in rule 5J-21.001, F.A.C., for the periods indicated. The specific standards affected are included below.

**SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE:** Novel Coronavirus Disease 2019 (COVID-19) is a severe acute respiratory illness that can spread among humans through respiratory transmission and presents with symptoms similar to those of influenza. COVID-19 is a communicable disease with significant morbidity and mortality. As a result, it presents a severe danger to public health. Access to immunization and vaccine administration data is critical to the government response to the COVID-19 public health emergency. In furtherance of state and federal government response efforts, the Florida Department of Health, the U.S. Department of Health and Human Services (HHS), and the Centers for Disease Control and Prevention (CDC) seek to obtain and utilize data from COVID-19 vaccine data sources, including the Florida Department of Health’s immunization information system (IIS), in order to rapidly assess patterns of vaccination among the population; identify pockets of undervaccination; assist in determining vaccine resource allocation; monitor vaccine effectiveness and safety; assess spectrum of illness, disease burden, and risk factors for severe disease and outcomes; and help to understand the impact of COVID-19 on the healthcare system and communities. Reporting the administration of COVID-19 vaccines to individuals in Florida is paramount to controlling this communicable disease and for reporting to the Centers for Disease Control and Prevention. Therefore, there is an immediate need to adopt rules setting forth the procedures for continued reporting of vaccine administration in order to control the spread of COVID-19 to protect the health, safety, and welfare of Florida’s citizens.

**REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES:** COVID-19 presents a public health threat to the state of Florida. The Surgeon General has declared a statewide Public Health Emergency due to the spread of COVID-19. There is an immediate need to set forth procedures for the continued reporting of vaccine administration in the effort to control this communicable disease in the State of Florida.

**SUMMARY:** Emergency rule 64DER21-4 sets forth the reporting requirements for all practitioners and other enrolled COVID-19 vaccine providers administering COVID-19 vaccines.
