(2)(a) All monies (cashiers checks, money orders, or certified bank drafts only; no cash or personal checks allowed) shall be mailed pursuant to the instructions provided on Form DC2-363, Money Order Deposit Form For Inmate Deposits, and shall be initially deposited into the Inmate Trust Fund. Form DC2-363 is hereby incorporated by reference. This form may be obtained from any institution, facility, the vendor listed on Form DC2-363, the Bureau of Finance and Accounting, Inmate Trust Fund Section, Centerville Station, P. O. Box 12100, Tallahassee, Florida 32317-2100 or the Forms Control Administrator, Office of Research, Planning and Support Services, 501 South Calhoun Street, Tallahassee, Florida 32399-2500, <http://www.flrules.org/Gateway/reference.asp?No=Ref-02765>. The effective date of this form is ~~___ 7-13~~. Funds must be mailed with the completed Form DC2-363, Money Order Deposit Form For Inmate Deposits, and made payable to vendor listed on Form DC2-363 and

include the inmate’s name and DC number. Funds will become available for the inmate’s use within ten working days after receipt by the vendor listed on Form DC2-363. Every effort shall be made to have funds available sooner. Any money order, cashiers check, or certified bank draft in the amount of \$400 or higher posted to an inmate’s account will have a ten day hold placed on the funds. After ten days the funds will be available for the inmate’s use. Deposits mailed to institutional or other Department addresses including the Bureau of Finance and Accounting, Inmate Trust Fund Section will be returned to the sender. Do not include any letters or notes with your payments, these will be discarded.

(c) Deposits sent by mail are processed using an advanced high-speed processing machine which requires the use of the deposit form; ~~the form should not be photocopied~~. Attempts will be made to process deposits sent without the accompanying form, but the absence of the form could cause a delay of up to 30 days to process. If staff are unable to determine to which inmate the money is being sent, the money will be returned to the sender with a request for additional information necessary to process the deposit. If staff are unable to determine to which inmate the money is being sent and are unable to return the money because the sender did not provide a valid return address, the money will be held in a clearing account until the sender or receiving inmate is identified. If the inmate remains unidentified for 1 year the funds shall escheat to the state as unclaimed funds held by a government agency in accordance with Section 717.113, F.S.

PURPOSE AND EFFECT: To provide a format for proof of insurance cards to incorporate legislative changes that allow for electronic devices to be used as proof of insurance.

SUMMARY: The rule is amended to provide standards regarding an electronic format for proof of insurance, in addition to paper-formatted proof of insurance cards.

15A-3.006 Identification Cards.

(1) For renewals and new policies issued after June 1, 2014 ~~Effective October 1, 1989~~, proof that personal injury protection benefits and property damage liability insurance have been purchased when required under Sections 627.733 and 324.022, F.S., shall be made by the applicant at the time of registration of any motor vehicle owned as defined in Section 627.732, F.S. Insurers shall furnish uniform proof of ~~insurance purchase cards~~ in paper or electronic formats such form as prescribed by the Department. Such proof of insurance card shall also indicate the existence of any bodily injury liability insurance voluntarily purchased.

(2) The required paper or electronically-formatted proof of insurance I.D. card must be provided for all policies issued or renewed with personal injury protection/property damage liability and bodily injury liability PIP and property damage liability on and after October 1, 1989. Such proof of insurance Effective October 1, 1990, such I.D. card shall indicate the vehicle year, make and VIN number of up to two insured vehicles per proof insured up to a maximum of 25. No more than two vehicles may be shown on a single proof of insurance when the policy covers more than two vehicles but less than 25. When more than 25 vehicles are insured under any policy, the term "Fleet Coverage" must may be indicated. Proof of insurance I.D. cards must be furnished on renewal policies at least annually thereafter.

(3) New proof of insurance ~~I.D. cards~~ shall be provided whenever there is a change in the required information. Electronically-formatted proof of insurance requires the same information as the paper proof of insurance.

(a) Specifications for paper or electronic proof of insurance ~~I.D. card specifications~~ are as follows:

1. Size: 3 1/2 inches × 2 1/4 inches, if paper card is issued.

2. Color: Optional

3. Information:

a. Header – Florida Automobile Insurance Identification Card.

b. Company Number: Numeric Florida identification number of the insurance company (not group).

c. Company Name: Insurer’s full legal company name or group name provided on the insurance policy.

d. Named Insured: First and last name(s) of the insured as indicated on the policy.

e. Policy Type: Must include an indicator of the type of coverage provided: personal injury protection/property damage liability, bodily injury liability.

f. Policy Number: Alphanumeric assigned policy number, self-insurance license, or contract number.

g. Effective Date: Numeric policy effective date, date the terms and conditions of the policy commence (special characters allowed). Effective date must include month, day and year.

h. Vehicle Identification Number (VIN):

(I) Vehicle(s) Year and Make (not to exceed two vehicles per proof of insurance)

(II) Fleet Coverage (more than twenty five vehicles insured)

i. Not valid more than one year from effective date.

j. Warning of violation of Section 316.646, F.S., must be present on all I.D. cards, “Misrepresentation of insurance is a first degree misdemeanor.”

PURPOSE AND EFFECT: This is MANDATORY rulemaking to implement statutory changes to Section 497.382, during the 2013 legislative session, at s. 18 of Ch. 2013-138, Laws of Florida. The said statutory changes eliminated the requirement that monthly Bodies Handled Reports be filed with the FCCS Division; instead, the reports are completed and retained by the licensee. This proposed rulemaking amends current Rule 69K-20.001, F.A.C., to conform the current rule to the revised statutory requirement.

SUMMARY: This proposed rulemaking amends current Rule 69K-20.001, F.A.C., to conform the current rule to the revised statutory requirement, by eliminating the requirement that the reports be filed with the Division.

(1) This rule implements Section 497.382, Florida Statutes.

(2) Each funeral establishment, direct disposal establishment, cinerator facility, and centralized embalming facility, shall each month complete the form identified in subsection (3) below, as pertinent to its category of licensure. The licensee shall retain each such completed form in its records at its licensed business premises, for inspection by Division staff, for 36 months after the month to which the form relates.

(a) Funeral establishments shall utilize form DFS-N1-1751, "Funeral Establishment/Monthly Report of Cases Embalmed or Bodies Handled," Rev. 10-06, which is incorporated by reference in Rule 69K-1.001, F.A.C.

(b) Direct disposal facilities shall utilize form DFS-N1-1752, "Direct Disposal Establishment/Monthly Report of Cases Embalmed or Bodies Handled," Rev. 10-06, which is incorporated by reference in Rule 69K-1.001, F.A.C.

(c) Cinerator facilities shall utilize form DFS-N1-1753, "Cinerator Facility/Monthly Report of Cases Embalmed or Bodies Handled," Rev. 10-06, which is incorporated by reference in Rule 69K-1.001, F.A.C.

(d) Centralized embalming facilities shall utilize form DFS-N1-1754, "Centralized Embalming Facility/Monthly Report of Cases Embalmed or Bodies Handled," Rev. 10-06, which is incorporated by reference in Rule 69K-1.001, F.A.C.

Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 39, No. 186, of the September 24, 2013, issue of the Florida Administrative Register. The change is in response to written comments submitted by the staff of the Joint Administrative Procedures Committee. The changes are as follows:

1. Subsection (2)(h)1., under the minimum penalty column, "\$2000" shall be changed to now read "\$10,000".

2. Subsection (2)(u)1., under the minimum penalty column the fine "1,500" shall be changed to now read "10,000" and under the maximum penalty column, the penalty shall now read "Revocation, and a fine of \$10,000".

3. Subsection (2)(u)11., shall now read:

11. Making or filing a report which the licensee knows to be false, intentionally or negligently failing to file a report or record required by state or federal law, or willfully impeding or obstructing another person to do so. Such reports or records shall include only those that are signed in the capacity of a licensee.
