33-602.201 Inmate Property.

- (1) through (3) No change.
- (4) Authorized Property.
- (a) through (d) No change.
- (e) Inmates shall be required to maintain receipts for items purchased from <u>an authorized source</u> the canteen for as long as they possess the items. <u>An authorized source includes the canteen</u>, the friends and family program, and any vendor authorized to conduct business with the department that has

been approved to make items available for purchase to the inmates. In instances where items purchased from an authorized source the canteen are added to Form DC6-224, Inmate Personal Property List, by the property officer, the inmate will not be required to maintain the original canteen receipt from the authorized source. Perishable food and beverage items purchased from an authorized source the canteen are intended for immediate consumption and may not be stored in an inmate's housing area. Perishable food and beverage items are those that are unsealed or that require refrigeration. Nonperishable food or beverage items may not be kept longer than 30 days, as evidenced by the canteen receipt from an authorized source, and shall be considered contraband if found in the possession of an inmate more than 30 days after purchase.

- (f) No change.
- (5) Unauthorized Property (Also see Control of Contraband, Rule 33-602.203, F.A.C.).
- (a) Property that is contraband pursuant to Rule 33-602.203, F.A.C., shall be handled as provided in that rule.
- 1. If an inmate receives postage stamps in the mail that, added to the number already in his possession, place him over the maximum allowed, he shall be allowed to send the excess stamps out at his own expense. It is the inmate's responsibility to make arrangements with staff to send out the extra stamps as soon as they are received. The stamps must be sent out; the institution will not store excess stamps for inmates. Excess stamps found in an inmate's property will be considered contraband.
- 2. If an inmate receives photographs in the mail that, added to the number already in his possession, place him over the maximum allowed, he shall be allowed to send the excess photographs out at his own expense. It is the inmate's responsibility to make arrangements with staff to send out the extra photographs as soon as they are received. Excess photographs found in an inmate's property will be considered contraband.
- 3. An inmate who is in possession of the maximum number of articles allowed by this rule and who wishes to replace a worn item must contact the property officer to arrange to discard or send the worn item out at his own expense before purchasing a replacement item.
- (b) Property that is authorized for inmates in general population such as shaving powders, oils, and lotions shall be unauthorized or restricted based upon an inmate's confinement or other high security status when that item presents a security risk. Further limits on personal items for inmates in confinement or other high security statuses are authorized as referenced in Rules 33-602.220, 33-602.221, 33-602.222, 33-601.800 and 33-601.820, F.A.C.
 - (6) through (15) No change.

- (16) Religious Property.
- (a) through (e) No change.
- (f) Religious property and other religious items shall be acquired through an authorized <u>source</u> <u>vendor</u>, <u>canteen</u> purchase, bona fide religious organization, or donor.
 - (g) through (i) No change.

APPENDIX ONE PROPERTY LIST

This list incorporates all property authorized to be possessed by inmates in all department institutions and facilities except community correctional centers. Except for items specified below as "exemptions," property received must be in compliance with this list. Inmates in possession of property previously approved by the Department of Corrections which meets the description of property on the list shall be allowed to retain the property. Inmates transferring to department facilities from private correctional facilities shall be allowed to retain only those items that are in compliance with the list of authorized property. As items sold in canteens at private facilities may differ from those sold by an authorized source in department canteens, items purchased in canteens at private facilities will not always be admissible in department facilities.

Definitions.

The "quantity" establishes a maximum possession limit. This does not mean that all state issue items will be issued to each inmate, or that the maximum number of items will be issued. All canteen items from authorized source are subject to availability and may not be available for purchase. Items found in the possession of an inmate that are in excess of the established "quantity" shall be treated as contraband in accordance with Rule 33-602.203, F.A.C. Where there is a "value" indicated, the authorized item shall not exceed that value. The terms "authorized source" "canteen" and "state issue" refer to the sources from which property can be obtained after January 1, 1996. All items with the "authorized source" "canteen" designation shall be available in all institutional canteens or through orders from an authorized source canteen order. All authorized source canteen items are transferable between department institutions. "State issue" means that the institution has the authority to issue this item to inmates based upon the character of the institution, the location of the institution, the housing or work assignment of the inmate, or other factors related to institution or inmate needs. Institutions housing death row inmates shall make adjustments to this property list when possession of listed items by death row inmates would create a threat to the security of the institution.

Exemptions.

Inmates already in possession of the following previously approved items shall be allowed to retain the items until they are no longer serviceable, but shall not be allowed to replace them with like items.

- Clothing items of a different color than specified on the property list.
 - Locks other than V68 series

- Plastic bowls, tumblers, cups and lids
- Pantyhose
- Nail clippers larger than 2-1/2"

(1) Initial applications for a cardroom <u>license</u> shall include a <u>complete set of</u> written internal <u>controls</u> <u>control system</u> established in compliance with Section 849.086, F.S., and the rules promulgated thereunder. Subsequent changes to the internal controls must be submitted to the division for approval prior to implementation, as one complete set, in a format which will include underlining additions and striking through deletions, since the last date of approved revisions with a footnote of the current revision date. The division will have 30 days from receipt to approve or disapprove the internal controls.

- (2) Failure of any cardroom operator to follow the internal controls once approved by the division shall be a violation of these rules.
- (3) A cardroom operator shall design and document an internal controls control system to reasonably assure that:

- (c) Transactions are performed in accordance with management's authorization;
- (d) Access to assets is permitted only in accordance with management's specific authorization;
- (e) Recorded accountability for assets is compared with actual assets at frequent intervals and appropriate action is taken with respect to any discrepancies;
- (f) Functions, duties, and responsibilities are appropriately segregated and performed in accordance with sound practices by competent, qualified personnel so that errors will be disclosed and corrected in a timely manner;
 - (g) Fraud is prevented or detected;
 - (h) Safety of the public and employees is enhanced; and
- (i) Competency of staff and ability to comply with established policies and procedures is promoted through training.; and

(j) Efficiency of operations is enhanced.

- (4) The cardroom manager or general manager shall sign and submit the internal <u>controls</u> control procedures to the division. The internal <u>controls</u> control procedures shall at a minimum contain the following:
- (a) A requirement that a supervisor or the transporter verify all transfers between imprest trays and the cardroom <u>vault bank</u> with their signature on the transfer document or a procedure in which tokens that display monetary amounts, commonly referred to as a lammers, are used by cardroom floor staff to authorize and document transfers between imprest trays and cardroom <u>vaults or cages banks</u>;
- (b) The designation of a cardroom <u>vault</u> bank holding all cardroom funds;
- (c) The designation of <u>the secure location</u> an imprest bank holding all imprest trays;
- (d) The designation of a cashier cage methodology for or as a method of controlling and accounting for funds within the <u>cashiers</u>' <u>eashier</u> cage that are part of the cardroom <u>vault</u> bank as an alternative to an imprest bank if designated in the internal controls;
- (e) A requirement that all transactions flowing through the cardroom <u>vault</u> bank be summarized daily as specified in the internal controls as follows:
- 1. Increases and decreases to the cardroom <u>vault</u> bank inventory shall be summarized and supported by documentation;

- 2. A record shall reflect that the cardroom <u>vault</u> bank inventories are counted by at least two persons and recorded at the end of each day on inventory documentation;
- 3. Information shall be summarized and recorded in the cardroom operator's accounting records on the business day following each day of operation; and
- 4. A statement of whether <u>a cardroom vault</u> an imprest bank or cashier cage methodology is used shall be indicated by the cardroom operator.
- (f) When a cashier cage methodology is used, the facility shall include in the <u>cardroom facility</u> internal <u>controls controls</u> procedures security <u>procedures controls</u> that limit access into the <u>cashiers</u>' <u>cashier</u> cage.  - a. Each cardroom table and its corresponding table number;
 - b. Security cameras and other surveillance equipment;
 - c. Count rooms and cashier cage;
- d. The location of the cardroom operator's designated cardroom gaming area. Designated cardroom gaming areas shall be separated by a check in area where the cardroom operator shall check identifications of players prior to being seated for play or shall have controlled entry and exit points where the cardroom operator shall check identifications to ensure no persons under 18 years of age are allowed access to the designated cardroom gaming area; and
 - e. The security surveillance system monitoring room.
- 2. Provide for clear lines of sight for the security surveillance system. There shall be no area where cards or dominoes are played or where money is collected, distributed, or counted which the security surveillance system is unable to monitor with clarity.

- (n)(p) The methodology for retirement of cards, chips, dominoes, or tokens. The methodology shall:
