Additional purposes and effects are to provide flexibility to allow certain activities on managed lands with written permission which are otherwise prohibited; to provide more flexibility to District and Center Managers to allow extended camping days and use of hunt camps during non-hunting seasons; to increase the penalties for violations from \$500 to \$1,000 to be consistent with Section 590.14, F.S., and to adopt an updated fee schedule.

Inmates may subsequently be transferred from one institution to another to serve the Department’s mission as it relates to the classification and management of the state prison population as well as to meet the needs of the inmate. ~~; however, the goal of the classification system is to retain inmates at institutions for longer periods of time in order to reduce transfers and stabilize the inmate population.~~ Inmates participating in academic, vocational, substance abuse or betterment programs will not be transferred to another institution prior to completion of the program unless the program is available at the receiving institution, or for purposes of population management or security and safety concerns specifically set forth in writing. Transfers are subject to review by the inmate grievance procedure.

On May 15, 2015, the Division of Hotels and Restaurants received a Petition for an Emergency Variance for Subparagraph 3-305.11(A)(2), 2009 FDA Food Code, Section 3-305.14, 2009 FDA Food Code, Section 6-202.15, 2009 FDA Food Code, Section 6-202.16, 2009 FDA Food Code, subsection 61C-4.010(1), F.A.C., and subsection 61C-4.010(6), F.A.C., from Roberto Diaz located in Orlando. The above referenced F.A.C. addresses the requirement for proper handling and dispensing of food. They are requesting to dispense bulk time/temperature control for safety foods other than frankfurters from an open air mobile food dispensing vehicle.

The Petition for this variance was published in Vol. 41, No. 101, F.A.R., on May 26, 2015. The Order for this Petition was signed and approved on May 27, 2015. After a complete review of the variance request, the Division finds that the application of this Rule will create a financial hardship to the food service establishment. Furthermore, the Division finds that the Petitioner meets the burden of demonstrating that the underlying statute has been achieved by the Petitioner ensuring that each pan within the steam table is properly covered with an individual lid; the steam table is enclosed within a cabinet with tight-fitting doors, and is protected by an air curtain installed and operated according to the manufacturer's specifications that protects against flying vermin or other environmental contaminants; all steam table foods must be properly reheated for hot holding at approved commissaries and held hot at the proper minimum temperature per the parameters of the currently adopted FDA Food Code; and steam table food is to be dispensed by the operator with no customer self-service. The Petitioner shall also strictly adhere to the operating procedures and copies of the variance and operating procedures are to be present on the MFDV during all periods of operation.

The rule states in part, “the facility shall provide fencing of at least four feet in height in areas identified by the Agency as Hazardous”. Advocates, Inc. requested a variance from the requirement of a four foot fence and for the Agency to allow a three foot fence because its residents are wheelchair bound and unable to walk to any area of the outside the fenced area without staff assistance. The Agency agreed that removal of the fence would be an additional cost and would constitute an unnecessary financial hardship to the Petitioner and, given the present physical limitations of the current residents, would serve no purpose since adding a foot to the height of the fence would not have any measurable impact on the safety provided by the current fence. The variance shall remain in effect as long as the petitioner serves exclusively residents that are non-ambulatory. The order granting the petition was issued on May 29, 2015.

The Agency for Persons with Disabilities hereby gives notice: That on May 7, 2015, the Agency for Persons with Disabilities, received a petition for a waiver from paragraph 65G-5.004(2)(d), F.A.C., from William Palmer Esq., counsel for the Petitioner. The rule states in part: “Neither the supported living provider nor the immediate family of the supported living provider shall serve as landlord or have any interest in the ownership of the housing unit.” Petitioner sought a waiver from paragraph 65G-5.004(2)(b), F.A.C., and indicates that R.S., has been living in the home owned by her provider for more than 20 years, has received intense specialized care while there, and regards the residence as her home. The Agency agrees that strict application of the rule would cause a significant hardship to R.S., and would preclude R.S. from receiving necessary personal support services from the provider she has known all of her life in the familiar environment she considers her home. The waiver shall be effective retroactively to May 18, 2015 and shall expire on December 31, 2015. Thereafter, the waiver is subject to annual renewal every calendar year starting January 1st pending receipt of a new petition. The order granting the petition was issued on May 29, 2015.
