Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph 120.54(3)(d)1., F.S., published in Vol. 42 No. 89, May 6, 2016 issue of the Florida Administrative Register.

A Notice of Change was published in Vol. 42 No. 123, June 24, 2016 issue and in Vol. 42, No. 184 September 21, 2016 issue of the Florida Administrative Register.

No changes to rule language are being made; all changes are to language in the Marine Turtle Conservation Handbook incorporated by reference in subsection 68E-1.004(14). Changes are being made to improve clarity, to remove all hyperlinks and any requirements to use techniques or forms not incorporated by reference in the rule and to specify that all required instructions, protocols or forms have been incorporated by reference in Rule 68E-1.004(14)(b).

Section 1, Monitoring for Coastal Construction Projects, paragraph 6, “other parts of the state” has been changed to “all other coastal counties”.

Section 2, Nesting Beach Surveys, has been changed to remove the requirement to dig into all nests to locate the eggs for the Nest Productivity Assessment (NPA) program; to reduce the number of nests required to be inventoried for NPA and the time to dig into leatherback nests with no signs of hatching from 90 to 80 days; to require submittal of all nest inventory data; and to specify the requirements for locations to hold hatchlings overnight or for methods to protect nests from mammalian predators and that requests for approval for both be submitted to mtp@myfwc.com.

Section 4, Holding Marine Turtles in Captivity, has been changed to add an option to release loggerhead turtles at smaller sizes in appropriate developmental habitat; to reduce necropsy requirements for captive marine turtles under certain situations and reporting requirements of captive marine turtle status; to increase acceptable salinity ranges in captive tanks; and to clarify requirements for veterinary licenses for Florida marine turtles held out of state.

Section 5, Tagging Turtles, language has been changed to remove references to technical documents and for clarification.

Appendix F, Nesting Information, has been changed to update Appendix F-2 for consistency with the revised Section

2 and to include instructions and protocols for reporting disorientations (F-6) and obstructed nesting attempts (F-7).

 RULE TITLE: Volatility Standards for Gasoline

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: As a result of the effects on the supply and distribution of fuel caused by Hurricane Matthew, extreme and unusual circumstances exist that are expected to prevent the distribution of an adequate fuel supply to consumers throughout the state. Following the adoption of this emergency rule, waiving certain volatility standards statewide will allow for adequate and rapid distribution of available fuel, helping to stabilize the fuel market, thus protecting the welfare of Florida consumers.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: This emergency rule was initiated at the request of fuel suppliers in order to more adequately meet the fuel needs of Florida consumers as a result of anticipated fuel shortages created by Hurricane Matthew. The storm has disrupted distribution of fuel in this state. This emergency rule will help alleviate distribution difficulties and shortages of motor fuel anticipated from this event to provide relief to Florida.

SUMMARY: This emergency rule allows for the retail distribution and sale of gasoline of a different volatility class than adopted in ASTM International designation D4814-13a, as adopted in Rule 5J-21.001, F.A.C., for the period beginning October 6, 2016, through October 31, 2016, statewide. The specific standards affected are below.

20ER16-2 Grapefruit Maturity Standards - Processed
 SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 120.54(4)(b), Florida Statutes, states that those rules pertaining to perishable agricultural commodities shall be included in the definition of rules relating to the public health, safety, or welfare.

Due to adverse growing conditions over the last 10 years due to Huanglongbing (“HLB” or “Greening”) disease significant amounts of the Florida grapefruit crops in the 2016-2017 season will have a minimum ratio of solids to citric acid below the eight to one minimum established in rule. In addition, strong winds and rain caused by Hurricane Matthew has placed fruit on the ground, which could cause economic waste by allowing good and safe food to be ruled immature.

After taking testimony and discussing the matter at a telephonic meeting and hearing in Bartow, Florida on October 5, 2016, the Florida Citrus Commission found that there exists unusual weather conditions which could cause a substantial portion of the grapefruit crop to fail maturity requirements. They voted unanimously to adopt Emergency Rule 20ER16-2, lowering the minimum ratio of total soluble solids to anhydrous citric acid requirement for grapefruit for processing for the 2016-17 season.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: Adequate notice procedures were used by the Department of Citrus to inform the public and the Florida citrus industry of the pending adoption of Emergency Rule 20ER16-2 adjusting the minimum ratio of total soluble solids to anhydrous citric acid requirement for grapefruit for processing, in that notice was made via email of the emergency rulemaking to take place at the October 5, 2016 meeting to members of the Florida Citrus Commission, all industry organizations, the Florida Press Corps and other interested persons.

SUMMARY: Emergency rule 20ER16-2 lowering the minimum ratio of total soluble solids to anhydrous citric acid requirement for grapefruit for processing for the 90-day period beginning October 6, 2016 and ending January 4, 2017.

EMERGENCY ORDER

I hereby find that the Division of Emergency Management’s timely execution of the mitigation, response, and recovery aspects of the State’s emergency management plan, as it relates to Hurricane Matthew, is negatively impacted by the application of certain regulatory statutes prescribing the procedures for the conduct of state business as well as by certain orders and rules of this agency.

Therefore, pursuant to the authority granted by Executive Order No. 16-230, I hereby suspend the effect of any statute, rule, or order that would in any way prevent, hinder, or delay necessary action by the Division in coping with this emergency.

By its express terms, this Order suspends any statute, rule, or order if: (1) strict compliance with the statute, rule, or order (as unsuspended) would in any way prevent, hinder, or delay any mitigation, response, or recovery action undertaken by the Division; and, (2) such action is necessary to cope with this emergency. The suspension includes, but is not limited to, any and all statutes, rules, or orders that affect budgeting, leasing, printing, purchasing, travel, conditions of employment, and the compensation of employees.

Because section 252.36(5)(a), Florida Statutes, allows the Governor to suspend the provisions of “any regulatory statute prescribing the procedures for [the] conduct of state business”, and because Executive Order No. 16-230 designates the Director of the Division of Emergency Management as the State Coordinating Officer for this emergency, the requirements of sections 252.46 and 120.54(4), Florida Statutes, do not apply to this Order.

The effective dates of this Order shall correspond with the effective dates of Executive Order No. 16-30.
