(1) The determination as to whether probable cause exists to believe that a violation of the provisions of Part I, Chapter 489, F.S., Chapter 455, F.S., or the rules promulgated thereunder, has occurred shall be made by a unanimous vote of the appropriate probable cause panel unless the probable cause determination is made by the Department pursuant to subsection (7).

(2) through (6) No change.

(7) The Department may make the determination as to probable cause for any case it investigates or may defer such determination to the Board's probable cause panel. In a case where the Department defers the determination of probable cause to the expertise of the Board's probable cause panel, the Department will not further exercise the determination of probable cause as to that case or as to any other case arising out of the same transaction or occurrence. Rather, the Department will continue to defer the probable cause determinations and/or dismissal decisions over the respective case to the Board's probable cause panel. The Board reserves to its probable cause panels the sole authority to find probable cause for the purpose of authorizing the filing of an administrative complaint, except as provided in Section 489.131(7)(c), F.S.

~~(8) Notwithstanding the provisions of subsections (1) and (7) above, the Board hereby delegates to the Department the determination of probable cause when the only charge that otherwise would go before the probable cause panel is that of failure to satisfy a judgment pursuant to Section 489.129(1)(q), F.S. (1998 Supp.), the case shall be presented to the probable cause panel for a determination of probable cause.~~

~~(1)~~ Section 481.321(5), F.S., requires that each registered landscape architect, corporation or partnership display its certificate of registration number in any newspaper, telephone directory or other advertising medium. The term “other advertising medium” shall be deemed to include business cards, stationery, magazines, billboards, proposals, contracts, job site signs, and electronic media. The term “other advertising medium” shall not be deemed to include articles of clothing and other promotional novelty items.

~~(2) A landscape architect or his firm may advertise in any medium, including the telephone directory yellow pages, even if no office is physically present in the area of the advertisement. Such advertisement or listing in the telephone directory, however, shall not mislead the public into believing that the phone number and address given is capable of delivering landscape architectural services to the public at that location if in fact the phone number or address listed is not a landscape architectural office.
