**PURPOSE AND EFFECT:** The Department is initiating rulemaking to establish Total Maximum Daily Loads (TMDLs) for certain Florida surface waters, where those waters previously have been identified as impaired for specific pollutants and included on the Department’s verified list of impaired waters. Pursuant to Section 403.067(6), F.S., TMDLs must be adopted in rule by the Secretary of the Department. Chapter 62-304, F.A.C., was established as the rule chapter within which rules adopting TMDLs shall reside. In accordance with paragraph 62-302.531(2)(a), F.A.C., any of these rules which establish nutrient TMDLs, if adopted, may constitute site specific numeric interpretations of the narrative nutrient

criterion set forth in paragraph 62-302.530(48)(b), F.A.C., that will supersede the otherwise applicable numeric nutrient criteria in subsection 62-302.531(2), F.A.C., for the particular surface water segment.

**SUBJECT AREA TO BE ADDRESSED:** TMDLs and their allocations will be established for the pollutants identified in the Department’s verified list of impaired waters as causing the impairment for certain impaired waters in the above listed basin. Additionally, as part of Triennial Review process, the Department will consider amendments to all surface water quality standards, including those within Chapter 62-304, F.A.C.

SPECIFIC REASONS FOR FINDING AN IMMEDIATE  
DANGER TO THE PUBLIC HEALTH, SAFETY OR  
WELFARE: Due to a recent cyberattack on Colonial Pipeline, the typical movement of fuel into North Florida has been interrupted, slowing the distribution of fuel across the panhandle. Pursuant to adopted national fuel standards, fuel volatility requirements recently shifted to accommodate the changing seasons, however, the United States Environmental Protection Agency has determined that “extreme and unusual fuel [] supply circumstance” exists that will prevent the distribution of an adequate supply of compliant gasoline to consumers. Noncompliant fuel remains available, and its sale could alleviate fuel supply issues in the northern part of the state. On May 28, 2021, the EPA issued a Third Fuel Waiver Concerning Conventional and Reformulated Gasoline, temporarily waiving federal fuel quality standards in specified areas in order to address this crisis. If Florida’s volatility standards are not also adjusted to account for this extraordinary situation, there may be a shortage of lawful fuel for sale, even as useable fuel remains available.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: This emergency rule was initiated at the request of fuel suppliers to ensure a consistent supply of fuel in Florida while avoiding the unnecessary creation of a fuel shortage. As this is an unprecedented and rapidly-evolving situation, prompt action based on information regarding recent developments in the fuel industry is both necessary and fair.

SUMMARY: This emergency rule allows fuels of different volatility classes than those set forth in ASTM International designation D4814-20a, as adopted in rule 5J-21.001, F.A.C., for the periods indicated.

5JER21-4 Volatility Standards for Gasoline

(1) Fuel Introduced at Wholesale. Through June 6, volatility Class C fuels, as specified in ASTM International designation D4814-20a, shall be lawful for introduction into terminal storage tanks from which gasoline and gasoline blendstocks are dispensed for distribution to retail outlets. Such fuel held in terminal storage tanks on or before June 6 shall be lawful for distribution to retail outlets until supplies are depleted.

(2) Fuel Introduced and Sold at Retail. Volatility Class C fuels, as specified in ASTM International designation D4814-20a, shall be lawful for sale at retail outlets until supplies are depleted, provided that they were distributed in accordance with subsection (1) of this rule.

(3) The allowances set forth in subsections (1) and (2) of this rule shall apply only to fuels introduced or sold in the following counties: Escambia, Santa Rosa, Okaloosa, Walton, Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon, Wakulla, Jefferson, Madison, Taylor, Hamilton, Suwannee, Columbia, Baker, Union, Bradford, Lafayette, Alachua, Gilchrist, Dixie, Levy, Marion, Nassau, Duval, Clay, St. Johns, Putnam, Flagler, and Volusia.

5B-40.010 Endangered and Threatened Native Flora Conservation Grants Program

The FDACS’ Division of Plant Industry is soliciting applications for review for the 2022 ENDANGERED AND THREATENED NATIVE FLORA CONSERVATION GRANTS PROGRAM. The program was authorized by the 1997 Florida Legislature to support the protection, curation, propagation, reintroduction and monitoring of native plant species of the state that are endangered or threatened and is contingent on an annual appropriation.

Who is eligible to apply?

By law, a qualified corporation:

- is a not-for-profit corporation pursuant to s. 501(c) (3) of the Internal Revenue Code of 1954.

- is described in, and allowed to receive contributions pursuant to, the provisions of, s. 170 of the Internal Revenue Code of 1954.

- is a corporation not for profit incorporated pursuant to Chapter 617 Florida Statutes.

- can demonstrate, based on program criteria described below, the ability to protect, conserve, propagate, reintroduce and monitor endangered and threatened native flora.

What specific criteria must the applicant document to be eligible for consideration?

The law requires that each applicant must successfully document:

- (1) Existing conservation experience with endangered and threatened native flora.
- (2) Existing facilities appropriate for program needs.
- (3) Existing programs administered by the corporation that successfully protect, conserve, propagate, reintroduce, and monitor native flora.
- (4) Existing record keeping and data that is accessible to national databases of endangered and threatened plants.
- (5) Qualified staff with demonstrated experience in native plant conservation.
- (6) Documentation of collaboration with related state, national, or international conservation programs.
- (7) Successful experience propagating and reintroducing endangered and threatened native flora.
- (8) Public exhibit programs publicizing the conservation of native species and the importance of the conservation effort.
- (9) Fiscal stability and ability to match grant funding.

What projects are eligible for funding?

Activities which may receive Endangered and Threatened Native Flora Conservation grant funding are:

- Activities which provide recognition of those native floras to the state that are endangered and threatened.
- Activities that encourage, within a controlled program, the protection, curation, propagation, reintroduction and monitoring of native flora that are identified as endangered or threatened.

**Local Match**

In all cases, applicants eligible to receive state funds must document matching funds. Local match may be in the form of cash, in-kind services, donated services, or materials.

**Application Deadline**

To be considered for funding applications must be delivered to the Division of Plant Industry on or before 5:00 PM, July 31, 2021, or clearly postmarked or show evidence of submission to an express mail service on or before the same time and date.

**Application Review and Project Selection**

All eligible applications will be evaluated on a competitive basis by the Endangered Plant Advisory Council at a public meeting scheduled for the fall of 2021. The Council consists of members appointed by the Florida Commissioner of Agriculture. The Council will review the applications in accordance with the criteria and procedures established in Florida Statute 581.185 and Rule-Chapter 5B-40, Florida Administrative Code. The Council will make a recommendation based on applications received and qualifications of each applicant to the Florida Commissioner of Agriculture. A level of funding (full or partial) will be suggested for each project recommended.

Final selection of projects for inclusion in the Florida Department of Agriculture and Consumer Services 2020 legislative budget request will be made by the Florida Commissioner of Agriculture and will be based on Council recommendations.

The selection will not result in an immediate grant award. Rather, the proposed grants will be subject to approval of the department’s budget request before the 2022 Legislature. The award and level of funding of each project will be subject to legislative consideration.

If projects receive 2022 legislative funding, funds will become available after July 1, 2022, the beginning of the next fiscal year. The funds will need to be obligated by June 30, 2023. Any unexpended balance of grant funds not under terms of a contract will revert to the state.

**Administrative Requirements**

To receive grant funds, grantees will be required to sign a grant award contract. The grant award contract shall be prepared by the Division and shall contain by reference all regulations, rules, and other conditions governing the grant award. In addition, each grant recipient shall cause an annual post audit

to be conducted by an independent certified public accountant. The annual audit report must be submitted to the Department for review.
