PURPOSE AND EFFECT: The purpose of this rulemaking is to adopt definitions, establish statewide renewable energy goals, require electric utilities to send their 10-year site plans, prepared pursuant to section 186.801, F.S., to the Florida Department of Agriculture and Consumer Services, and require the Florida Department of Agriculture and Consumer Services to take certain internal actions regarding renewable energy.

SUMMARY: Adopts definitions, establishes statewide renewable energy goals, requires electric utilities to send their 10-year site plans to the Florida Department of Agriculture and Consumer Services, and requires the Florida Department of Agriculture and Consumer Services to take certain internal actions regarding renewable energy.

**SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:**

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The Department’s economic analysis of the adverse impact or potential regulatory costs of the proposed rule did not exceed any of the criteria established in Section 120.541(2)(a), Florida Statutes. As part of this analysis, the Department relied upon the Office’s experience and knowledge with the industry.

Additionally, no interested party submitted additional information regarding the economic impact.

**50-5.001 Definitions**

For the purpose of this rule chapter, the definitions in section 377.602, F.S., and the following shall apply:

(1) “Department” means the Florida Department of Agriculture and Consumer Services

(2) “Electric Utility” shall have the same meaning as defined in Rule 25-22.070, F.A.C.

(3) “Renewable Energy” shall have the same meaning as defined in Section 366.91, F.S.

**50-5.002 Statewide Renewable Energy Goals**

(1) Section 377.703(2)(h)1., Florida Statutes, authorizes the department to establish goals and strategies to increase the use of renewable energy in Florida. Pursuant to this authority, the department hereby establishes the following statewide renewable energy goals. Each Electric Utility that produces or purchases energy should seek to achieve an increase in the amount of renewable energy produced or purchased to at least:

(a) 40% renewable energy by 2030;

(b) 63% renewable energy by 2035;

(c) 82% renewable energy by 2040;

(d) 100% renewable energy by 2050;

(2) For purposes of determining whether these goals have been met, the baseline amount of renewable energy produced or purchased by each Electric Utility shall be the amount of renewable energy reported in 2021 by the Electric Utility to the Public Service Commission as part of its 10-year Site Plan pursuant to Section 186.801, F.S.

**50-5.003 Renewable Energy Data Reporting**

(1) Pursuant to ss. 377.603 and 377.604, F.S., no later than the first Wednesday of May each year, each Electric Utility shall submit to the Department its 10-year site plan, prepared pursuant to section 186.801, F.S., and submitted to the Public Service Commission. The plan shall be submitted to the department via email to Energy@FDACS.gov.

(2) The information submitted to the department is subject to the limitations of Section 377.606, F.S.

(3) Failure to submit the 10-year site plan to the Department is a violation of Section 377.607, F.S.

**50-5.004 Department Actions**

(1) The Department shall submit comments, in accordance with Rule 25-22.071(3)(c), F.A.C., on each Ten-Year Site Plan submitted by an Electric Utility to the Public Service Commission including an evaluation the capability of the Ten-Year Site Plan to achieve the goals adopted in this rule chapter.

(2) The Department shall monitor each Electric Utility’s progress toward the goals adopted in this rule chapter and shall include its findings and recommendations as an addendum to its annual report to the Governor and Legislature required by section 377.703, F.S.

Notice is hereby given that the following changes have been made to the proposed rule in accordance with subparagraph

120.54(3)(d)1., F.S., published in Vol. 48 No. 71, April 12, 2022 issue of the Florida Administrative Register.

In response to public comment the rule is amended as follows:

(8) Reimbursement for Quality Programs. A child care provider that is currently participating in a state or local quality improvement program, as documented by the coalition and approved by the Division of Early Learning, may receive a differential rate higher than the established coalition reimbursement rate for each care level and unit of care. The reimbursement rate for each state and local quality improvement differential shall be calculated using the established coalition reimbursement rate for each care level and unit of care.

(a) No change.

(b) Reimbursement for Quality Performance Incentive. Beginning July 1, 2022, an eligible child care provider that receives a program assessment composite score at or above the Contract Minimum Threshold score, as defined in Rule 6M-4.741, F.A.C., shall receive a tiered Quality Performance Incentive differential rate above the established coalition reimbursement rate for each care level and unit of care. A child care provider’s Quality Performance Incentive differential shall be based on the most recent program assessment composite scores. The differential will be adjusted and applied at the next monthly provider reimbursement payment. A child care provider that is currently on a Quality Improvement Plan, pursuant to Rule 6M-4.740, F.A.C., is not eligible for the Quality Performance Incentive.

1. Providers that receive program assessment composite scores of 4.50 to 4.99 shall receive a four (4) percent Quality Performance Incentive differential.

2. 1. Providers that receive program assessment composite scores of 5.00 to 5.99 shall receive a seven (7) percent Quality Performance Incentive differential.

3. 2. Providers that receive program assessment composite scores of 6.00 to 7.00 shall receive a ten (10) percent Quality Performance Incentive differential.

FINAL ORDER  
 APPROVING CITY OF AUBURNDALE ORDINANCE NO.  
 1680

The Department of Economic Opportunity (“Department”) hereby issues its Final Order, pursuant to section 380.05(6), Florida Statutes, approving land development regulations adopted by City of Auburndale, Florida, (the “City”) Ordinance No. 1680 (the “Ordinance”).

FINDINGS OF FACT

- The Green Swamp Area is designated by section 380.0551, Florida Statutes, as an area of critical state concern. The City is a local government within the Green Swamp Area of Critical State Concern.
- The City adopted the Ordinance on December 6, 2021, and rendered it to the Department on February 22, 2022.
- The Ordinance amends Chapter 15 of the City’s Land Development Code to create the Lakes District Master Planned Community Area under a new section, Article 4. The Ordinance also establishes land development regulations applicable within the Lakes District Master Planned Community Area, including zoning, building, general, and master guidelines and standards.

CONCLUSIONS OF LAW

- The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. *See* Section 380.05(6), Florida Statutes; *See also* Chapter 28-26, Florida Administrative Code.
- “Land development regulations” include local zoning, subdivision, building, and other regulations controlling

the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.

6. The Ordinance is consistent with the City’s Comprehensive Plan generally, as required by section 163.3177(1), Florida Statutes, and specifically, with Policy 1.1, Policy 1.27, Policy 2.8, Policy 4.12, Policy 11.2 and Policy 11.15.

7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must also be consistent with the principles for guiding development for that area. *See* section 380.05(6), Florida Statutes. The Principles for Guiding Development for the Green Swamp Area of Critical State Concern are set forth in Rule 28-26.003, Florida Administrative Code.

8. The Ordinance is consistent with the Principles for Guiding Development as a whole, and is not inconsistent with any of the Principles for Guiding Development.

WHEREFORE, IT IS ORDERED that the Department finds that City of Auburndale Ordinance No. 1680 is consistent with the City’s Comprehensive Plan and the Principles for Guiding Development for the Green Swamp Area of Critical State Concern and is hereby APPROVED.

This Order becomes effective 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
