The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: There are no costs to the regulated public as a result of the proposed amendments. Therefore, this rulemaking will not result in any adverse economic impacts or regulatory cost increases that require legislative ratification.

- (2) Normally applicable permit application fees will apply when the fee is less than \$100.00. In order for a county or municipality which is described in one of the above eategories to qualify for a permit fee reduction, the governing body of the county or municipality must submit and certify that the fee reduction is necessary due to fiscal hardship.

- (3) The submission of a certification pursuant to Section 218.075, F.S., and this section shall be a factor in determining whether the permit applicant can provide reasonable assurance of conditions of issuance for an environmental resource permit with required mitigation. The governing body shall certify to the District, with supporting documentation, that the fiscal hardship is due to at least one of the following factors:
- (a) Per capita taxable value is less than the statewide average for the current fiscal year;
- (b) Percentage of assessed property value exempt from ad valorem taxation is higher than the statewide average for the current fiscal vear:
- (c) Any condition specified in Section 218.503, F.S., that determines a state of financial emergency;
- (d) Ad valorem operating millage rate for the current fiscal year is greater than 8 mils; or
- (e) A financial condition documented in annual financial statements at the end of the current fiscal year which indicates an inability to pay the permit fee during that fiscal year.
- (4) Upon receipt of the above certification, with the supporting documentation, the District shall review and determine the fee is reduced to \$100.00 for the proposed activity.
- (5) The certification shall be submitted at the time of application for a permit pursuant to Chapter 40D-2, 40D-4, 40D-40 or 40D-400, F.A.C.
- (6) Unless at the time of submittal of an application either the appropriate fee or a certification pursuant to this section is submitted, the application shall be subject to denial.
- (7) The submission of a certification pursuant to this section shall be a factor in determining whether the county or municipality can provide reasonable assurance of conditions of issuance for an environmental resource permit with required mitigation.

The provisions of this rule control the treatment of dental patients in an outpatient dental office where a dentist with a general anesthesia permit performs the sedation services for a treating dentist. The treating dentist must possess a general anesthesia permit, conscious sedation permit, or pediatric conscious sedation permit. The level of anesthesia

administered shall be to any level necessary to safely and effectively treat the dental patient. This rule shall control notwithstanding any rule provision in this Chapter that prohibits such conduct.

# (1) General Anesthesia Permit Holder's Office:

A general anesthesia permit holder may perform sedation services for a dental patient of another general anesthesia permit holder or conscious or pediatric conscious sedation permit holder in his or her office or in another general anesthesia permit holder's office. In this setting, the following shall apply:

- (a) The dental treatment may only be performed by a treating dentist who holds a valid anesthesia permit of any level:
- (b) The treating dentist and the anesthesia provider are both responsible for the adverse incident reporting under Rule 64B5-14.006, F.A.C.
- (2) Conscious and Pediatric Conscious Sedation Permit Holder's Office:

A general anesthesia permit holder may perform sedation services for a dental patient of another dentist who holds a conscious sedation permit or a pediatric conscious sedation permit at the office of the treating dentist. In this setting, the following shall apply:

- (a) The dental treatment may only be performed by the conscious sedation or pediatric conscious sedation permit holder;
- (b) The general anesthesia permit holder may perform general anesthesia services once an additional board-inspection establishes that the office complies with the facility, equipment and supply requirements of Rule 64B5-14.008, F.A.C.;
- (c) The treating dentist and the anesthesia provider are both responsible for the adverse incident reporting requirements under Rule 64B5-14.008, F.A.C.

# (3) Equipment:

When the general anesthesia permit holder performs the anesthesia services in a dental office of a conscious or pediatric conscious sedation permit holder office, the electrocardiograph and end tidal carbon dioxide monitor equipment mandates may be met as follows:

- (a) The general anesthesia permit holder provides the equipment which has already been inspected during the general anesthesia permit holders required inspection;
- (b) The equipment is available for inspection during the office's mandated inspection; and
- (c) The equipment is immediately available for an adverse incident report inspection.

# (4) Staff or Personnel:

An anesthesia provider and the treating dentist are both responsible for ensuring that a minimum number of three (3) personnel are present during the procedure. The personnel must meet the minimum credentialing requirements of Rule 64B5-14.003, F.A.C.

(5) Records: The treating dentist shall maintain a complete copy of the anesthesia records in the patient's dental chart. The dentist performing the anesthesia must maintain the original anesthesia records. The treating dentist must identify by name and license number all personnel utilized during the procedure.

The provisions of this rule control the treatment of patients where an anesthesia permitted dentist sedates the dental patient in his or her board-inspected and board-registered dental office and a Florida licensed dentist without an anesthesia permit performs the dental treatment. This rule shall control notwithstanding any rule provision in this Chapter to the contrary, which prohibits such conduct.

- (1) The permitted dentist shall perform the sedation in his or her out-patient dental office where the permitted dentist is registered to perform the anesthesia services;
- (2) The permitted dentist shall remain with the patient from the onset of the performance of the anesthesia until discharge of the patient;

After the initial airway management course, the treating dentist shall continue to repeat a minimum of four hours in airway management every four years. The continuing education courses taken shall be credited toward the mandatory thirty hours of continuing education required for licensure renewal.

## THE FULL TEXT OF THE PROPOSED RULE IS:

64B8-15.002 Introduction.

(1) In 1986, Florida enacted legislation governing the eertification of foreign medical schools. The intent of the Legislature is best expressed in Section 458.314(1), Florida Statutes (1986 Supp.), in which the Legislature recognized the need to ensure that graduates of foreign medical schools who have received an education which is reasonably comparable to that of similar accredited institutions in the United States and which adequately prepares its students for the practice of medicine shall be subject to the same licensure requirements as graduates of accredited medical schools or colleges. The stated purpose of the legislation is to provide for the evaluation of foreign medical schools and the certification of those foreign medical schools which provide an education which is reasonably comparable to that of similar accredited institutions in the United States and which adequately prepare their students for the practice of medicine.

(2) In order to determine reasonable comparability between the medical education programs of foreign medical schools seeking certification and accredited medical schools in the United States, the Department shall employ the standards published by the Liaison Committee on Medical Education (LCME), known as Functions and Structure Structures of a Medical School, (May 2012) which is hereby incorporated by reference and available at http://www.lcme.org/functions.pdf , have served as a basis for the development of standards for Florida's certification program. Portions of the LCME standards which are primarily applicable in the United States have been eliminated or modified where appropriate.

(3) In the United States medical education leading to the degree of Doctor of Medicine (M.D.) is evaluated by the LCME, a committee of the Association of American Medical Colleges and the American Medical Association. The LCME is recognized by the U.S. Department of Education as the accrediting agency for programs of medical education leading to the first professional degree in the United States. The LCME has 18 members including both physicians and non-physicians. medical students and a representative of the Committee for the Accreditation of Canadian Medical Schools.

(4) The LCME publishes guidelines for the structure and functions of a medical school which are designed to allow flexibility among schools while requiring that each meets defined basic standards. The LCME has the authority and responsibility to evaluate the quality of each educational program and to withhold or withdraw accreditation from any school which in its judgment fails to meet minimum standards.

(5) The standards which Florida has developed are known as Florida Standards for Certification of Foreign Medical Education Programs (Florida Standards). Florida has also developed a Florida Medical Education Data Base, adapted from the LCME Medical Education Data Base, designed to elicit from the school the basic information necessary to form a preliminary judgment concerning foreign medical education programs.

(6) To the extent the standards herein are consistent with LCME standards, interpretations given the standards by the LCME shall be relied upon.

Form DC6-2067 also may include the time of collection, if the test was initiated due to substance abuse program participation, and identification of all individuals who had custody of the specimen from the time of collection until the specimen was prepared for shipment to the laboratory. Once the outside laboratory receives the specimen, it will become the laboratory's responsibility to maintain a chain of custody throughout the testing process.

Rule 33-602.2035(3)(a)3. shall read as:

3. The tester shall ensure that all collected urine specimens being sent to a designated outside laboratory for confirmation testing are properly labeled and sealed with a security label as provided on Form DC6-2067, the Chain of Custody Form. The tester shall also ensure that Form DC6-2067, the Chain of Custody Form for all collected urine specimens is completed in accordance with department procedure 108.005(4).

Form DC6-2067, the Chain of Custody Form, shall be changed to add the words "Chain of Custody Form" at the top of the form.
