PURPOSE AND EFFECT: The purpose of this rule is to establish procedures used by the Commission for Independent Education (Commission) for receiving complaints of failure to report child abuse, abandonment or neglect, as required by Section 30.205, F.S., and assessing a fine. Nonpublic college, university and school administrators and their law enforcement agencies are required to report information received about child abuse, abandonment or neglect that occurred on institution property or at an event sponsored by the institution to the Florida Department of Children and Family Services. This rule defines the terms "administrator," "commission" and "law enforcement agency." The effect of this rule is that if an institution's administrator or law enforcement agency is informed of child abuse, abandonment or neglect and does not report it, or knowingly and willingly prevents another person from doing so, the institution shall be subject to a fine of \$1 million by the Commission.

<u>6E-6.001 Failure of Nonpublic College, University or School Administrator or Law Enforcement Agency to Report Child Abuse, Abandonment or Neglect.</u>

(1) Definitions. For purposes of this rule, the following definitions apply:

- (a) The term "administrator" means the personnel who have been assigned the responsibilities of institution-wide or campus-wide academic or administrative functions.
- (b) The term "Commission" means the Commission for Independent Education.
- (c) The term "law enforcement agency" means any unit of the nonpublic college, university, or school, as defined in Section 1002.21 or Section 1005.02, Florida Statutes, which is vested with the authority to bear arms and make arrests, and whose primary responsibility is the prevention and detection of crime or the enforcement of the penal, criminal, traffic, or highway laws of the state.
  - (2) Failure to Report.
- (a) Any person who has knowledge that a nonpublic college, university or school administrator knowingly and willfully failed to report information of known or suspected child abuse, abandonment or neglect, or knowingly and willfully prevented another person from doing so, as required by Section 30.205, Florida Statutes, to the Department of Children and Families, may file a complaint with the Commission by e-mail at www.fldoe.org/cie, by fax at (850) 245-3238, or by writing to the Commission at 325 West Gaines Street, Suite 1414, Tallahassee, FL 32399-0400.
- (b) Any person who has knowledge that a law enforcement agency failed to report information of known or suspected child abuse, abandonment or neglect, as required by Section 30.205, Florida Statutes, to the Department of Children and Families, may file a complaint with the Commission by e-mail at www.fldoe.org/cie, by fax at (850)245-3238, or by writing to the Commission at 325 West Gaines Street, Suite 1414, Tallahassee, Florida 32399-0400.
- (c) Upon receipt of a complaint, the Commission shall investigate it within thirty (30) days.
- (d) The institution shall be provided with the complaint, the Commission's investigation, and a copy of Section 39.205, Florida Statutes, and shall have twenty (20) working days after receipt to submit a written response to the Commission.
  - (3) Action by the Commission.

Prior to imposing a fine, the Commission shall consider the complaint, the investigation, and the institution's response at a publically noticed meeting. Any order imposing a fine shall be reduced to writing and a copy provided to the institution or agency.

(4) Fines.

<u>Fines assessed under this section shall be paid to the Chief</u> Financial Officer of the Department of Education for deposit into the Institutional Assessment Trust Fund in accordance with subsection 6E-4.001(9), F.A.C.

64B16-28.810 Special Pharmacy – Limited Community Permit.

A Special-Limited Community Permit shall be obtained by a Class II Institutional Pharmacy that dispenses medicinal drugs, including controlled substances, to:

- (1) through (2) No change.
- (3) Patients obtaining medical services in the facility's emergency room and, whenever it is otherwise appropriate, as indicated in the applicant's policy and procedure manual, and-
- (4) Discharged patients of the hospital who are under a continuation of a course of therapy using multi-dose medicinal drugs if the following requirements are met:
- (a) The label affixed to a container used in dispensing multi-dose medicinal drugs contains at least the following information:
  - 1. The name of and contact information of the pharmacy;
  - 2. The name of the prescriber;
  - 3. The name of the patient;
- 4. The date of the original filling and any applicable expiration date;
- <u>5. The prescription number or other prescription</u> identification adequate to readily identify the prescription;
  - 6. The directions for use;
- 7. The name, strength, and size of the medicinal drug dispensed; and
  - 8. The quantity of the drug in the container.
- (b) The patient is deemed competent to handle and administer the multi-dose medicinal drug.
- (c) A specific order is written by the patient's physician to authorize that the multi-dose medicinal drug is appropriate to dispense upon discharge.
- (d) Before the hospital dispenses a multi-dose medicinal drug as specified in subsection (4) of this section, the hospital shall establish protocols to ensure the following:
- 1. Infection control during transport and handling of multi-dose medicinal drug containers that have been in contact with a patient;
- 2. Patient or caregiver education on administration of the multi-dose medicinal drug if necessary on an individual basis.
- (e) A "multi-dose medicinal drug" as used in this rule means, but is not limited to, commercially available multi-

dose packages such as inhalers, ocular products, insulin vials or pens, otic products, bulk antibiotic suspensions, topical agents, and methylprednisolone dose packets dispensed to inpatients, provided in containers that may exceed a three (3) day supply, and are intended to be continued by the patient on an outpatient basis but not to be re-filled by the hospital. Controlled substances are not considered multi-dose medicinal drugs as defined in this rule.
