Penalties for Failure to Report Child Abuse 6A-14.099 PURPOSE AND EFFECT: The purpose of this rule development is to establish penalty procedures by the State Board of Education for assessing a fine to Florida College System (FCS) institutions and Law Enforcement Agencies (LEAs) that fail to report child abuse as required by Section 39.205(10), Florida Statutes. FCS institution administrators and LEAs are required to report information received about child abuse that occurred on institution property or at an event sponsored by the institution to the Florida Department of Children and Family Services. This rule also defines the term "administrator" and the term "Law Enforcement Agency." The effect of this rule is that if an administrator of an FCS institution or an LEA is informed of child abuse and does not report it, the institution will be fined \$1,000,000 by the SBOE. FCS institutions will be allowed to challenge the SBOE's determination that there was a knowing and willful failure to report this information.

For Rule 1A-32.003, F.A.C., the proposed rule amendment clarifies that only museums, universities, colleges or other historical, scientific or educational institutions or societies that subscribe to the "Principles of Archaeological Ethics" of the Society for American Archaeology will be considered as valid research applicants for Chapter 1A-32 Archaeological Research Permits issued by the Bureau of Archaeological Research. For Rule 1A-32.005, F.A.C., the amendment incorporates reference proposed bv Archaeological Research Permit - 1A-32 Application (Form HRE4404-13), and provides information on where to obtain a copy of this form.

SUMMARY: The proposed amendments will define the criteria necessary to apply for an archaeological research permit.

1A-32.001 Definitions.

(1) Accredited Institutions shall mean those state institutions that which:

- (a) Ppermanently possess professional archaeological staff who meet or, in the judgment of the State Archaeologist, are capable of meeting the following Secretary eriteria of the Interior's training and experience necessary for registration in the Society of Professional Archaeologists with emphases in field and collections research as defined in the "Qualifications Standards for archaeology, which for Recognition as a Professional Archaeologist," of the Society. The emphases in field and collections research may be represented by separate individuals. Such institutions should also:
- 1. A graduate degree in archaeology, anthropology, or closely related field plus:
- a. At least one year of full-time professional experience or equivalent specialized training in archaeological research, administration or management;
- b. At least four months of supervised field and analytic experience in general North American archaeology, and
  - c. Demonstrated ability to carry research to completion.
- 2. In addition to these minimum qualifications, a professional in prehistoric archaeology shall have at least one year of full-time professional experience at a supervisory level in the study of archaeological resources of the prehistoric period. A professional in historic archaeology shall have at least one year of full-time professional experience at a supervisory level in the study of archaeological resources of the historic period; and
- (b) Subscribe to the "Principles Code of Archaeological Ethics;" "Standards of Research Performance," and "Institutional Standards" of the Society for American Archaeology of Professional Archaeologists, particularly with in respect to facilities and support services for the successful, professional conduct of archaeological field research. The "Principles of Archaeological Ethics" are incorporated herein by reference and may be obtained by writing the Bureau of Archaeological Research, 1001 de Soto Park Drive, Tallahassee, Florida 32301, or by calling (850)245-6444.
- (2) Non-Accredited Institution shall mean all other institutions as provided in subsection 267.12(2)(1), F.S.
- (3) Professional archaeological expertise shall mean persons who meet, or in the judgment of the State Archaeologist are capable of meeting, the <u>Secretary eriteria</u> of training and experience necessary for registration in the <u>Interior's Society of Professional Standards for archaeology Archaeologists</u>, as defined in the "Qualifications for Recognition as a Professional Archaeologist" of the Society.
- (4) <u>Principles</u> <u>Professional quality research shall mean</u> research conducted by persons with professional archaeological expertise and in a manner consistent with the

<u>"Code of Archaeological</u> Ethics" and "Standards of Research Performance" of the Society for American Archaeology of Professional Archaeologists.

1A-32.003 Criteria for Evaluating Research Requests.

The following criteria are established to insure that research upon archaeological sites pursuant to Section 267.12, F.S., shall be conducted in a professional manner, and that the data recovered as a result thereof shall benefit the people of Florida in understanding their rich and varied heritage. All research requests shall contain the following:

- (1) Only reputable museums, universities, colleges or other historical, scientific or educational institutions or societies that subscribe to the "Principles of Archaeological Ethics" of the Society for American Archaeology will be considered as valid research applicants; and,
- (2) Applicants shall possess or will secure the professional archaeological expertise necessary for the performance of professional quality archaeological field research, comprehensive analysis and interpretation in the form of publishable reports and monographs; and,
- (3) Applicants shall possess or will secure sufficient artifactual conservation and storage capabilities to insure artifact preservation during the research period; and,
- (4) No research request shall be considered, exclusive of reconnaissance survey requests, unless (a) a degree of endangerment to the archaeological resources is present in the proposed research area (i.e. severe erosion); (b) the proposed research area form an integral part in a well-defined research design or (c) the research is part of a planned interpretive reconstruction or restoration project; and,
- (5) Adequate funding capability must be available to fully implement the proposed research plan, including field work, laboratory analysis and processing and manuscript preparation.

- (a) Name, address and official status of person to be in general charge of project, including a resume of previous experience pertinent to archaeological research; and,
- (b) Nature, status and scientific affiliations of applicant organization; and,
- (c) Names and qualification of additional research participants who will exercise any supervisory authority during the proposed research project; and,
- (d) Total fiscal resources available for publication requirements.

(3)(2) Completed permit applications must be submitted to the Division prior to the project research initiation date.

The purpose and effect of the proposed amendments to Rule 62-40.416, F.A.C., is to promote the use of reclaimed water in lieu of higher quality sources where appropriate, and provide clarification to consumptive use permit applicants seeking supplemental water for reuse systems on how they may meet the conditions for issuance.

SUMMARY: In both the addition of a definition in Rule 62-40.210, F.A.C., and the addition of criteria in Rule 62-40.416, F.A.C., the proposed rule amendments provide criteria for the review of consumptive use permit applications to supplement reclaimed water systems with water from other sources.

- (1) through (8) No change.
- (9) Supplementation of reclaimed water systems is a strategy that can benefit Florida's water resources by reducing reliance on traditional water supplies and maximizing the use of reclaimed water.
- (a) When use of water for supplementation is requested, as part of the permit application review, the District shall require that an applicant provide reasonable assurance that:
- 1. The use of water for supplementation will increase the amount of reclaimed water beneficially used, reduce the amount of reclaimed water disposal to the extent practicable, and reduce the need to use higher quality sources for non-potable purposes; and
- 2. The quantity of water requested for supplementation to achieve the requirements in subparagraph 62-40.416(9)(a)1., F.A.C., has been minimized to the extent environmentally, technically, and economically feasible.
- (b) To meet the requirements of subparagraph 62-40.416(9)(a)2., F.A.C., the District shall require a plan from the applicant for the use of supplemental water in the reclaimed water system. The plan shall demonstrate why the requested quantity of water is needed to reasonably meet demands, how it will be used efficiently in the system, and, if applicable, how it will be used to expand the system. The plan shall consider the following elements or explain why an element is not applicable:

- 1. Use of lower quality water sources;
- 2. Designation of primary and secondary (interruptible) customers;
- 3. The appropriate level of certainty to be provided to end users during drought conditions;
  - 4. Financial incentives for voluntary use reductions;
- 5. Reclaimed water interconnects with other reuse utilities;
- <u>6. Providing customers with information explaining the</u> need to conservatively use reclaimed water;
  - 7. Regulatory constraints or requirements on discharges;
- 8. Demand management when using the supplemental water;
  - 9. Creation of additional storage; and
- 10. Any other measures identified by the applicant to demonstrate the efficient use of supplemental water.
- (c) For the purposes of facilitating supplementation with stormwater to improve water quality in surface or ground waters, a District may adopt alternative criteria for such use in lieu of the requirements in subparagraph 62-40.416(9)(a)2. and paragraph 62-40.416(9)(b), F.A.C.

69L-6.031 Stop-Work Orders in Effect Against Successor Corporations or Business Entities.

- (1) Under <u>paragraph Section</u> 440.107(7)(b), F.S., stop-work orders or orders of penalty assessment issued against a corporation, <u>limited liability company</u>, partnership, or sole proprietorship shall be in effect against any successor corporation or business entity that has one or more of the same principals, <u>limited liability company members</u>, or officers as the predecessor corporation or business entity against which the stop-work order was issued and are engaged in the same or equivalent trade or activity.

- (b) For employers engaged in the non-construction industry, a corporation, <u>limited liability company</u>, partnership, or sole proprietorship and the successor corporation or business entity that has been issued a stop\_work order or order of penalty assessment, are engaged in the same or equivalent trade or activity if they each perform or have performed business operations that include operations described in at least one classification code that is in the manufacturing, goods and services, or the office and clerical industry group listed in subsection (6) of this rule.
- (c) For employers that perform business operations described by one of the classification codes in the miscellaneous industry groups listed in subsection (6) of this rule, a corporation, <u>limited liability company</u>, partnership, or sole proprietorship and the successor corporation or business entity that has been issued a stop-work order or order of penalty assessment, are engaged in the same or equivalent trade or activity if they each perform or have performed the same business operation described in one of the classification codes contained in the miscellaneous industry groups.
- (2) A stop-work order or order of penalty assessment issued against a corporation, <u>limited liability company</u>, partnership, or sole proprietorship becomes effective against a successor corporation or business entity that has one or more of the same principals, directors, officers, <u>limited liability company members</u>, partners, or shareholders with a 10% or greater interest, including any "affiliated person" as defined in

subsection Section 440.05(15), F.S., in common with the predecessor corporation or business entity against which the original stop\_work order or order of penalty assessment was issued and is engaged in the same or equivalent trade or activity, through service on the successor corporation or business entity of an order applying a stop\_work order or order of penalty assessment to successor corporation or business entity. The order applying a stop\_work order or order of penalty assessment to successor corporation or business entity remains in effect until withdrawn by the department.

- (3) In the event one of the following three criteria is satisfied, the department will withdraw an order applying a stop\_work order or order of penalty assessment:
- (a) The department must have released the stop- work order or order of penalty assessment in effect against the predecessor corporation, <u>limited liability company</u>, partnership, or sole proprietorship that has one or more of the same principals, officers, directors, <u>limited liability company members</u>, partners, or shareholders with a 10% or greater interest, in common with the successor corporation or business entity.
- (b) The principal, officer, director, <u>limited liability company member</u>, partner, or a shareholder with a 10% or greater interest in the successor corporation or business entity against which the stop-work order or order of penalty assessment has been served, must formally disassociate himself or herself from the predecessor corporation, <u>limited liability company</u>, partnership, or sole proprietorship by providing the department with the following:
- 1. Records obtained from the Florida Department of State, Division of Corporations, indicating that no person or entity affiliated with the successor corporation or business entity holds any position as an officer, director, <u>limited liability company member</u>, or shareholder with a 10% or greater interest in the predecessor corporation or business entity.
  - 2. through 3. No change.
- (c) The successor corporation or business entity and the predecessor corporation, <u>limited liability company</u>, partnership, or sole proprietorship that has been issued a stopwork order or order of penalty assessment, must no longer be engaged in the same or equivalent trade or activity, as determined by the department, pursuant to the codes from subsection (6) of this rule.
- (4) An order applying a stop\_work order or order of penalty assessment shall take effect when served upon the employer or, for a particular worksite, when served at that worksite.
- (5) Under <u>paragraph</u> Section 440.107(7)(c), F.S., the department shall assess a penalty of \$1,000 per day against an employer for each day that the employer conducts business

operations in violation of an order a applying a stop-work order or order of penalty assessment.

In these such considerations, the property appraiser must shall properly evaluate the relative merit and significance of each factor.
