PURPOSE AND EFFECT: The purpose of this rule development is to repeal the Special Acts of Local Application (Special Acts) for Gilchrist and Indian River.

Chapter 21254, L.O.F., allowed the year round sale of saltwater fish in Gilchrist County, provided the seller is properly licensed. Chapter 21305, L.O.F., prohibited nets and limits the type of gear that can be used to take fish in the Indian River channel or its banks. Chapter 77-572, L.O.F., limited the type of fishing gear that can be used to take fish near the bridges of the Indian River and Sebastian Inlet or the canals of Indian River County. It also prohibited throwing cast nets from most Indian River County bridges. Chapter 79-480, L.O.F., prohibited shellfish harvest on submerged lands within 75 feet of the shore, with allowances for shellfish harvest on privately owned submerged lands or docks. These Special Acts will be repealed in order to ensure that current relevant statewide rules apply in these Counties, creating greater consistency among saltwater fishing

The effects of this rule will be to repeal a series of outdated and/or redundant saltwater fishing regulations, eliminate confusion, and increase consistency with current statewide regulation. The repeal of Chapter 21254, L.O.F., Gilchrist County Special Acts will have no effect on fishing regulations because the provisions of these Special Acts are already provided for elsewhere in Florida Statutes, the Florida Constitution and Florida Administrative Code. The repeal of Chapters 21305, 77-572 and 79-480, Indian River County Special Acts, will create greater consistency among Florida fishing regulations by ensuring that existing statewide gear regulations and regulations on oyster harvest are applied in Indian River County.

SUBJECT AREA TO BE ADDRESSED: Subject areas to be addressed in the rule development notice include the repeal of Special Acts; the sale of saltwater fish in Gilchrist County; the types of fishing gear permitted and areas they can be used, and shellfish harvest in marine waters of Indian River County.

Existing Rule 69L-7.710, F.A.C., is rewritten and reorganized into five proposed rules that are intended to replace existing Rule 69L-7.710, F.A.C. The proposed rules incorporate updated versions of form DFS-F5-DWC-9, related instructions, including revised billing instructions for dispensing practitioners when billing for dispensed medications and for pharmacists billing on form DFS-F5-DWC-10. 6A-1.09401 Student Performance Standards

PURPOSE AND EFFECT: Under the proposed revisions, the Next Generation Sunshine State Standards for social studies will now include a financial literacy strand. In addition, the Next Generation Sunshine State Standards for English and mathematics will now include access points to provide access to the general education curriculum for students with significant cognitive disabilities and English language learners will now have English language proficiency standards to become fully proficient in both social and academic English.

SUMMARY: Next Generation Sunshine State Standards for social studies have been revised to meet legislative requirements. English Language Development/Proficiency Standards for English Language Learners has been added to provide clarity, address all content previously being taught, and define more measurable expectations for students. Next Generation Sunshine State Standards for English and mathematics now include revised access points.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION: The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

- (1) Student Performance Standards in Florida are defined as the Next Generation Sunshine State Standards and establish the core content of the curricula to be taught and specify the core content knowledge and skills that K-12 public school students are expected to acquire. The Next Generation Sunshine State Standards are rigorous and reflect the knowledge and skills students need for success in college and careers. The standards and benchmarks describe what students should know and be able to do at grade level progression for kindergarten to grade 8 and in grade bands for grade levels 9-12. The access points and core content connectors contained in the Next Generation Sunshine State Standards provide access to the general education curriculum for students with significant cognitive disabilities. Public schools shall provide appropriate instruction to assist students in the achievement of these standards for Special Diploma as appropriate. These standards, benchmarks, access points and core content connectors are contained in the following publications which are hereby incorporated by reference and made a part of this rule.

- (3) Each district school board shall incorporate the Sunshine State Standards, Sunshine State Standards for Special Diploma, or Next Generation Sunshine State Standards as appropriate for subject areas contained herein into the district Student Progression Plan.
- (4) The Sunshine State Standards and Next Generation Sunshine State Standards shall serve as the basis for statewide assessments.
