(e) Zero annual fee from any independent or dependent special district that meets all of the following conditions:

1. The special district is in compliance with its Annual Financial Reporting Requirements to the Department of Financial Services;

2. The special district reported \$3,000.00 or less in revenues to the Department of Financial Services on its Annual Financial Report for the most recent fiscal year in which complete annual data is available from the Department of Financial Services, or as a newly created special district, has <u>submitted</u> attached a current income statement verifying \$3,000.00 or less in revenues for the current fiscal year;

3. The special district is not a component unit of a general purpose local government as defined in the Governmental Accounting Standards Board's Statement No. 14, issued in June 1991, effective after December 15, 1992, as amended; and

4. The special district's registered <u>agent</u> agency has <u>successfully complied with subsections (1) and (2) of this Rule</u> <u>and the Department has determined that</u> fully completed the certification section on the Special District Fee Invoice and Update Form certifying the special district meets the conditions for a zero annual fee, and has returned the Special District Fee Invoice and Update Form to the Department by the due date.

(f) \$175.00 from all other independent and dependent special districts.

(3) The Department shall verify the conditions for a zero annual fee within 30 days of receiving the completed certification section on the Special District Fee Invoice and Update Form.
