64B16-27.797 Standards of Practice for Compounding

Sterile Preparations (CSPs)

PURPOSE AND EFFECT: The Board proposes the rule amendment for the specific purpose of determining the necessity of incorporating and setting as the minimum standards to follow when compounding sterile products, the following chapters of the United States Pharmacopeia: 797; 1160; 71; 85; 731; and 1231.

SUMMARY: The following chapters of the United States Pharmacopeia will be incorporated into the rule as the minimum standards to follow when compounding sterile products: 797; 1160; 71; 85; 731; and 1231.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: During discussion of the economic impact of this rule at its Board meeting, the Board, based upon the expertise and experience of its members, determined that a Statement of Estimated Regulatory Costs (SERC) was not necessary and that the rule will not require ratification by the Legislature. Specifically, the Board considered that 21 U.S.C. §353a, as amended by Public Law Number 113-54 (November 27, 2013), requires compounding to comply with the applicable chapters of the United States Pharmacopeia (USP) on compounding. Therefore, any economic impact is a direct result of federal mandates. Further, the Board considered that all institutional pharmacies are already mandated to comply with the compounding provisions that are being incorporated. Finally, the Board considered that since approximately 2008, Board rule requirements essentially required compliance with the provisions of the USP which are being incorporated. The Board considered that having to come into compliance with laws and rules that are already effective is not an economic impact that is applicable for consideration for this proposed rule amendment. No person or interested party submitted additional information regarding the economic impact at that time.

#### THE FULL TEXT OF THE PROPOSED RULE IS:

(Substantial rewording of Rule 64B16-27.797 follows. See Florida Administrative Code for present text.)

64B16-27.797 <u>The Standards of Practice for Compounding Sterile Products Preparations (CSPs)</u>.

The purpose of this section is to assure positive patient outcomes through the provision of standards for 1) pharmaceutical care; 2) the preparation, labeling, and distribution of sterile pharmaceuticals by pharmacies, pursuant to or in anticipation of a prescription drug order; and 3) product quality and characteristics. These standards are intended to apply to all sterile pharmaceuticals, notwithstanding the location of the patient (e.g., home, hospital, nursing home, hospice, doctor's office, or ambulatory infusion center).

- (1) Adoption of the United States Pharmacopiea: Beginning on October 1, 2014, all sterile compounding shall be performed in accordance with the minimum practice and quality standards of the following chapters of the United States Pharmacopeia (USP):
- (a) Chapter 797, Pharmaceutical Compounding-Sterile Preparations;
- (b) Chapter 1160, Pharmaceutical Calculations in Prescription Compounding;
  - (c) Chapter 71, Sterility Tests;
  - (d) Chapter 85, Bacterial Endotoxins Test;
  - (e) Chapter 731, Loss on Drying; and
  - (f) Chapter 1231, Water for Pharmaceutical Purposes.

All referenced chapters of the USP, in subsection (1) are specifically referring to the United States Pharmacopeia, 36th revision, Second Supplement, which is hereby incorporated and adopted by reference with the effective chapter dates of December 1, 2013. A copy of the USP chapters referenced in this rule may be examined and inspected, but not copied, at the office of the Board of Pharmacy in Tallahassee, Florida. A subscription to all relevant chapters is available for purchase at www.uspnf.com.

(2) Minimum Standards: The minimum practice and quality standards of the USP are adopted as the minimum standards to be followed when sterile products are compounded. However, nothing in this rule shall be construed

to prevent the compounding of sterile products in accordance with standards that exceed the USP.

- (3) Current Good Manufacturing Practices: The Board deems that this rule is complied with for any sterile products that are compounded in strict accordance with Federal Current Good Manufacturing Practices per 21 C.F.R. §§ 210.1 211.3.
  - (4) Specific Exceptions to the United States Pharmacopeia:
- (a) Although the USP requires the donning of gloves prior to entry into the clean-room, all required donning of gloves can be performed after entry into the clean-room to avoid contamination of the gloves from the door handle or access device leading into the clean-room.
- (b) USP Chapter 797 requires that: "When closed-system vial-transfer devices (CSTDs) (i.e., vial-transfer systems that allow no venting or exposure of hazardous substance to the environment) are used, they shall be used within an ISO Class 5 (see *Table* 1) environment of a BSC or CACI. The use of the CSTD is preferred because of their inherent closed system process. In facilities that prepare a low volume of hazardous drugs, the use of two tiers of containment (e.g., CSTD within a BSC or CACI that is located in a non-negative pressure room) is acceptable." For purpose of said provision, a "low volume of hazardous drugs" is defined as less than 40 doses per month.
- (5) Additional Exceptions: The Board encourages the use of a Petition for Rulemaking to inform the Board of a request to add an additional exception to subsection (5) of this rule. A Petition for Rulemaking is controlled by Section 120.54(7) of the Florida Statutes.
- (6) Rule Conflicts: On October 1, 2014 this rule shall control notwithstanding any rule to the contrary located throughout the provision of Chapter 64B16, F.A.C. Upon the effective date of this rule, the board will begin the process of repealing all rules that conflict with this rule.

PURPOSE AND EFFECT: The proposed rulemaking amends Rule 69L-5.209, F.A.C., deleting references to a Current or Former Self-Insurer's Net Worth requirements, with regards to Financial Statements Reporting requirements; the proposed rule is renumbered, accordingly. Proposed Rule 69L-5.225, F.A.C., is amended to provide guidance to Current and Former Self-Insured entities regarding purpose-specific distinctions in methodologies used when determining a self-insured's Net Worth. Proposed Rule 69L-5.219, F.A.C., is amended to increase a self-insurer's maximum per occurrence retention from the greater of \$500,000 or 1% of the self-insurer's net worth to the greater of \$600,000 or 1.5% of the self-insurer's Net Worth, and to clarify factors that the Department must consider when reviewing a Current Self-Insurer's request for a higher self-insured retention. The aforementioned changes are made to reflect inflation in the costs of claims and to provide self-insurers with a measure of control over premium costs for excess insurance. Proposed Rule 69L-5.215, F.A.C., is amended to delete erroneous references to Rule 69L-5.209, F.A.C., and to make certain technical changes.

SUMMARY: The proposed rulemaking provides guidance to current, former and prospective self-insurers regarding allowable, purpose-specific methods for use when determining a self-insured's Net Worth. The proposed rulemaking also provides for an increase in the maximum dollar-amount (and, in the alternative an increase in the percentage-amount of a self-insured's net worth) of a self-insured's per occurrence retention rate. The proposed increase in the maximum amount of the per occurrence retention rate provides self-insurers with a measure of flexibility in controlling the costs of excess insurance.

Current Self-Insurers and Former Self-Insurers, other than Governmental Entities, shall submit their Financial Statements no later than 120 days after the end of their fiscal year. Failure to submit the required Financial Statements shall constitute good cause for revocation of the self-insurance authorization in addition to civil penalties specified in Rule 69L-5.217, F.A.C.

- (1) The Financial Statements shall meet the following requirements:
  - (a) through (b) No change.
- (c) The Financial Statements shall show a Net Worth of the greater of \$10,000,000 U.S. or three (3) times Standard Premium, and;
- (c)(d) The Financial Statements shall be audited in accordance with Generally Accepted Auditing Standards.
- (d)(e) Financial statements submitted for Current Self Insurers and Former Self Insurers under an authorization granted prior to January 1, 1997, are not required to be audited in accordance with Generally Accepted Auditing Standards.
- (2) All legal entities included under the self-insurance authorization shall submit Financial Statements in accordance with this rule. Separate Financial Statements shall be submitted for each entity unless consolidated or combined Financial Statements are submitted. All Financial Statements submitted must comply with the provisions of this rule. However, for purposes of meeting the Net Worth requirement, the Net Worths of the companies comprising an Affiliated Self Insurer may be combined.
- (3) through (6) No change. Rulemaking Authority 440.38(1), (2), (3), 440.385(6), 440.525(2), 440.591 FS. Law Implemented 440.38(1), (2), (3), 440.385(1), (3), (6), 440.525 FS. History–New 3-9-10, Amended

- (4) The Net Worth of the parent company shall be used to apply the Net Worth requirements in <u>subsection</u> subparagraph 69L 5.209(1)(a)3. and paragraph 69L-5.225(1)(a), F.A.C., and
- (5) through (6) No change.

#### 69L-5.219 Excess Insurance.

(1) Current Self-Insurers, other than Governmental Entities, shall maintain a Specific Excess Insurance Policy. Such policy shall have a workers' compensation limit of not less than \$50,000,000.

- (a) The self-insured retention of Specific Excess Insurance Policies shall be as follows:
- 1. The self-insurer's per occurrence retention shall be no more than \$600,000500,000 or 1.5 4% of the self-insurer's Net Worth as shown on the self-insurer's latest audited Financial Statements, whichever is greater. The self-insured retention shall be rounded to the nearest \$50,000.
- 2. A higher self-insured retention shall be allowed, if approved by the Department. The Department shall consider the Current Self-Insurer's financial strength, including but not limited to its Net Worth, and its Net Worth in relation to the requested self-insured retention, in its review of the requested self-insured retention.

  - (2) through (4) No change.

PURPOSE AND EFFECT: The purpose and effect will be to implement changes in the rules listed above to implement the amended provisions of Section 849.086, Florida Statutes. The changes are required by Section 24 of Chapter 2009-170, Laws of Florida, amending Section 849.086, F.S., which amendment by reason of Section 5, Chapter 2010-29, was made effective July 1, 2010. Rules will also be updated and clarified to implement other provisions of Section 849.086, Florida Statutes.

SUMMARY: The amendments to Section 849.086, Florida Statutes, contained in Chapter 2009-170, Laws of Florida, will increase the operating hours of licensed cardrooms at parimutuel wagering facilities and significantly increase the amounts wagered on poker and dominoes conducted at those facilities. 11B-21.0051 Criminal Justice Training School Satellite Facilities and Equipment Requirements

NOTICE IS HEREBY GIVEN that on March 10, 2014, Criminal Justice Standards and Training received a petition for an emergency temporary rule waiver of paragraph 11B-21.0051(2)(d), F.A.C., by the Citrus County Public Safety Training Center. Petitioner wishes to waive that portion of the rule that requires an entity wishing to conduct training at a satellite facility to obtain the approval of the affected Regional Training Council and local training school before delivery of

the training at the satellite site outside of the entity's service area. Petitioner states that the local training school did not approve of its application. Petitioner further asserts that the application of the rule in its case will cause it undue hardship by forcing it to forego the possibility of training much-needed correctional officers. The Petitioner further alleges an economic hardship that will be compounded if the waiver is not granted.
