Reporting, Compliance, and Enforcement 62-600.740 PURPOSE AND EFFECT: The Department of Environmental Protection (DEP) gives notice that it is amending Chapter 62-600, F.A.C., to update, clarify, and eliminate redundancy in requirements applicable to domestic wastewater facilities. Rules will be revised to simplify and clarify requirements, correct rule references, and to be made consistent with more recently adopted rules and statutory requirements. Rules will be repealed where requirements are obsolete, duplicative of other rules or statutory requirements, or have been superseded by other rules or statutory requirements. As part of this rulemaking effort, some requirements from Chapter 62-601, F.A.C., Domestic Wastewater Treatment Plant Monitoring, will be incorporated into Chapter 62-600, F.A.C. Chapter 62-601, F.A.C., will then be repealed simultaneously with the rulemaking to adopt the amendments to Chapter 62-600, F.A.C. SUBJECT AREA TO BE ADDRESSED: Chapter 62-600, F.A.C., will be revised in order to simplify design, operation, monitoring, and reporting requirements applicable to domestic wastewater facilities. Domestic wastewater facility requirements are being revised to clarify reliability design requirements, applicability of specific operation and maintenance requirements, innovative and alternative treatment process requirements, sampling methodology, sinkhole reporting requirements, permit monitoring effective date, flow recording device calibration requirements, procedures for electronic submittal of monitoring results, and minimum ground water monitoring requirements. Requirements are also being updated to be consistent with other DEP rules, including Chapters 62-520, 62-528, 62-610, and 62-640, Florida Department of Health Chapter 64-E-6, F.A.C., and ocean outfall legislation adopted in Section 403.086(9), F.S. Domestic wastewater facility requirements are being revised to eliminate obsolete and redundant requirements, including requirements for obtaining construction permits, exemptions from state water quality criteria no longer in use, test methods approved specifically for domestic wastewater facilities, requirements redundant to or superseded by Chapters 62-4, 62-610, 62-620, and 62-650, F.A.C. DEP is also soliciting other suggestions for clarifying, streamlining, reducing costs, or other items that may be beneficial to domestic wastewater management.

The Agency proposes to amend Rule 59A-17.102, F.A.C., to conform the rule to the licensing requirements in Chapter 408, Part II, F.S., and correct technical errors. Rule 59A-17.119, F.A.C., is amended to include physical plant standards for TLFs, as required by statute.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has been prepared by the Agency.

Based on this information at the time of analysis and pursuant to Section 120.541, F.S., the rules will not require legislative ratification.

Statement of estimated regulatory costs has been prepared for proposed Rule 59A-17.102, F.A.C., and is available from the person to be contacted regarding this rule listed below. The following is a summary of the SERC:

For proposed rule subsection 59A-17.102(1), F.A.C., license fees are increased by the Consumer Price Index pursuant to Section 408.805(2), F.S. An application for a license with said fee shall also be filed in any of the following situations:

- (a) Renewal of license at least 90 days prior to expiration;
- (b) Initial licensure of a new owner or of an entity to which ownership of a facility is transferred.
- (2) The license shall be returned to the Agency for Health Care Administration within ten days when there is a change of ownership, revocation, or voluntary cessation.
- (3) Facilities which change location or number of beds shall notify the agency 60 days prior to the change.
- (2)(4) Prior to issuance of the initial license for a transitional living facility, the Agency for Health Care Administration shall receive notification from the Brain and Spinal Cord Injury Program with the Department of Health Division of Vocational Rehabilitation that the facility meets the service requirements adopted by the Division as required in Section 400.805(2)(c) Chapter 413.49(6), Florida Statutes.
- (5) When the name of the facility is changed, a letter giving the old and new names shall be sent to the Agency for Health Care Administration notifying the agency of the name change. 12D-7.0143 Additional Homestead <u>Exemptions</u> <u>Exemption Up To \$50,000</u> for Persons 65 and Older Whose Household Income Does Not Exceed \$20,000 Per Year.

- (1)(a) The Florida Constitution and Section 196.075, F.S., authorize counties and municipalities to grant by local ordinance two separate additional exemptions for qualified persons who are 65 years of age and older and who meet the household adjusted gross income requirements of Section 196.075, F.S.
- 1. Paragraph 196.075(2)(a), F.S., authorizes an additional exemption of up to \$50,000 for persons who meet the requirements of this law.
- 2. Paragraph 196.075(2)(b), F.S., authorizes an additional exemption of the assessed value of a homestead property with a just value of less than \$250,000 for persons who have maintained their permanent residence on this property for at least 25 years and who meet the requirements of this law.
- (b) The following procedures shall apply in counties and municipalities that have granted one or more an additional homestead exemptions exemption up to \$50,000 for persons 65 and older on January 1, whose household adjusted gross income for the prior year does not exceed \$20,000, adjusted beginning January 1, 2001, by the percentage change in the average costof-living index.
- (2) A taxpayer claiming either the additional exemption must is required to submit a sworn statement of adjusted gross income of the household (Form DR-501SC, Sworn Statement of Adjusted Gross Income of Household and Return, incorporated by reference in Rule 12D-16.002, F.A.C.) to the property appraiser by March 1, including comprising a confidential return of household income for the specified applicant and property. The sworn statement must be supported by copies of the following documents to be submitted for review inspection by the property appraiser:
- (a) Federal income tax returns for the prior year for each member of the household, which must shall include the federal income tax returns 1040, 1040A, and 1040EZ, if any; and
- (b) Any request for an extension of time to file federal income tax returns; and
- (c) Any wage earnings statements for each member of the household, which must shall include Forms W-2, RRB-1042S, SSA-1042S, 1099, 1099A, RRD-1099 and SSA-1099, if any.
- (3) Proof of age is shall be prima facie established for persons 65 and older by submitting submission of one of the following: certified copy of birth certificate; driver's drivers license or Florida identification card; passport; life insurance policy in effect for more than two years; marriage certificate; Permanent Resident Card (formerly known as Alien Registration Card); certified school records; or certified census record. If none of these forms of identification is submitted In the absence of one of these forms of identification, the property appraiser may rely on appropriate proof.

- (4)(a) When determining if the taxpayer has been a permanent resident of the property for 25 years or more, the property appraiser must consider that the residency requirement is met if the taxpayer has qualified and been receiving the homestead exemption on the property for 25 years or more.
- (b) If the taxpayer has not received the homestead exemption on the property for 25 years or more, but maintained permanent residency on the property, the property appraiser must look at other evidence, including but not limited to, evidence described in Section 196.015, F.S., to determine if the taxpayer has maintained their permanent residence on the property for the required period.
- (c) The taxpayer did not have to receive or qualify for the homestead exemption on the property during the entire period as long as they maintained it as their permanent residence.
- (d) If the taxpayer was not the owner of the property but maintained permanent residency on the property for at least 25 years and currently has legal and equitable title, the taxpayer qualifies for the additional homestead exemption.
- (5) Unless requested by the property appraiser, supporting Supporting documentation does not have is not required to be submitted with the sworn statement for renewal of an the exemption, unless requested by the property appraiser.
- (6)(5) The property appraiser may not grant or renew an the exemption if the required documentation is not provided including what is requested by the property appraiser is not provided.

12D-9.020 Exchange of Evidence.

(1) Section 194.011(4)(a), F.S., provides that at least 15 days before the hearing, the petitioner shall provide the property appraiser with a list and summary of evidence, accompanied by copies of documentation, to be presented at the hearing. If the petitioner does not provide this information, the property appraiser shall not be required under Section 194.011(4)(b), F.S., to provide the petitioner with the property appraiser's evidence before the hearing; but a petitioner's noncompliance with this statute does not authorize a value adjustment board or magistrate to exclude the petitioner's evidence. The petitioner has the option of participating in an exchange of evidence with the property appraiser. If the petitioner chooses not to participate in the evidence exchange, the petitioner may still present evidence for consideration by the board or the special magistrate. However, as described in this section, if the property appraiser asks in writing for specific evidence before the hearing in connection with a filed petition, and the petitioner has this evidence and knowingly refuses to provide it to the property appraiser a reasonable time before the hearing, the evidence cannot be presented by the petitioner or accepted for consideration by the board or special Reasonableness shall be determined by whether the material can be reviewed, investigated, and responded to or rebutted in the time frame remaining before the hearing. These requirements are more specifically described in subsection (8) of this rule and in paragraphs Rule 12D-9.025(4)(a) and (f), F.A.C.

(2)(a) If the petitioner chooses to participate in an exchange of evidence with the property appraiser, at least fifteen (15) days before the hearing, the petitioner shall provide the property appraiser with a list and summary of evidence to be presented at the hearing accompanied by copies of documentation to be presented at the hearing. To calculate the fifteen (15) days, the petitioner shall use calendar days and shall not include the day of the hearing in the calculation, and shall count backwards from the day of the hearing.

(b) When a petitioner If the petitioner chooses to participate in an exchange of evidence with the property appraiser and he or she shows good cause to the board clerk for not being able to meet the fifteen (15) day requirement and the property appraiser is unwilling to agree to a different timing of the exchange, the board clerk is authorized to reschedule the hearing to allow for the exchange of evidence to occur.

(c) No later than seven (7) days before the hearing, if the property appraiser receives the petitioner's documentation and if requested in writing by the petitioner, the property appraiser shall provide the petitioner with a list and summary of evidence to be presented at the hearing accompanied by copies of documentation to be presented by the property appraiser at the hearing. There is no specific form or format required for the petitioner's written request for a list of evidence with copies of all documents and a summary of the evidence to be presented by witnesses. The evidence list must contain the property record card if requested provided by the board clerk. To calculate the seven (7) days, the property appraiser shall use calendar days and shall not include the day of the hearing in the calculation, and shall count backwards from the day of the hearing.
