6A-6.0573 Industry Certification Process.

PURPOSE AND EFFECT: The purpose of this rule revision is to amend the rule to adopt updated funding weights for industry certifications on the 2013-14 Industry Certification Funding List. The effect of this amendment is to ensure that appropriate weights, in accordance with the provisions of Section 1011.62(1)(o), F.S., are included on the Industry Certification Funding List.

SUMMARY: The amendment includes revisions to the 2013-14 Industry Certification Funding List which is incorporated by reference. The State Board of Education is adopting new articulation agreements in Rule 6A-10.0401, F.A.C., and the addition of these agreements impacts the funding weight that should be assigned to the industry certification, as specified in Section 1011.62(1)(o), F.S. This statute specifies that a value of 0.2 full-time equivalent membership shall be calculated for each student who is issued an industry certification that has a statewide articulation agreement for college credit approved by the State Board of Education. The 2013-14 Industry Certification Funding List is updated to change the funding weight from 0.1 to 0.2 for six certifications for which the State Board of Education is adopting articulation agreements for college credit.

PURPOSE AND EFFECT: The purpose of this amendment is to incorporate by reference the updated Gold Standard Career Pathways Statewide Articulation Agreements. Gold Standard Career Pathways Articulation Agreements are based on industry certifications and guarantee individuals who have earned the industry certification specified in the agreement and enrolled in the specified associate degree program at a Florida College System (FCS) institution will be awarded college credit as indicated in the agreement.

SUMMARY: Gold Standard Career Pathways Articulation Agreements are developed periodically through a consensus process with the FCS institutions and are based on industry certifications on the Department of Education's "Industry Certification Funding List." Six new articulation agreements have recently been developed and approved by the FCS institutions and the Articulation Coordinating Committee. Approved by the State Board of Education, the Gold Standard

Career Pathways Articulation Agreements continue to provide guaranteed college credit for students who have earned the industry certification specified in the agreement and enrolled in the specified associate degree program. This is a saving of tuition costs for the students and eliminates the need to repeat coursework mastered as evidenced by passage of a third party examination leading to the award of an industry certification.

PURPOSE AND EFFECT: The purpose of this rule amendment is to revise the postsecondary course equivalency to the competencies contained in two credits of secondary foreign language. The effect changes the equivalency from 8-10 semester credits to completion of a postsecondary course at the elementary 2 level and authorize the Florida College System (FCS) institution to establish other mechanisms to determine completion.

SUMMARY: The rule updates community colleges to FCS institutions. It changes the requirement in one foreign language from 8-10 semester credits to competence at the elementary 2 level. It removes the language regarding the use of the College Level Examination Program in favor of the award of credit pursuant to Section 1007.27(3), Florida Statutes. It removes an outdated MAPS Latin exam. The rule authorizes FCS institutions to use other mechanisms to indicate competence in one foreign language.

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.
