This clarification will also be made in the corresponding instructions to DEP Form No. 62-210.900(5) Annual Operating Report for Air Pollutant Emitting Facility [Including Title V Source Emissions Fee Calculation]. Several non-substantive changes will also be made to DEP Form No. 62-210.900(5).
