RULE NO.: RULE TITLE:

40D-8.624 Guidance and Minimum Levels for Lakes PURPOSE AND EFFECT: The purpose of this rulemaking is to adopt revised minimum and guidance levels for Lakes Bird, Crystal and Hobbs located in Hillsborough County. The effect of the rule is to support the District's water supply planning, water use permitting, and environmental resource permitting programs.

SUMMARY: Section 373.042, F.S., requires the District to establish minimum flows and levels for water bodies located within the District's boundaries. Section 373.0421(3), F.S., further requires the District to periodically reevaluate and revise adopted minimum flows and levels. This rulemaking will revise the minimum levels for Lakes Bird, Crystal and Hobbs, which are located within the Hillsborough River

Groundwater Basin and hydrologically connected to the Upper Floridan aquifer ground water system. In addition, flow from these lakes contribute to the surface water flow of major tributaries to the Hillsborough River. The establishment and periodic evaluation of minimum levels is required by statute to ensure that the minimum hydrologic requirements of the water resources and ecology of these lakes and the Hillsborough River are maintained. The revised minimum and guidance levels for Lakes Bird, Crystal and Hobbs have been developed using previously peer-reviewed, Governing Board adopted methods.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION: The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: The District conducted an economic review of the revisions to the rule and determined that the impact or regulatory cost, if any, of the revisions will not exceed any one of the economic analysis criteria in a SERC as set forth in Section 120.541(2)(a), F.S. The revised minimum levels for this lake is unlikely to constitute an additional significant regulatory constraint on groundwater or surface water withdrawals in the area due to existing resource conditions and regulatory constraints in the basin.

The South Florida Water Management District hereby gives notice that on May 6, 2015, the Executive Director of the South Florida Water Management District (SFWMD or District) issued an Order Granting Variance under Section 120.542, Florida Statutes, (SFWMD 2015-025-DAO-ERP) to the Florida Department of Transportation – District IV (FDOT), concerning a project known as the I-95/I-595 Interchange Wet Armoring, located in Broward County, Florida, near the Fort Lauderdale-Hollywood International Airport; Section 21, Township 50 South, Range 42 East. The Petition for Variance (Application No. 150305-18) was

received by the SFWMD on March 5, 2015. Notice of receipt of the Petition was published in the Florida Administrative Register, Vol. 41, Number 50, on March 13, 2015. No public comment was received. This Order provides a variance for the proposed modification of previously constructed and permitted wet ponds within the I-95/I-595 Interchange area. The particular criterion from which the variance is sought is found at Section 5.4.2(d) of the South Florida Water Management District Environmental Resource Permit Applicant's Handbook Volume II, effective August 10, 2014, which is incorporated by reference in paragraph 40E-4.091(1)(a) and Chapter 62-330, F.A.C., pertaining to degree of side slopes acceptable for wet retention/detention and attenuation areas. This criterion provides, in general, that for purposes of public safety, water quality enhancement, and maintenance, all wet retention/detention areas shall be designed with side slopes no steeper than (horizontal:vertical) from top of bank out to a minimum depth of two feet below the control elevation, or an equivalent substitute. The Order sets forth the basis of the SFWMD decision to grant the variance, as follows: 1) the variance is necessary to prevent a substantial hardship on FDOT; and 2) the purpose of the underlying rule has been achieved by other means.

NOTICE IS HEREBY GIVEN that on April 15, 2015, the Dept. of Environmental Protection's Coastal Construction Control Line Program, received a petition for permanent variance from George and Cynthia Andrew seeking a variance from the rule provisions of subsection 62B-33.002(18), F.A.C., which defines "Eligible Structures"; subsection 62B-33.002(43), F.A.C., which defines "Nonconforming Structures"; and subparagraph 62B-33.0051(1)(a)1, F.A.C., which states that "[c]onstruction of armoring shall be authorized under the following conditions: 1. The Petitioners seek a variance to construct a coastal armoring structure to protect their conforming home from additional erosion, and prevent pollution to the state waters as the home's sewer and water connection is located under the slab and is in imminent danger as a result of recent coastal storms in St. John's County. Additionally, an LP tank to service various gas appliances is buried along the north side of the dwelling in line with the seaward edge of the property. The proposed activities associated with the variance are located at 4588 Coastal Highway, St. Augustine, Florida. The petition has been assigned CCCL File # SJ-1217 AR V and OGC File #15-0294. No permit application has been submitted.
