 - (e) An employee from a major institution.

(3)(4) An <u>I</u>institutional <u>Eemployee Bbenefit Ttrust Ffund Team</u> appointed by the warden will be established at each institution. <u>Each This Institutional Team</u> will make recommendations to the <u>Central Office Team</u> for employee benefit projects, make recommendations and for the number and location of vending machines and canteens. <u>Fach Institutional Team shall also</u>, as to its institution, review canteen operations, establish inventory levels, and develop a methodology to establish pricing. <u>Each Institutional The Team shall be made up of the following staff members:</u>
