(1) The minimum qualifying criteria for Special Inspectors of Threshold Buildings, also referred to as Threshold Inspectors, established by the Board shall be as follows:

(a) No change

(b) Licensed professional engineers whose principal practice is structural engineering shall also have three (3) years of experience in performing structural field inspections on threshold buildings and two (2) years of experience in the structural design of threshold buildings after having achieved licensure as a professional engineer. ~~Such experience shall be within the seven (7) years preceding submission of the application.~~ For the purpose of these criteria, structural design shall mean the design of all structural components of the building and shall not be limited to specific structural components only, such as foundations, prestressed or post-tensioned concrete, etc.

These security measures shall: protect the learner's identity and the course and related content from unauthorized access; and include that only the attendee's registered computer is used for the course.

(d) Providers must include the course instructors' curriculum vitae or resume for each portion of the program.

(e) Providers must explain the appropriate level of technology required for the licensee to participate in the course.

(f) Providers must have technical assistance available as appropriate to the course format.

(g) Providers shall establish a deadline for course completion.

(h) Providers shall notify the program attendees when he or she is leaving a continuing education site and is being directed to a promotional or sponsored site.

(13) RELICENSURE RELATED TO CHANGE OF OWNERSHIP.

(a) This subsection implements the requirement for relicensure of certain specified categories of licensees upon a change of ownership of the licensee, as specified in the following provisions of Chapter 497:

1. Funeral establishments, section 497.380(12)(a);
2. Removal services, section 497.385(1)(g);
3. Refrigeration services, section 497.385(1)(g);
4. Centralized embalming facilities, section 497.385(2)(g);
5. Monument establishments, section 497.553(6)(a).

(b) For the purposes of the above identified license categories, a change of ownership occurs whenever a person or entity acquires an ownership interest of greater than 50% in the licensee or in a legal entity that directly or through subsidiaries owns the licensee, which person or entity did not previously have such an ownership interest of greater than 50%. Provided, in the case of a licensee owned by a corporation, LLC, or other legal entity that is part of a group of legal entities under common control, and the ultimate parent entity restructures the group, if the licensee’s ultimate parent entity remains unchanged, there is no change of ownership, but a change of licensee name shall be filed with the Division, with the appropriate fee for issuance of a revised license certificate to reflect the different legal entity holding the license.

(c) A relicensure required under the statutes cited in this subsection shall be accomplished by filing the same form or forms as required for initial licensure, but noting on the application for license that the application relates to a change of ownership.
