**SUMMARY:** The proposed amendments to this rule update language to align the pediatric age requirement with Medicaid definitions for designated pediatric transplant programs and remove an outdated grandfathering provision.

~~for patients under the age of 21. In case of conflict between provisions in this rule, the provisions of this subsection shall prevail. Any health care facility which operated an organ transplantation program as of October 1, 1987, shall be given a reasonable time, not to exceed 1 year from the effective date of this rule, within which to comply with these rule standards. Health care facilities to be included under this provision shall include any health care facilities which performed one or more transplants prior to October 1, 1987, or facilities which provide documentation to the Agency which shall include but not be limited to:~~

~~(a) A written implementation plan for the establishment of specific organ transplantation services which was approved by the hospital board of trustees or other duly designated authority prior to October 1, 1987, the effective date of the Health Facility and Services Development Act;~~

(1) The list of Drugs/Substances and associated Trade Names, Drug Class, and Penalty Class contained in the “Alphabetical Substance List” in the Uniform Classification Guidelines for Foreign Substances, Version 8.0, revised December 2014, by the Association of Racing Commissioners International, Inc., is hereby incorporated by reference. (2) The penalty for a violation of Section 550.2415, Florida Statutes, for impermissibly medicating a racing horse, or the finding of a prohibited substance in a racing horse, shall be based on the following penalty schedule and consideration of, if any, mitigating or aggravating factors:

<u>(a) Penalty Class A substances:</u>	
<u>1. First violation</u>	<u>Suspension – Minimum of one-year absent mitigating factors, maximum of three-years based on aggravating factors;</u> <u>and</u> <u>Fine – Minimum of \$10,000 or 10% of the total</u>

	<p>purse, whichever is greater, absent mitigating factors. The presence of aggravating factors may be used to impose a maximum fine of 25% of the total purse.</p>
2. Second violation	<p>Suspension – Minimum of three-years absent mitigating factors, maximum of license revocation and ineligibility to reapply for a three-year period based on aggravating factors; and                  Fine – Minimum of \$10,000 or 25% of the total purse, whichever is greater, absent mitigating factors. The presence of aggravating factors may be used to impose a maximum fine of 50% of the total purse.</p>
3. Third or subsequent violation	<p>Suspension – Minimum of five-years absent mitigating factors, maximum of license revocation and ineligibility to reapply for a five-year period based on aggravating factors; and                  Fine – Minimum of \$10,000 or 50% of total purse, whichever is greater, absent mitigating factors. The presence of aggravating factors may be used to impose a maximum fine of 100% of the total purse.</p>

(b) Penalty Class B substances, and for the presence of more than one NSAID if prohibited as provided in Rule 61D-6.008(3), Florida Administrative Code:	
1. First violation	<p>Suspension – Minimum of fifteen days absent mitigating factors,</p>

	<p>maximum of sixty days based on aggravating factors; and                  Fine – Minimum of \$500 absent mitigating factors. The presence of aggravating factors may be used to impose a maximum fine of \$1,000.</p>
2. Second violation	<p>Suspension – Minimum of thirty days absent mitigating factors, maximum of one hundred eighty days based on aggravating factors; and                  Fine – Minimum of \$1,000 absent mitigating factors. The presence of aggravating factors may be used to impose a maximum fine of \$2,500.</p>
3. Third or subsequent violation	<p>Suspension – Minimum of sixty days absent mitigating factors, maximum of one-year based on aggravating factors; and                  Fine – Minimum of \$2,500 absent mitigating factors. (b) The danger to the public and/or racing animals.

(c) The number and date of prior violations of any penalty class in Florida and any other jurisdiction.

(f)(e) The number of complaints filed against the licensee or permitholder, which have resulted in prior discipline.

An owner or trainer who fails to return the purse, prize, or award for redistribution within 60 days of the order is in violation of this rule and may be subject to further administrative action.
