PURPOSE AND EFFECT: To amend the rules to update and clarify water and wastewater utilities' requirements for responding to and keeping a record of customer complaints  
Docket No. 20170222-WS

SUMMARY: Rule 25-30.130, F.A.C. is being amended to require water and wastewater utilities to keep a record of all complaints received, to identify the information required to be in the record, to require the record to be maintained five years, and to require a utility to provide the record to the Commission upon Commission staff's request.

Rule 25-30.355, F.A.C. is being amended to clarify the definition of complaint, to specify a time frame for a utility to acknowledge and to respond to a customer complaint, to require a utility to specify in its acknowledgement whether any additional action will be taken on the customer's complaint, and to require each utility to have a procedure for receiving and responding to emergency calls 24 hours a day.

#### SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has been prepared by the Agency.

The SERC examined the factors required by Section 120.541(2), FS, and concluded that the rule amendment will not have an adverse impact on economic growth, business competitiveness, or small business.

25-30.130 Record of Complaints.

(1) Each utility shall maintain a record of all complaints each signed, written complaint received by the utility from any of that utility's customers.

(2) ~~Each~~ The record shall show include the name and address of the complainant; the nature of the complaint; the date received; the result of any the investigation; the disposition of the complaint; and the date of ~~the~~ disposition of the complaint. The word "complaint" as used in this rule is defined in subsection 25-30.355(2), F.A.C.

(2) Notwithstanding the requirements of paragraph 25-30.110(1)(a), F.A.C., utilities shall maintain a record of each complaint for a minimum of five years from the date of receipt and shall provide a copy of records of complaints to the Commission upon Commission staff's request. Documentation relating to customer complaints processed under Rule 25-22.032, F.A.C., shall be retained as set forth in paragraph 25-22.032(10)(a), F.A.C.

25-30.355 Complaints.

(1) A utility shall give a customer verbal or written acknowledgement of the utility's receipt of the customer's complaint no later than three business days after it receives the complaint. The utility shall specify in its acknowledgement whether any additional action will be taken on the issue(s) raised by the customer. A utility shall investigate the complaint and give the customer a verbal or written response no later than 15 days after it receives the complaint. make a full and prompt acknowledgement and investigation of all customer complaints and shall respond fully and promptly to all customer requests.

(2) ~~For the purpose of this rule~~ The word "complaint" as used in this rule means shall mean an objection made to the utility by a the customer by telephone call, by e-mail, by letter, or on the utility's website form as to the utility's charges, facilities or service; that where the disposal of the complaint requires action by on the part of the utility.

(3) Each utility shall have a procedure for receiving and responding to emergency calls 24 hours a day. Examples of emergencies shall include reports of water or wastewater main breaks or conditions caused by utility-owned facilities where property damage or personal injury is reasonably foreseeable. Replies to inquiries by the Commission's staff shall be furnished within fifteen (15) days from the date of the inquiry and shall be in writing, if requested.

PURPOSE AND EFFECT: This rule implements s. 381.986(8)(e)1., Florida Statutes, by establishing a procedure for the Florida Department of Health to process ownership transfer requests made by a medical marijuana treatment center.  
SUMMARY: Creates a process by which a medical marijuana treatment center may request approval to transfer ownership to a new entity or person.

64-4.018 Medical Marijuana Treatment Center Transfer of Ownership.

(1) A medical marijuana treatment center may request to transfer ownership of its license pursuant to section 381.986(8)(e), F.S.

(2) "Transfer of ownership" means the transfer of a medical marijuana treatment center license to a new entity or person.

(3) The addition or removal of an owner or a change in ownership shares that does not effectuate a transfer of license to a new entity or person is not a transfer of ownership, and such requests should be submitted to the department pursuant to Rule 64-4.023, F.A.C.

(4) In order to transfer ownership, the medical marijuana treatment center shall submit a request to the department using form DH8018-OMMU-5/2018, "Medical Marijuana Treatment Center Request for Transfer of Ownership," incorporated by reference and available at <https://www.flrules.org/Gateway/reference.asp?No=Ref-XXXXX>.

(5) A medical marijuana treatment center may not proceed with the transfer of ownership without department approval.

(6) If the department determines a medical marijuana treatment center has transferred ownership without approval, the medical marijuana treatment center's registration shall be suspended pending the submission of a request to transfer pursuant to this rule and department approval of the transfer of ownership.

(7) Upon approval of the transfer, the new owner (transferee) of the medical marijuana treatment center assumes responsibility and liability for any violations of statute or department rule by, and any regulatory obligations of, the previous owner (transferor). The transferee must operate the medical marijuana treatment center in accordance with the representations made in the initial application, and any approved variances, on file with the department at the time of the transfer. All proposed alternatives to the specific representations in the initial application must be submitted to the department in accordance with Rule 64-4.023, F.A.C.

(8) If the medical marijuana treatment center intends to claim any exemption from public records disclosure under section 119.07, F.S., or any other exemption from public records disclosure provided by law for any part of its transfer request, it shall indicate on the request the specific sections for which it claims an exemption and the statutory basis for the exemption. The requestor shall submit a redacted copy of the transfer request redacting those items identified as exempt concurrent with the submission of the transfer request for approval under subsection (4) above. Failure to provide a redacted copy of the transfer request at the time of submission or failure to identify and redact information claimed as trade secret will result in the release of all information in response to a public records request, unless the information falls under another public records exemption. All identified trade secrets are subject to review by the department in accordance with section 381.83, F.S.

(1) A medical marijuana treatment center may request a variance from the representations made in the initial application pursuant to section 381.986(8)(e), F.S.

(2) In order to obtain a variance from the representations made in the initial application, the medical marijuana treatment center shall submit a request to the department using Form DH8019-OMMU-05/2018 “Medical Marijuana Treatment Center Request for Application Variance,” incorporated by reference and available at <https://www.flrules.org/Gateway/reference.asp?No=Ref-XXXXX>.

(3) A medical marijuana treatment center may not proceed with a proposed alternative until receipt of approval from the department.

(4) If the department determines that a medical marijuana treatment center has proceeded with a proposed alternative, prior to receiving approval, the medical marijuana treatment center shall be subject to the penalties set forth in section 381.986(10)(f), F.S.

(5) If the medical marijuana treatment center intends to claim any exemption from public records disclosure under section 119.07, F.S., or any other exemption from public records disclosure provided by law for any part of its variance request, it shall indicate on the request the specific sections for which it claims an exemption and the statutory basis for the exemption. The requestor shall submit a redacted copy of the variance request redacting those items identified as exempt concurrent with the submission of the variance request for

approval under subsection (2) above. Failure to provide a redacted copy of the variance request at the time of submission, or failure to identify and redact information claimed as trade secret will result in the release of all information in response to a public records request unless the information falls under another public records exemption. All identified trade secrets are subject to the department review in accordance with section 381.83, F.S.
