(1) All applicants who have taken and failed the licensure examination for a standard certificate and who wish to apply for reexamination in that certificate category shall submit the following to the Department:

(1)(a) A completed application form for reexamination in the category in which certification is sought. The form that shall be used for this purpose shall be provided by the Department and available on the Department's website.

(2)(b) Those individuals who are not employed by a local government agency having responsibility for building code inspection, building construction regulation, and enforcement of building, plumbing, mechanical, electrical, gas, fire prevention, energy, accessibility, and other construction codes at the time of their application for reexamination shall submit payment of the applicable reexamination fees as specified in Chapter 61G19-10, F.A.C.

NOTICE OF CORRECTION

Notice is hereby given that the following correction has been made to the proposed rule in Vol. 45 No. 77, April 19, 2019 issue of the Florida Administrative Register.

When published, the notice of proposed rule omitted the description of the information expressly relied upon when addressing the SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION. In the summary, the Agency states that it has determined that this rule will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule and that a SERC has not been prepared by the agency. Furthermore, the Agency states that it has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein.

The proposed rule amendments will not have any adverse impact on small businesses to which the rule chapter is completely inapplicable; do not increase regulatory costs or negatively impact small counties or cities because they are for processes that are already mandated in law and regulation to provide Veterans' Preference for certain kinds of jobs and for Preference-Eligible persons who are request Veterans' Preference. The proposed amendments resulted from the informal discussions between the Veterans' Preference Coordinator and State and local government entities during training sessions, as well as discussions about Veterans' Preference complaints and investigation, and the suggestions led to language amendments to create better efficiencies and outcomes, and reduce costs and burdens, including time and money.

Due to this omission of description, any person who wishes to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower cost regulatory alternative must do so in writing within 21 days of this notice.

In addition, the text of 55A-7.013 Documentation of Preference Claim omitted the following description at the end of the rule language: "VP-1, VP-2, and VP-3 forms, referenced and incorporated in this rule, have not changed in any way. The links will become active once the rule is adopted and becomes effective."

This correction does not affect the substance of the rule as originally published. It is anticipated that the final rule amendments will be published during June 2019.

12BER19-02 Fuel Used for Agricultural Shipment or

Hurricane Debris Removal

SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE PUBLIC HEALTH, SAFETY OR WELFARE: Section 22, Chapter 2019-42, L.O.F., provides an exemption from tax on fuel purchased in this state between October 10, 2018 and June 30, 2019, which is used in this state for agricultural shipment or hurricane debris removal. The exemption is only available through a refund of tax paid. This requires the creation of a form to be used by taxpayers seeking a refund.

Section 22, Chapter 2019-42, L.O.F., authorizes the Department of Revenue, and all conditions are deemed met, to adopt emergency rules pursuant to s. 120.54(4), Florida Statutes, for the purpose of administering the refund provisions. Given the application period set out in the law, an emergency rule is the most appropriate and expedient means to provide taxpayers with the necessary refund application. This emergency rule incorporates, by reference, Form DR-26HF, Application for Refund – Fuel Used for Agricultural Shipments or Hurricane Debris Removal, effective May 2019.

REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES: The Legislature expressly authorized in Section 22, Chapter 2019-42, L.O.F., the promulgation of an emergency rule by the Department to

provide forms and instructions to seek a refund of tax paid on qualifying purchases. The promulgation of this emergency rule, incorporating by reference the form used to apply for the refund, ensures that the public is notified by the most appropriate and expedient means regarding the process to elect to use this reporting method.

SUMMARY: Emergency Rule 12BER19-02 incorporates, by reference, Form DR-26HF, Application for Refund – Fuel Used for Agricultural Shipments or Hurricane Debris Removal, to allow taxpayers to seek a refund of tax on qualifying purchases, as provided by law.

12BER19-02 Fuel Used for Agricultural Shipment or Hurricane Debris Removal

- (1) Definitions. For purpose of this rule, the following terms mean:
- (a) "Agricultural processing or storage facility" means property used or useful in separating, cleaning, processing, converting, packaging, handling, storing, and other activities necessary to prepare crops, livestock, related products, and other products of agriculture, and includes nonfarm facilities that produce agricultural products, in whole or in part, through natural processes, animal husbandry, and apiaries.
- (b) "Agricultural product" means the natural products of a farm, nursery, forest, grove, orchard, vineyard, garden, or apiary, including livestock as defined in s. 585.01(13), F.S.
- (c) "Agricultural shipment" means the transport of any agricultural product from a farm, nursery, forest, grove, orchard, vineyard, garden, or apiary located in Okaloosa, Walton, Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon, or Wakulla County to an agricultural processing or storage facility.
- (d) "Fuel" means motor fuel or diesel fuel, as those terms are defined in ss. 206.01 and 206.86, F.S., respectively.
- (e) "Fuel tax" means all state and county taxes authorized or imposed on fuel under chapter 206, F.S.
- (f) "Hurricane debris removal" means the transport of Hurricane Michael debris from a farm, nursery, forest, grove, orchard, vineyard, or apiary located in Okaloosa, Walton, Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Gadsden, Liberty, Franklin, Leon or Wakulla County.
- (g) "Motor vehicle" and "public highways" have the same meanings as provided in s. 206.01, F.S.

(2)(a) Fuel purchased and used in this state during the period from October 10, 2018, through June 30, 2019, which is or was used in any motor vehicle driven or operated upon the public highways of this state for agricultural shipment or hurricane debris removal, is exempt from all state and county taxes authorized or imposed under parts I and II of chapter 206, F.S., excluding the taxes imposed under s. 206.41(1)(a) and (h), F.S.

(b) The exemption provided by this section is available to the fuel purchaser in an amount equal to the fuel tax imposed on fuel that was purchased for agricultural shipment or hurricane debris removal during the period from October 10, 2018, through June 30, 2019. The exemption provided by this section is only available through a refund from the Department of Revenue.

(3) Application for Refund.

(a) To receive a refund, the fuel purchaser must submit Form DR-26HF, Application for Refund - Fuel Used for Agricultural Shipments or Hurricane Debris Removal, effective June 2019 (hereby incorporated by reference).

(b) Fuel purchasers must apply for a refund by December 31, 2019.

(c) Form DR-26HF is available, without cost, by one or more of the following methods: 1) downloading the form from the Department's website at www.floridarevenue.com/forms; or, 2) calling the Department at 850-488-6800 Monday through Friday (excluding holidays); or, 3) visiting any local Department of Revenue Service Center or, 4) writing the Florida Department of Revenue, Taxpayer Services, Mail Stop 3-2000, 5050 West Tennessee Street, Tallahassee, Florida 32399-0112. Persons with hearing or speech impairments may call the Florida Relay Service at 1-800-955-8770 (Voice) and 1-800-955-8771 (TTY).

SUMMARY: This emergency rule describes Game Number 1427, "\$2,000,000 CASHWORD," for which the Department of the Lottery will start selling tickets on a date to be determined by the Secretary of the Department. The rule sets forth the

specifics of the game; determination of prizewinners; estimated odds of winning, value, and number of prizes in the game.

<u>53ER19-40 Game Number 1427, \$2,000,000</u> CASHWORD.

(1) Name of Game. Game Number 1427, "\$2,000,000 CASHWORD."

(2) Game Number 1427, \$2,000,000 CASHWORD, is a Scratch-Off lottery game (also known as an instant lottery game).

(3) Price. \$2,000,000 CASHWORD lottery tickets sell for \$10.00 per ticket.

(4) "\$2,000,000 CASHWORD" lottery tickets shall have a series of numbers in Machine Readable Code (or bar code) on the back of the ticket, along with a Void If Removed Number under the latex area on the ticket. To be a valid winning \$2,000,000 CASHWORD lottery ticket, the ticket must meet the applicable requirements of Rule 53ER15-31, Florida Administrative Code.

(5) The "YOUR LETTERS" play symbols are as follows:

A B C D E F G H I J K L M N O P Q R S T U V W X Y Z

(6) The CROSSWORD PUZZLE play symbols for GAME 1, GAME 2 and GAME 3 are as follows:

(7) The "CASHWORD BONUS" play symbols are as follows:

- (10) The prizes in GAME 1 and GAME 2 are: \$10, \$20, \$500, and \$10,000.
- (11) The prizes in GAME 3 are: \$10, \$20, \$50, \$100, \$200, \$500, \$1,000, \$10,000, \$100,000 and \$2,000,000.
 - (12) Determination of Prizewinners.
- (a) There are three (3) games on a ticket. Each game is played independently. Words in one game cannot be used in the other game. Players may win in one or more games.
- 1. GAME 1. The holder of a ticket whose play symbols in the "YOUR LETTERS" play area match the play symbols in the CROSSWORD PUZZLE of GAME 1 to form at least three (3) different complete words that satisfy the requirements set forth is paragraph (12)(c) shall entitle the prizewinner to the corresponding prize in the "GAME 1 and 2 PRIZE LEGEND" for the total number of words matched.
- 2. GAME 2. The holder of a ticket whose play symbols in the "YOUR LETTERS" play area match the play symbols in the CROSSWORD PUZZLE of GAME 2 to form at least three (3) different complete words that satisfy the requirements set forth is paragraph (12)(c) shall entitle the prizewinner to the corresponding prize in the "GAME 1 and 2 PRIZE LEGEND" for the total number of words matched.
- 3. GAME 3. The holder of a ticket whose play symbols in the "YOUR LETTERS" play area match the play symbols in the CROSSWORD PUZZLE of GAME 3 to form at least three (3) different complete words that satisfy the requirements set forth is paragraph (12)(c) shall entitle the prizewinner to the corresponding prize in the "GAME 3 PRIZE LEGEND" for the total number of words matched.
- (b) CASHWORD BONUS. The holder of a ticket whose letters (play symbols) in the "YOUR LETTERS" play area completely match the play symbols in the "CASHWORD BONUS" play area shall entitle the prizewinner to the corresponding prize shown in the "PRIZE" box. The CASHWORD BONUS is played independently and cannot be used in other games.
- (c) A "word" must contain at least three (3) letters. A "word" cannot be formed by linking letters diagonally or by reading the letters from the bottom to top or right to left. Letters combined to form a "word" must appear in an unbroken horizontal or vertical string of letters in the CROSSWORD PUZZLE that is not interrupted by a blank space and contains every single letter square between two blank spaces or an edge and a blank space. Every letter in the unbroken string must be revealed in "YOUR LETTERS" and be included to form a "word." The possible complete words are shown in each CROSSWORD PUZZLE. Each possible complete word space. All of the letters in a possible complete word must be matched in order to complete the word.
 - (13) \$2,000,000 Top Prize Payment Options.

- (a) A winner of a \$2,000,000 top prize may choose one of two payment options for receiving his or her prize. Payment options are "Cash Option" or "Annual Payment." At the time the \$2,000,000 top prize is claimed, the terminal will produce a player claim instructions ticket. The winner has sixty (60) days after the date the player claim instructions ticket is produced to file a claim choosing the Cash Option. Once the winner files a claim and exercises the winner's chosen option, the election of that option shall be final. The Annual Payment method of payment will also be final when it is applied due to a top prize winner not making his or her payment election within sixty (60) days after the player claim instructions ticket is produced.
- (b) Cash Option prizes will be paid in a single cash payment of \$1,475,000, less applicable federal withholding taxes.
- (c) Annual Payment prizes will be paid in twenty-five (25) equal annual installments of \$80,000 per year, less applicable federal withholding taxes.
