For the purpose of this chapter, the definitions provided in Sections 585.001 and 585.01, F.S., and the following words shall apply have the meaning indicated:

(1) Livestock market. — <u>Aany location place</u> in the state where livestock is assembled <u>and sold atfor sale</u>, whether by private sale or public auction, or on a commission basis <u>during regularly scheduled or special sales</u>, wholly or in part. The term "livestock market" does not include privately owned farms <u>orand</u> ranches or sales made <u>at livestock shows</u>, <u>fairs</u>, <u>exhibitions</u>, or special breed association sales thereat.

(2) Dealer. – <u>Aany</u> person, <u>not a market agency</u>, engaged in the business of buying or selling livestock in <u>commerce</u> either on his <u>or her</u> own account or as the employee or agent of <u>a the</u>-vendor <u>and/or</u> purchaser, <u>or any person engaged in the business of buying or selling livestock in commerce on a commission basis</u>. The term shall not include a person who buys or sells livestock as part of his own bona fide breeding, feeding, <u>or</u> dairy <u>and/or</u> beef operations and is not engaged in the business of buying, selling, trading or negotiating the transfer of livestock, nor a person who receives livestock exclusively for immediate slaughter on his own premises.

- (2) All livestock presented at livestock markets on regular sale days <u>mayshall</u> be inspected by an employee of the <u>Ddepartment</u> and any animal showing evidence of infection with any infectious, contagious or communicable disease or infestation with pest which have been declared as dangerous transmissible pests shall be denied entry.

Breeding Ceattle over 18 months of age sold through livestock markets or by dealers to packing establishments for immediate slaughter shall be identified as to herd of origin by the application of numbered back or hip tags supplied by the United States Department of Agriculture (USDA), or other approved method of identification as provided by Chapter 5C-31 F.A.C. supplied by the department. Cattle so identified, upon arrival at the packing establishment, shall have blood samples drawn for brucellosis tests to be conducted in a state federal laboratory.

- (2) All livestock markets shall ensure their facilities, including all yards, docks, pens, alleys, sale rings, chutes, scales, means of conveyance, and other associated equipment, are thoroughly cleaned and disinfected as provided in 9 C.F.R. part 71, revised as of May 1, 2019, and hereby incorporated by reference and available online at http://www.flrules.org/Gateway/reference.asp?No=Ref-xxxx. weekly or more often if deemed necessary under supervision of a representative of the Division. Each market operator shall be responsible for the proper cleaning of his market. Disinfecting equipment and materials will be furnished by the department.
- (3) USDA Approved Livestock Facilities must operate in compliance with a signed USDA agreement and comply with 9 C.F.R. §71.20, revised as of May 1, 2019, and previously incorporated by reference herein.

Such records shall show the name and address of the owner of said livestock, and the names and addresses of the purchaser or purchasers of said livestock, records identifying the livestock as provided in 9 C.F.R. § 86.3 and the livestock's breed, age and sex, to allow for the successful tracing of each animal to its herd of origin. Records allowing for the successful tracing of animals to their herd of origin shall be kept for two years for poultry, and swine, and for five years for cattle, cervids, equines, goats, sheep, and any animal purchased for resale and required to be officially identified as set forth in Chapter 5C-31, F.A.C. or 9 C.F.R. § 86 revised as of May 1, 2019 and incorporated herein available online reference and http://www.flrules.org/Gateway/reference.asp?No=Ref-xxxx. These records shall be made available to the Department upon request.
- (2) Any dealer who purchases, deals in, or sells cattle; or who acts as a commission representative or broker; or who operates and conducts an auction where cattle are sold must be licensed and bonded. Each registered or licensed person, firm or corporation shall keep sufficient records of all test eligible animals purchased for resale to successfully trace such animals to their herd of origin.

- (3) Any dealer or firm involved may be denied registration or have their registration suspended or cancelled when one of the following occurs:
- (a) There is adequate evidence to establish intent to violate or circumvent record keeping requirements of this section and/or animal health regulations; or
- (b) There is a demonstrated history of repeated inability to trace back to the point of origin those exposed or reactor animals handled by the dealer.

SUMMARY: This emergency rule describes the Fast PlayTM game, MERRY MONEY MATCH for which the Department of the Lottery will start selling tickets on November 1, 2019. The rule sets forth the specifics of the game; determination of prizewinners; estimated odds of winning, value and number of prizes in the game.

53ER19-69 MERRY MONEY MATCH.
(1) Name of Game. MERRY MONEY MATCH.

- (2) Price. MERRY MONEY MATCH lottery tickets sell for \$1.00 per play.
- (3) Game Description. MERRY MONEY MATCH is a Fast Play™ instant-win game (also known as an online terminal game) printed from an authorized Florida Lottery retailer terminal at the time of purchase. Players may play the game and determine immediately if the ticket is a winner. All prizes are predetermined. The player does not have the ability to select his or her own numbers or play symbols.
- (4) MERRY MONEY MATCH Lottery Ticket Purchase. Players may purchase a MERRY MONEY MATCH lottery ticket at an authorized retailer by: telling the retailer; presenting to the retailer a barcode found on MERRY MONEY MATCH supporting materials; or by submitting a MERRY MONEY MATCH play slip for processing through a retailer terminal. In addition, a MERRY MONEY MATCH barcode may be printed from the Florida Lottery's website at flalottery.com. Supporting materials with a MERRY MONEY MATCH barcode include game brochures or Florida Lottery emails.
- (a) Players who choose to purchase a MERRY MONEY MATCH lottery ticket or tickets by telling the retailer shall specify the number of plays desired. Each play will print on a separate ticket.
- (b) Players who choose to present a barcode to purchase a MERRY MONEY MATCH lottery ticket shall provide the barcoded material to the retailer to scan. One scanned barcode will produce one MERRY MONEY MATCH lottery ticket.
- (c) Players who choose to use a play slip to purchase a MERRY MONEY MATCH lottery ticket or tickets may mark the appropriate box on the play slip for the number of plays desired and submit it to the retailer. The retailer will process the play slip through the retailer terminal. Each play will print on a separate ticket. Play slips must be Florida Lottery approved and players must use only blue or black ink or pencil for making selections. The use of mechanical, electronic, computergenerated or any other non-manual method of marking MERRY MONEY MATCH play slips is prohibited.
- (d) MERRY MONEY MATCH lottery tickets cannot be purchased through a Florida Lottery vending machine.
- (e) MERRY MONEY MATCH lottery tickets cannot be canceled.
- (5) The YOUR NUMBERS and WINNING NUMBER play symbols that may appear in the play area are as follows:

(6) How to Play and Determination of Prizewinners. Each MERRY MONEY MATCH lottery ticket contains a YOUR SNOWFLAKE play area with 20 symbols and a YOUR WINTER SYMBOLS play area with 3 symbols. Players match

the symbols in the YOUR WINTER SYMBOLS play area to the symbols in the YOUR SNOWFLAKE play area. A ticket containing six or more matches shall entitle the claimant to a single prize corresponding to the total number of matches on the ticket as shown in the prize legend.

- (c) It is the responsibility of the player to verify the readability of the information printed on the MERRY MONEY MATCH lottery ticket at the time of purchase. Additionally, the player should check the date and time printed on a MERRY MONEY MATCH lottery ticket to confirm that the printed date and time of purchase correspond to the actual date and time of purchase. It shall be the responsibility of the player to immediately notify the retailer of any such errors or discrepancies of a ticket prior to leaving the retailer location.
- (d) Subject to a retailer's hours of operation and gaming system availability, MERRY MONEY MATCH lottery tickets are available for purchase daily between the hours of 6:00 a.m. and 12:00 midnight, Eastern Time (ET).

SUMMARY: This emergency rule describes the Fast PlayTM game, BLIZZARD BINGO for which the Department of the Lottery will start selling tickets on November 1, 2019. The rule sets forth the specifics of the game; determination of prizewinners; estimated odds of winning, value and number of prizes in the game.

THE FULL TEXT OF THE EMERGENCY RULE IS:

53ER19-70 BLIZZARD BINGO.

- (1) Name of Game. BLIZZARD BINGO.
- (2) Price. BLIZZARD BINGO lottery tickets sell for \$2.00 per play.
- (3) Game Description. BLIZZARD BINGO is a Fast Play[™] instant-win game (also known as an online terminal game) printed from an authorized Florida Lottery retailer terminal at the time of purchase. Players may play the game and determine immediately if the ticket is a winner. All prizes are predetermined. The player does not have the ability to select his or her own numbers or play symbols.
- (4) BLIZZARD BINGO Lottery Ticket Purchase. Players may purchase a BLIZZARD BINGO lottery ticket at an authorized retailer by: telling the retailer; presenting to the retailer a barcode found on BLIZZARD BINGO supporting materials; or by submitting a BLIZZARD BINGO play slip for processing through a retailer terminal. In addition, a BLIZZARD BINGO barcode may be printed from the Florida Lottery's website at flalottery.com. Supporting materials with a BLIZZARD BINGO barcode include game brochures or Florida Lottery emails.
- (a) Players who choose to purchase a BLIZZARD BINGO lottery ticket or tickets by telling the retailer shall specify the number of plays desired. Each play will print on a separate ticket.
- (b) Players who choose to present a barcode to purchase a BLIZZARD BINGO lottery ticket shall provide the barcoded

- material to the retailer to scan. One scanned barcode will produce one BLIZZARD BINGO lottery ticket.
- (c) Players who choose to use a play slip to purchase a BLIZZARD BINGO lottery ticket or tickets may mark the appropriate box on the play slip for the number of plays desired and submit it to the retailer. The retailer will process the play slip through the retailer terminal. Each play will print on a separate ticket. Play slips must be Florida Lottery approved and players must use only blue or black ink or pencil for making selections. The use of mechanical, electronic, computergenerated or any other non-manual method of marking BLIZZARD BINGO play slips is prohibited.
- (d) BLIZZARD BINGO lottery tickets cannot be purchased through a Florida Lottery vending machine.
 - (e) BLIZZARD BINGO lottery tickets cannot be canceled.
- (5) The CALL NUMBERS play symbols that may appear in the play area are as follows:

(6) How to Play and Determination of Prizewinners.

(a) There are two player's cards labeled CARD 1 and CARD 2, and one CALL NUMBERS play area on each BLIZZARD BINGO lottery ticket. Each player's card is played separately. Each player's card contains twenty-four play symbols (numbers) and one free space (snowflake) located in the center of each card. A free space can substitute as a number in a pattern of which it is a part. Each card contains a five by five grid with each column labeled as "B", "I", "N", "G", "O". The ranges of numbers associated with each letter/column are as follows:

(b) Players identify the numbers on CARD 1 and CARD 2 that match the numbers in the CALL NUMBERS play area. A ticket whose numbers on one of the player's cards match the CALL NUMBERS in one of the following patterns shall entitle the prizewinner to the prize shown for that pattern on that card:

- 1. Horizontal line pattern (consisting of five numbers or four numbers and the free space);
- 2. Vertical line pattern (consisting of five numbers or four numbers and the free space);
- 3. Diagonal line pattern (consisting of four numbers and the free space);
- 4. Four corners pattern (consisting of four numbers, one in each corner);
- <u>5. "X" pattern (two crossing diagonal lines consisting of a total of eight numbers and the free space);</u>
- <u>6. "Z" pattern (consisting of a total of twelve numbers and the free space); or</u>
- 7. An "All" pattern (consisting of a total twenty-four numbers and the free space).
 - (7) The CARD 1 prizes are \$2, \$10, \$25, \$100 and \$5,000.
- (8) The CARD 2 prizes are \$3, \$15, \$50, \$250, and \$10,000.
- (9) Players may win on one or both player's cards per ticket; however, players may not win more than one prize on each player's card and only the highest prize may be won.

(11) The estimated overall odds of winning some prize in the BLIZZARD BINGO game are 1:3.62. The BLIZZARD BINGO prize structure will be replenished automatically as each ticket is sold in each prize tier, including both winning and non-winning prize tiers. The odds remain the same for each ticket purchased for the life of the game.

(12) BLIZZARD BINGO Additional Provisions.

- (a) By purchasing a BLIZZARD BINGO lottery ticket, a player agrees to comply with and abide by all rules and regulations of the Florida Lottery.
- (b) Prizes must be claimed within 60 days after the official end of game. All BLIZZARD BINGO prizes shall be paid in a single, lump-sum payment. Ticket validation requirements for Fast Play BLIZZARD BINGO lottery tickets are set forth in the rule of the Florida Lottery governing payment of prizes.

Payment of prizes for Fast Play BLIZZARD BINGO lottery tickets shall be made in accordance with the rule of the Florida Lottery governing payment of prizes. (c) It is the responsibility of the player to verify the readability of the information printed on the BLIZZARD BINGO lottery ticket at the time of purchase. Additionally, the player should check the date and time printed on a BLIZZARD BINGO lottery ticket to confirm that the printed date and time of purchase correspond to the actual date and time of purchase. It shall be the responsibility of the player to immediately notify the retailer of any such errors or discrepancies of a ticket prior to leaving the retailer location.

(d) Subject to a retailer's hours of operation and gaming system availability, BLIZZARD BINGO lottery tickets are available for purchase daily between the hours of 6:00 a.m. and 12:00 midnight, Eastern Time (ET).

(13) The effective date of this emergency rule is November 1, 2019.

NOTICE IS HEREBY GIVEN by the State Board of Administration of Florida (the "Board") of the estimated borrowing capacity, estimated claims-paying capacity, and projected balance of the Florida Hurricane Catastrophe Fund (the "Fund") as of December 31, 2019, in compliance with the subparagraph 215.555(4)(c)2., Florida requirements of Statutes. estimates relate to the 2019-2020 These Reimbursement Contract Year. For October 2019, based on an estimated post-event borrowing capacity of \$9.0 billion, \$11.4 billion projected year-end cash balance, and \$0.92 billion of reinsurance, the Fund's total estimated claims-paying capacity over the next 12 months is \$21.3 billion, which amount exceeds the \$17 billion limit on the Fund's single-season obligations as specified by subparagraph 215.555(4)(c)1., Florida Statutes, for the contract year. The post-event borrowing capacity estimate is dependent on many factors, such as the credit rating of the debt, the amount of emergency assessments available for funding the debt, the limitations or constraints of the financial markets to absorb potential debt issuances, the time necessary to access such markets, and the existing level of interest rates at the time of issuance. The projected year-end balance available for reimbursement of participating insurers on December 31, 2019, is estimated to be \$11.4 billion, which represents the amount of assets available to pay claims resulting from Covered Events which may occur during the June 1, 2019 through May 31, 2020 Contract Year, not including any bond proceeds issued pursuant to subsection 215.555(6), Florida Statutes. The estimated claims-paying capacity consists of the estimated postevent borrowing capacity, the projected year-end cash balance, and reinsurance. Additional liquidity is provided by \$1.65 billion from Series 2013A and Series 2016A pre-event bonds. The projected year-end fund balance of \$11.4 billion reflects losses and loss reserves from Hurricanes Irma (2017) and Michael (2018), which the FHCF's consulting actuary has estimated to be \$6.45 billion. Greater detail may be obtained in the October 17, 2019 Claims-Paying Capacity Estimates Report, which can be found on the Fund's website at www.sbafla.com/fhcf/ under "Bonding Program." The Board recognizes that changing financial market conditions can impact the Fund's actual claims-paying capacity either positively or negatively. Current conditions might not be the same as the conditions that may be in place if and when the Board determines that it is necessary to issue revenue bonds. Participating insurers that rely on the estimates in this notice should recognize the potential impact the financial markets can have on the Board's claims-paying ability and plan accordingly.
