No dentists or dental hygienist licensed in this State shall administer nitrous-oxide inhalation analgesia in the practice of dentistry until they have complied with the provisions of this rule chapter, nor shall a hygienist administer nitrous-oxide to a patient previously sedated. No agents other than nitrous-oxide and oxygen shall be used for inhalation analgesia pursuant to Rule 64B5-14.003, F.A.C.

(6) A hygienist certified by the board to administer local anesthesia shall not administer local anesthesia to a patient sedated by general anesthesia, deep sedation, moderate sedation, or pediatric moderate sedation. If a dentist or dental hygienist has administered nitrous-oxide to the patient, the certified dental hygienist may administer local anesthesia under the direct supervision of the supervising dentist. A patient who has been prescribed a medical drug by their licensed health care provider for the purposes of life functions may be administered local anesthesia by the certified dental hygienist under the direct supervision of the supervising dentist. If, however, the medical drug is prescribed or administered for the purposes of a dental procedure which is intended to induce minimal sedation, the hygienist may not administer local anesthesia to the patient.

(a) A dentist may ~~employ or use, or employ and authorize a dental hygienist to administer under indirect supervision, as specified by Rule 64B5-16.006,~~ nitrous-oxide inhalation analgesia on an outpatient basis for dental patients provided such dentist and dental hygienist have:

1. ~~Has C~~ompleted no less than a two-day course of training as described in the American Dental Association’s “Guidelines for Teaching Pain Control and Sedation to Dentists and Dental Students (eff. 10/16), which is hereby incorporated by reference and available at <http://www.flrules.org/Gateway/reference.asp?No=Ref-11670> or available at <http://www.floridadentistry.gov>, or its equivalent, or

2. ~~Has T~~training equivalent to that described above while a student in an accredited school of dentistry or dental hygiene; and,

3. ~~Has a~~ A dental nitrous-oxide delivery system with fail-safe features and a 30% minimum oxygen flow.

(b) A dentist utilizing nitrous-oxide inhalation analgesia and such dentist’s assistants and ~~not~~ dental hygienist personnel shall be certified in an American Heart Association or American Red Cross or equivalent Agency sponsored cardiopulmonary resuscitation course at the basic life support level to include one man CPR, two man CPR, infant resuscitation and obstructed airway with a periodic update not to exceed two years. A dentist and all assistant/dental hygienist personnel shall also be trained in the use of either an Automated External Defibrillator or a defibrillator and electrocardiograph as part of their cardiopulmonary resuscitation course at the basic life support level. In addition to CPR certification, a dentist utilizing pediatric moderate sedation must be currently trained in PALS (Pediatric Advanced Life Support).

- (c) through (d) No change.

(e) Dental assistants ~~and dental hygienists~~ may monitor nitrous-oxide inhalation analgesia under the indirect supervision of a dentist if the dental assistant ~~or dental hygienist~~ has complied with the training requirements in paragraph 64B5-14.003(4)(b), F.A.C., and has completed, at a minimum, a two-day course of training as described in the American Dental Association’s “Guidelines for Teaching Pain Control and Sedation to Dentists and Dental Students” or its equivalent. After the dentist or dental hygienist has induced a patient and established the maintenance level, the assistant ~~or hygienist~~ may monitor the administration of the nitrous-oxide oxygen

making only diminishing adjustments during this administration and turning it off at the completion of the dental procedure.

PURPOSE AND EFFECT: Pursuant to section 633.218(1), F.S., it is the duty of the State Fire Marshal to inspect each state-owned building on a recurring basis to ascertain and cause to be corrected any conditions liable to cause fire or endanger life from fire and any violation of the firesafety standards for state-owned buildings. Section 633.218(5), F.S., requires the Division of State Fire Marshal (Division) to provide by rule a schedule of fees to pay for the costs of the inspections of state-owned buildings and premises, any firesafety review or plans for proposed construction, renovations, or occupancy, and related administrative expenses. This rulemaking sets incorporates forms to request the plans reviews and building inspections. The rulemaking also clarifies what the inspection fees pay for and when they must be paid, among other required updates.

SUMMARY: The proposed amendments will update the process for requesting inspections of state-owned buildings for compliance with the Florida Fire Prevention Code and methods of calculating and charging fees to inspect state-owned buildings.

 Petition to Amend the Boundaries of the

Fiddler's Creek Community Development District 1  
 On November 18, 2021, the Florida Land and Water Adjudicatory Commission ("FLWAC" or "Commission") received a petition to amend the boundaries of the Fiddler's Creek Community Development District 1 ("the District"). The Commission will follow the requirements of Chapter 42-1, F.A.C., and Chapter 190, F.S., as amended, in considering the petition.

**SUMMARY OF CONTENTS OF PETITION:** The petition requests amendment to contract the boundaries of the District by taking out three land areas totaling approximately 38.50 acres and to expand the boundaries by adding three land areas totaling approximately 11.87 acres, resulting in a net contraction of the District boundaries by approximately 26.64 acres. The District currently consists of approximately 1,342.95 acres located in Collier County, Florida. After amendment, the District will encompass a total of approximately 1,316.31 acres.

**SUMMARY OF ESTIMATED REGULATORY COSTS:** A statement of estimated regulatory costs (SERC) was prepared at the request of the District. The complete text of the SERC is contained as Exhibit 7 to the petition. Generally, the SERC indicates:

- The proposed amendment to the District's boundaries will not have an adverse impact on economic growth, job creation, employment, private sector investment, business competitiveness, or regulatory costs;
- The proposed amendment of the District will involve the State and its residents, and Collier County and its residents,

property owners within the existing District and those to be contracted or added through District amendment, and future property owners;

- If approved, the owners and future residents within the amended District will be subject to the District's jurisdiction and potential assessments;
- The proposed amendment will result in limited review costs to the reviewing agency and other state and local government entities;
- The District plans to continue providing localized infrastructure improvements and services to serve the land within the District boundaries. The District may finance future District infrastructure by issuing bonds, including tax-exempt bonds from time to time secured by proceeds of non-ad valorem special assessments levied on benefitted land within the District. The District proposes to continue maintaining existing infrastructure and provide future infrastructure to the District land to support the overall development program;
- The proposed amendment of the District is not expected to have a negative impact on state or local revenues; and,
- The proposed amendment of the District will have no adverse impact on small businesses, counties or cities.

To all interested parties: the Pilotage Rate Review Committee has determined that as of February 1, 2022, the rates of pilotage at the Port of Palm Beach are **MODIFIED** to the following:

- 1) Draft Charge

- \$20.00 per foot - minimum 17 feet
  - 2) Tonnage Charge
  - \$0.032 per GT - minimum 5,000 GT
  - 3) Shifting Vessel
  - Less than 7,000 GT - \$400.00
  - 7,000 GT or greater - \$800.00
  - 4) Barges
  - GT + 1.5 x draft - for barges greater than 5,000 GT
  - 5) Running Lines by Pilot Boat
  - \$400.00
  - 6) Anchoring Vessel in Anchorage Area
  - \$1,000.00
  - 7) Detention/Cancellation of Pilot
  - \$300.00 per 1/2 hour
  - 8) New Pilot Boat Fee
  - \$50.00 per handle for 7 years
  - 9) Port Control Duties Fee
  - \$25 per handle
  - 10) Reduced Passenger Vessel GT Charge
  - \$0.016/GT on GT above 55,000 GT
  - 11) Late Payment Charge
  - 2% per month after 30 days from invoice submission
  - 12) 5.0% increase per year for 10 years beginning six months after the implementation date and annually thereafter.
- This increase applies to all rates including the Pilot Boat Fee and Port Control Duties Fee.

**NOTICE OF HEARING RIGHTS**

This Order will become final agency action if no request for a hearing is received by the Pilotage Rate Review Committee (PRRC) by any person whose substantial interests will be affected by this action within twenty-one days after receipt or publication of this notice in the Florida Administrative Register or in the newspaper, or by close of business on February 1, 2022, whichever is latest. A person whose substantial interests will be affected may petition the PRRC for a hearing involving disputed issues of material fact before an administrative law judge pursuant to Section 120.57(1), Florida Statutes, by filing an appropriate petition with the Executive Director of the Committee at Department of Business and Professional Regulation, P.O. Box 5377, Tallahassee, Florida 32314-5377. A petition for a hearing involving disputed issues of material fact must contain information required by Rule 28-106.201, Florida Administrative Code, including a statement of all disputed issues of material fact. The PRRC may refer a petition to the Division of Administrative Hearings for assignment of an

administrative law judge only if the petition is in substantial compliance with the rule requirements.

In the absence of such a petition or if the PRRC concludes that the petitioner has not raised a disputed issue of material fact and does not designate the petition for hearing, this Order shall become final agency action for purposes of Section 120.68, Florida Statutes.

In accordance with Section 120.573, Florida Statutes, mediation is not available.
