6A-6.0331        General Education Intervention Procedures, Evaluation, Determination of Eligibility, Reevaluation and the Provision of Exceptional Student Education Services

**PURPOSE AND EFFECT:** : To address the timeline for initial ESE evaluations and to update the Parental Consent Form Instruction in Florida’s Access Points - Alternate Academic Achievement Standards (AP-AAAS) and Administration of the Statewide, Standardized Alternate Assessment including revisions to align the form with Rule 6A-1.0943, F.A.C., Statewide Assessment for Students with Disabilities, which was revised to include a definition for most significant cognitive disability and eligibility to be assessed on alternate academic achievement standards.

**SUMMARY:** Evaluation timeline for students with disabilities and Parental Consent Form Instruction in Florida’s Access Points - Alternate Academic Achievement Standards (AP-AAAS) and Administration of the Statewide, Standardized Alternate Assessment.

**6A-6.0331 General Education Intervention Procedures, Evaluation, Determination of Eligibility, Reevaluation and the Provision of Exceptional Student Education Services.**

The state's goal is to provide full educational opportunity and a free appropriate public education (FAPE) to all students with disabilities ages three (3) through twenty-one (21) and to students who are gifted in grades kindergarten through 12. School districts have the responsibility to ensure that students suspected of having a disability are subject to general education intervention procedures. They must ensure that all students with disabilities or who are gifted and who are in need of exceptional student education (ESE) as defined in paragraph 6A-6.03411(1)(n), F.A.C., are identified, located, and evaluated, and FAPE is made available to them if it is determined that the student meets the eligibility criteria specified in Rules 6A-6.03011, 6A-6.03012, 6A-6.030121, 6A-6.03013, 6A-6.03014, 6A-6.030151, 6A-6.030152, 6A-6.030153, 6A-6.03016, 6A-6.03018, 6A-6.03019, 6A-6.03020, 6A-6.03022, 6A-6.03023, paragraph 6A-6.03026(1)(b) and Rule 6A-6.03027, F.A.C. ESE includes specially designed instruction as defined in paragraph 6A-6.03411(1)(jj), F.A.C.; special education as defined in paragraph 6A-6.03411(1)(kk), F.A.C.; and related services as defined in paragraph 6A-6.03411(1)(dd), F.A.C. These requirements apply to all students, including those who are homeless or are wards of the state or who attend private schools, regardless of the severity of their disability. Additionally, school districts may elect to serve children with disabilities below the age of three (3) years in collaboration with the Part C Early Steps Program. The procedures and criteria for general education interventions, identification, evaluation, and determination of eligibility of students with disabilities and gifted students by school districts shall be set forth in the school district's ESE Policies and Procedures document consistent with the following requirements.

(1) through (2) No change.

(3) Initial evaluation. Each school district must conduct a full and individual initial evaluation before the initial provision of ESE. Either a parent of a kindergarten through grade 12 student or child age three (3) to kindergarten entry age, or a school district may initiate a request for initial evaluation to

determine if the student is a student with a disability. Either a parent of a kindergarten through grade 12 student or a school district may initiate a request for initial evaluation to determine if a student is gifted.

(a) through (g) No change.

(h) The sixty (60)-day timeframe for evaluation does not apply to a school district if:

1. The parent and school district, by mutual written agreement, extend the sixty (60)-calendar day requirement by no more than thirty (30)-calendar days. The written agreement must be secured before the forty-fifth (45th) calendar day, but after the formal testing has begun and it was determined that other evaluators are needed to complete the required full and individual evaluation.

2. 1- The parent of the student repeatedly fails or refuses to produce the student for the evaluation; or

3. 2- A student enrolls in a school served by the school district after the timeframe has begun, and prior to a determination by the student's previous school district as to whether the student is a student with a disability. This exception applies only if the subsequent school district is making sufficient progress to ensure a prompt completion of the evaluation, and the parent and subsequent school district agree to a specific time when the evaluation will be completed. Assessments of students with disabilities who transfer from one school district to another school district in the same school year must be coordinated with those students' prior and subsequent schools, as necessary and as expeditiously as possible, to ensure prompt completion of full evaluations.

(10) Parental Consent for Specific Actions.

(a) A school district may not proceed with the following actions included in a student's IEP without written informed consent of the parent unless the school district documents reasonable efforts to obtain the parent's consent and the student's parent has failed to respond, or the school district obtains approval through a due process hearing in accordance with subsection 6A-6.03311(9), F.A.C. To meet the reasonable efforts requirements to obtain parental consent the school district must document its attempts to obtain parental consent using procedures such as those used to obtain parental participation in meetings as described in subparagraph 6A-6.03028(3)(b)7., F.A.C.

Those actions requiring parental consent include:

1. Provision of instruction in the state alternate academic achievement standards (Access Points), and administration of the statewide, standardized alternate assessment in accordance with Section 1008.22, F.S. Administration of an alternate assessment in accordance with Section 1008.22, F.S., and

~~provision of instruction in the state standards access points curriculum; and,~~

2. Except for a change in placement as described in Section 1003.57(1)(h), F.S., placement of the student in an exceptional student education center as defined in paragraph 6A-1.099828(2)(b), F.A.C.

(b) The district shall obtain written parental consent for the actions described above on the Parental Consent Form – Instruction in ~~the State Standards Access Points - Alternate Academic Achievement Standards (AP-AAAS) and Administration of the Statewide, Standardized Alternate Assessment Curriculum and Statewide, Standardized Alternate Assessment,~~ Form 313181, (<http://www.flrules.org/Gateway/reference.asp?No=Ref-04779>) (effective ~~August 2022~~ December 2014) English, Arabic, Chinese, French, Haitian Creole, Portuguese, Russian, Spanish, Tagalog, and Vietnamese, and Parental Consent Form – Student Placement in an Exceptional Education Center, Form 313182,

RULE NO.: 6A-10.041  
 RULE TITLE: Substitution for Requirements for Eligible Students with Disabilities at Florida Colleges and Postsecondary Career Centers

PURPOSE AND EFFECT: Senate Bill 366 (2021) amended multiple Florida Statutes to expand the mechanisms institutions may use to assess readiness for college-level work. In addition to identifying approved common placement tests, the State Board of Education (SBOE) adopted an amendment to Rule 6A-10.0315, F.A.C., Demonstration of Readiness for Communication and Computation, which identifies alternative methods for assessing communication and computation skills. The purpose of this rule amendment is to replace outdated language with the language from Rule 6A-10.0315, F.A.C., effective March 2022. In addition, the rule amendment incorporates by reference a form that postsecondary career centers must use to annually report course substitutions. This change aligns the career center reporting requirements with the Florida College System reporting requirements. Other technical changes will be made.

SUMMARY: Language referring to “college preparatory” requirements is being updated to “demonstration of readiness in college-level communication and computation” to better align with recent changes to Rule 6A-10.0315, F.A.C., Demonstration of Readiness for College-Level Communication and Computation. In addition, district career centers will be required to report course substitutions in a manner similar to Florida College System institutions.

**6A-10.041 Substitution for Requirements for Eligible Students with Disabilities at Florida Colleges and Postsecondary Career Centers.**

(1) Each district board of trustees within the Florida College System and each district school board which operates district postsecondary technical career centers under section 1001.44, F.S., and charter technical career centers under section 1002.34, F.S., ~~a postsecondary career center~~ shall develop and implement policies and procedures for providing reasonable substitution for eligible students as required by Sections 1007.264 and 1007.265, F.S. In determining whether to grant a substitution, documentation to substantiate that the disability can be reasonably expected to prevent the individual from meeting requirements for admission to the institution, admission to a program of study, entry to upper division, or graduation shall be provided. In determining whether to grant a substitution, a college may consider pertinent educational records. For purposes of this rule, the following definitions shall apply.

(a) through (j) No change.

(2) No change.

(3) The policies shall provide for articulation with other state institutions which shall include, at a minimum, acceptance of all substitutions previously granted by a Florida public state postsecondary institution.

(4) The policies shall include a provision that admitted for students who are assessed for readiness for college-level computation and communication under paragraphs Rule 6A-10.0315(1)(a) or (1)(b) and whose assessment results indicate a need for developmental education may be exempt from developmental education coursework if they qualify for a course substitution ~~qualify for a course substitution which would allow such students to be exempt from the college preparatory requirements, as provided in State Board Rule 6A-10.0315, F.A.C., in the basic skill area for which the student is~~

~~eligible for a course substitution, provided that successful completion of the college preparatory coursework is not considered an essential part of the curriculum in the student's academic program.~~

(5) ~~The Commissioner of Education shall coordinate with the Chancellor of the State University System to provide for coordination of the provision of technical assistance in the implementation of this rule.~~

(6) Each Florida college and postsecondary career center operated by a school district shall maintain and report records on the number of students granted substitutions by type of disability, the substitutions provided, the substitutions identified as available for each documented disability and the number of requests for substitutions which were denied. Each college within ~~t~~The Florida College System shall report such information to the Department of Education, Division of Florida Colleges once a year by July 1. The Course Substitution Report, Form CSR-01, <http://www.flrules.org/Gateway/reference.asp?No=Ref-06774>) is incorporated by reference herein effective August 2022 ~~June 2016~~, can be obtained at <http://fldoe.org/core/fileparse.php/3/urllt/coursesubstitutiontemplate.pdf>. Each career center under section 1001.44, F.S., and charter technical career center under section 1002.34, F.S., shall report such information to the Department of Education, Division of Career and Adult Education once a year by July 1. PURPOSE AND EFFECT: The proposed rule amendment updates the overall standards of practice for the prescribing of medication for the treatment of obesity in children and adults and allows for the use of telemedicine for such prescribing.

SUMMARY: To update the text with the prescribing of medication for the treatment of obesity in children and adults and the use of telemedicine for such prescribing.

SUMMARY OF STATEMENT OF ESTIMATED REGULATORY COSTS AND LEGISLATIVE RATIFICATION:

The Agency has determined that this will not have an adverse impact on small business or likely increase directly or indirectly regulatory costs in excess of \$200,000 in the aggregate within one year after the implementation of the rule. A SERC has not been prepared by the Agency.

The Agency has determined that the proposed rule is not expected to require legislative ratification based on the statement of estimated regulatory costs or if no SERC is required, the information expressly relied upon and described herein: During discussion of the economic impact of this rule at its Board meeting, the Board concluded that this rule change will not have any impact on licensees and their businesses or the businesses that employ them. 64B15-14.004 Standards for the Prescription of Drugs to Treat Obesity ~~Drugs~~.

The ~~prescribing~~ ~~prescription~~ of anti-obesity drugs ~~medication for the purpose of enhancing weight loss~~ should only be performed by osteopathic physicians qualified by ~~with~~ training and experience to treat obesity. All licensees are expected to abide by the following guidelines and standards in

the utilization of any drug, ~~or~~ synthetic compound, nutritional supplement, or herbal treatment, for the purpose of providing medically assisted weight loss. For purposes of this rule, "anti-obesity drugs" means any drug, synthetic compound, nutritional supplement, or herbal treatment used for the purpose of providing medically assisted weight loss.

(1) To justify the use of anti-obesity drugs ~~weight loss enhancers~~ as set forth above, the patient must have an initial Body Mass Index (BMI) of 30 or above, or an initial BMI of greater than 25 with at least one comorbidity factor, or an initial measurable body fat content equal to or greater than 25% of total body weight for male patients or 30% of total body weight for women. The treating physician may also take into account other factors such as ethnicity-specific values and markers such as waist circumference when justifying the use of anti-obesity drugs. ~~The prescription of such weight loss enhancers is not generally appropriate for children. Any time such prescriptions are made for children, the prescribing osteopathic physician must obtain a written informed consent from the parent or legal guardian of the minor patient in addition to complying with the other guidelines and standards set forth in this rule.~~ BMI is calculated by use of the formula  $BMI = \text{weight (kg)} / \text{height (m)}^2$ .  $BMI = \text{kg/m}^2$ . ~~The osteopathic physician may deviate from these guidelines in individual cases where two or more comorbidity factors are present.~~

(2) Physicians in Florida are prohibited from prescribing, ordering, dispensing, or administering any anti-obesity drug that is both a serotonergic and anorexic agent unless the drug has been approved by the U.S. Food and Drug Administration (FDA) specifically for use in weight loss management. Selective serotonin re-uptake inhibitors (SSRIs) that have not been approved by the FDA for weight loss may not be prescribed, ordered, dispensed, or administered for such purposes.

(3) Physicians may only prescribe anti-obesity drugs to children with an initial BMI greater than 120<sup>th</sup> percent of the 95<sup>th</sup> percentile with significant comorbidity or an initial BMI greater than 140<sup>th</sup> percent of the 95<sup>th</sup> percentile.

(4)(2) An initial evaluation of the patient shall be conducted prior to the prescribing, ordering, dispensing or administering of any drug, ~~or~~ synthetic compound, nutritional supplement, or herbal treatment and such evaluation shall include ~~an appropriate~~ physical and complete history; ~~appropriate~~ tests related to medical treatment for weight loss; ~~and appropriate~~ medical referrals as indicated by the history, physical examination, history and testing; all in accordance with general medical standards of care. The initial evaluation may be delegated to an educated and trained physician's assistant licensed pursuant to Chapter 458 or 459, F.S., or an advanced practice registered nurse licensed pursuant to Chapter 464, F.S.

~~(a) The initial evaluation may be delegated to an appropriately educated and trained osteopathic physician assistant licensed pursuant to Chapter 459, F.S., or an appropriately educated and trained advanced registered nurse practitioner licensed pursuant to Chapter 464, F.S.~~

~~(b) If the initial evaluation required above is delegated to a an osteopathic physician assistant or to an advanced registered nurse practitioner, then the delegating osteopathic physician must personally review the resulting medical records prior to the issuance of an initial prescription, order or dosage.~~

~~(3) Prescriptions or orders for any drug or synthetic compound for the purpose of assisting in weight loss must be in writing and signed by the prescribing osteopathic physician. Initial prescriptions or orders of this type shall not be called into a pharmacy by the osteopathic physician or by an agent of the osteopathic physician.~~

~~(5)(4) Prior to prescribing, ordering, dispensing, or administering anti-obesity drugs, At the time of delivering the initial prescription or providing the initial supply of such drugs to a patient, the prescribing osteopathic physician must personally meet with the patient and personally obtain an appropriate written informed consent from the patient. Such consent must state that there is a lack of scientific data regarding the potential danger of long term use of combination weight loss treatments, and shall discuss potential benefits versus potential risks of weight loss treatments. The written consent must also clearly state the need for dietary intervention and physical exercise as a part of any weight loss regimen. A copy of the signed informed consent shall be included in the patient's permanent medical record.~~

~~(6)(5) Each osteopathic physician who is prescribing, ordering, or providing anti-obesity drugs weight loss enhancers to patients must assure that such patients undergo a an in-person re-evaluation at least once every 3 months within 2 to 4 weeks of receiving a prescription, order or dosage. The re-evaluation shall include the elements of the initial evaluation and an assessment of the medical effects of the treatment being provided. Any patient that continues on a drug or synthetic compound assisted weight loss program shall be re-evaluated at least once every 3 months.~~

~~(6) Each osteopathic physician who prescribes, orders, dispenses or administers any drug or synthetic compound for the purpose of assisting a patient in weight loss shall maintain medical records in compliance with Rule 64B15-15.004, F.A.C., and must also reflect compliance with all requirements of this rule.~~
