64B13-5.001 Hours Requirement

The Board of Optometry hereby gives notice: of the issuance of an Order regarding the Petition for Waiver or Variance, which was filed on January 4, 2022, by Suzanne Kathleen Smith. Petitioner was seeking a waiver or variance from subsection 64B13-5.001(1), F.A.C., that states in part, as a condition to the renewal of a biennial license, each licensed practitioner shall be required to maintain professional competency by completing thirty (30) clock hours of continuing education in subjects relating to optometry that have been approved by the Board. Petitioner is also seeking a variance or waiver of subsection 64B13-5.001(2), F.A.C., that states in part, for licensed practitioners who are certified optometrists, at least six (6) of the required thirty (30) hours must be of "transcript quality."

"Transcript quality" refers to coursework in ocular and systemic pharmacology and the diagnosis, treatment and management of ocular and systemic conditions and diseases. Transcript quality CE must be sponsored by a school or college of optometry or equivalent educational entity as approved by the Board, must be obtained at a live in-person attendance course, and must require a test and passing grade. Petitioner is also seeking a variance or waiver of subsection 64B13-5.001(6), F.A.C., that states in part, as part of the thirty (30) clock hours, licensed practitioners shall be required to obtain two (2) hours in the area of Florida jurisprudence which lists the criteria or course content for approval of non-transcript quality continuing education programs. A licensed practitioner may earn two (2) hours in Florida jurisprudence by attending an in-person meeting of the Board at which another licensee is disciplined for no less than four (4) continuous hours or the duration of the meeting. Petitioner is also seeking a variance or waiver of subsection 64B13-5.001(7), F.A.C., that states in part, as part of the thirty (30) clock hours, licensed practitioners are required to complete a two (2)-hour course relating to prevention of medical errors, as part of the renewal process.

FINAL ORDER
APPROVING CITY OF KEY WEST ORDINANCE NO. 22-02

The Department of Economic Opportunity (“Department”) hereby issues its Final Order, pursuant to Section 380.05(6), Florida Statutes, approving land development regulations adopted by the City of Key West, Florida (“City”), by Ordinance No. 22-02 (“Ordinance”).

FINDINGS OF FACT

1. Section 380.0552, Florida Statutes, and Rule 28-36.002, Florida Administrative Code, designate the City as an area of critical state concern.
2. The City adopted the Ordinance on January 19, 2022 and rendered it to the Department on February 23, 2022.

3. The Ordinance amends Chapter 122, Section 122-1371, of the Code of Ordinances to increase the annual inspection and enforcement fees for a person or entity who holds a transient rental business tax receipt. The Ordinance also amends Chapter 122, Section 122-1371 to allow for the transfer of a transient medallion license to be included in the sale of a property that holds a transient medallion license upon payment of a transfer fee.

CONCLUSIONS OF LAW

4. The Department is required to approve or reject land development regulations that are adopted by any local government in an area of critical state concern. See Section 380.05(6), Florida Statutes.

5. “Land development regulations” include local zoning, subdivision, building, and other regulations controlling the development of land. Section 380.031(8), Florida Statutes. The regulations adopted by the Ordinance are land development regulations.

6. The Ordinance is consistent with the City’s Comprehensive Plan generally, as required by Section 163.3177(1), Florida Statutes, and is specifically consistent with Objective 4-1.3 and Policy 4-1.3.1.

7. All land development regulations enacted, amended, or rescinded within an area of critical state concern must be consistent with the principles for guiding development for that area. See Section 380.05(6), Florida Statutes. The Principles for Guiding Development for the City are set forth in Rule 28-36.003, Florida Administrative Code.

8. The Ordinance is consistent with the Principles for Guiding Development for the City as a whole, and specifically furthers the following Principles:

- (1)(a) Strengthen local government capabilities for managing land use and development; and
- (1)(h) Protection of the public health, safety, welfare and economy of the City of Key West, and the maintenance of Key West as a unique Florida resource.

WHEREFORE, IT IS ORDERED that the Department finds that Ordinance No. 22-02 is consistent with the City’s Comprehensive Plan and the Principles for Guiding Development for the City and is hereby APPROVED.

This Final Order becomes final 21 days after publication in the Florida Administrative Register unless a petition is timely filed as described in the Notice of Administrative Rights below.
