NOTICE IS HEREBY GIVEN THAT the Board of Psychology, State of Florida, has received a Petition for Declaratory Statement from Bernadine Rice, General Counsel, on behalf of the Orange County Sheriff's office, in which the Petitioner requests a declaratory statement as to the following: The Petitioner seeks the Department's opinion as to the applicability of Chapter 490, Florida Statutes, in the employment of James Herndon, Ed.D., as a "Staff Psychologist" by the Orange County Sheriff's Office (OCSO) to conduct pre-employment psychological examinations, certify deputies as being fit or unfit for duty when their mental state is in question, and assist crisis intervention teams. The University of Central Florida has contracted with OCSO to pre-employment psychological examinations, conducted by Dr. Herndon. In addition, OCSO is considering making Dr. Herndon available to OCSO employees to provide occasional and informal counseling through OCSO's Employee Assistance Program.

Dr. Herndon is not licensed in Florida as a psychologist. Therefore, the following questions are a concern:

- 1. Does Florida law require that Dr. Herndon be a licensed psychologist to perform his duties for the OCSO?
- 2. If Dr. Herndon is exempt from the licensing requirements for Chapter 490, Florida Statutes, is his status jeopardized by performing pre-employment psychological examinations for the University of Central Florida Department of Public Safety and Police as part of his regular duties for the OCSO?
- 3. If Dr. Herndon is exempt from the licensing requirements of Chapter 490, Florida Statutes, is his status jeopardized if he occasionally counsels agency members on an informal basis?
- 4. May Dr. Herndon use the title "Staff Psychologist," in performing his responsibilities for the OCSO?
- 5. If Dr. Herndon holds an earned Ed.D. from the University of Sarasota, is he qualified to be a licensed psychologist?
