NOTICE IS HEREBY GIVEN that the Office of Insurance Regulation has issued an order disposing of the amended petition for declaratory statement filed by C. Hamilton Boone of Physician Assistant Services, Inc., on March 6, 2003. The following is a summary of the agency's disposition of the petition.

For the purposes of Section 627.419(6), Florida Statutes, the legislature did not define the word "employer". Thus, the Florida Supreme Court has stated in numerous cases that when the legislature has not defined words or phrases used in a statute, the words or phrases must be construed in accordance with their plain and ordinary meaning. Moreover, the Florida Supreme Court has found that the plain and ordinary meaning of a word or phrase may be determined by reference to a dictionary. Thus, based on the facts presented by the Petitioner and the plain and ordinary meaning of the word "employer" as defined by the dictionaries referenced in the declaratory statement, Physician Assistant Services, the Petitioner's employer, qualifies as an employer pursuant to Section Statutes. 627.419(6). Florida and should receive reimbursement for Petitioner's and the other physician assistants' services as long as the other criteria for reimbursement of physician assistants set forth in Section 627.419(6), Florida Statutes, are met.
