The rule sets forth the specifics of the game; determination of prizewinners; estimated odds of winning; value and number of prizes in the game.

53ER07-53 Instant Game Number 715, MONEY MONEY MONEY.

(1) Name of Game. Instant Game Number 715, "MONEY MONEY MONEY."

(2) Price. MONEY MONEY MONEY lottery tickets sell for \$5.00 per ticket.

(3) MONEY MONEY MONEY lottery tickets shall have a series of numbers in machine readable code (or bar code) on the back of the ticket, along with a validation number under the latex area on the ticket. To be a valid winning MONEY MONEY MONEY lottery ticket, the ticket must meet the applicable requirements of Rule 53ER06-4, F.A.C.
