The Florida State University, announces that Qualifications Based Design/Build Services for the design and construction of a new Indoor Football Practice Facility, will be required for the project listed below

PROJECT NAME AND LOCATION: Indoor Football Practice Facility, Florida State University, Tallahassee, Florida

This project consists of the design and construction of a new Indoor Football Practice Facility. The new facility will be located and integrated into the site of the current football practice fields, which may require reconfiguring to accommodate the new facility. The new structure will contain approximately 65,000 gsf of mechanically ventilated and/or conditioned space and include the medical/training facility presently on the site. Interior lighting and elevated vantage points for coaches and video recording will be included. The playing surface will be synthetic athletic turf and include goal posts. Occupancy is expected by July 2012.

The Design/Build Services contract shall be in compliance with the qualifications based Design/Build selection provisions in Section 287.055, F.S. and Rule 6C-14.007, F.A.C., including design and pre-construction fees, construction related service costs and a guaranteed maximum price. The University will

contract with a single contract entity whose Design/Build Team shall provide all services including, but not necessarily limited to professional services, budgeting, construction services, labor, materials, and equipment required to design and construct the project. Blanket professional design liability insurance will be required for this project in the amount of \$1,000,000 and will be provided as a part of Basic Services.

The total proposed value of this project is approximately \$17,800,000, of which \$15,000,000 is budgeted for new construction and sitework. Currently \$500,000 of the project is funded. The respondent must be capable of bonding at 100% of the value of the contract with a surety licensed to do business in the State of Florida with a Best rating of A, Class IX. Project development including professional services is contingent upon availability of funds.

**AMENDED FINAL ORDER**

The Department of Community Affairs (the "Department") hereby issues its Final Order, pursuant to Sections 380.05(6) and 380.0552(9), Florida Statutes (2010), approving a land development regulation adopted by a local government within the Florida Keys Area of Critical State Concern as set forth below.

**FINDINGS OF FACT**

1. The Florida Keys Area is a statutorily designated area of critical state concern, and Monroe County is a local government within the Florida Keys Area.
